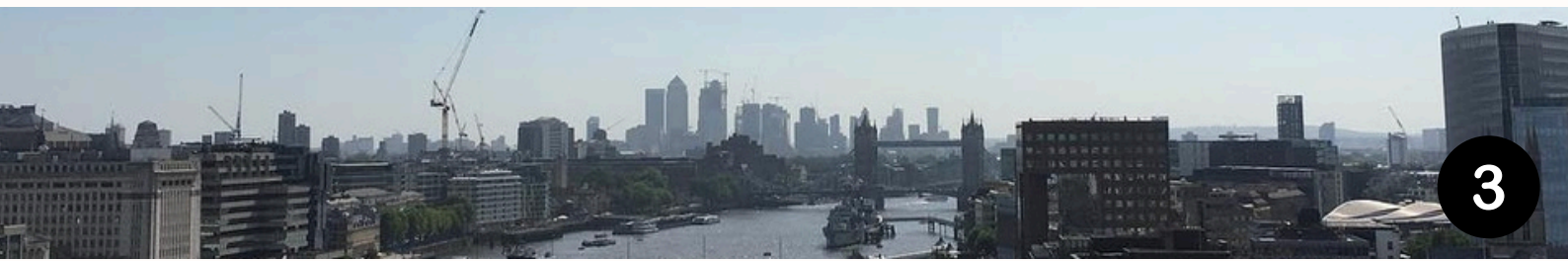
Duty holders must now maintain a complete, up-to-date documentation package that includes:
