

Alpha Xi Delta

“Membership Eligibility Alpha Xi Delta Fraternity is a private women’s membership organization for individuals who live and self-identify as women. Members are selected following a series of one or more meetings, social events and/or interviews by existing Fraternity members (which may include National Fraternity representatives and/or National Council designees). Each woman selected for membership in Alpha Xi Delta must demonstrate academic achievement, be of good character, have a desire to contribute to the Fraternity’s mission and vision, and be able to contribute to the overall prestige of Alpha Xi Delta. In addition, she must be neither a pledged member nor a past or present initiated member of any other National Panhellenic Conference fraternity, or any similar single –gender national college or university fraternity, with the exception of honorary and professional organizations.” - Alpha Xi Delta Constitution and Bylaws, Article III - Membership, Sec. 1

“We are committed to cultivating an inclusive environment where all members feel a sense of belonging. Membership may be considered for any undergraduate student who identifies as a woman and who is seeking membership. Chapters are prohibited from barring admission on the basis of race, color, religion, age, disability, marital/familial status, veteran status, national origin, or sexual orientation.”

Delta Phi Epsilon

“Every individual has the right to be addressed by a name and pronouns that correspond to the individual’s gender identity. Regardless of whether a transgender or gender nonconforming individual has legally changed their name or gender, Delta Phi Epsilon will allow individuals to use a chosen name and gender pronouns that reflect their identity. It is recommended that transgender or gender nonconforming individuals are asked how they want to be addressed. Recruitment Women will always be considered, regardless of other identities the (potential) member holds. This is inclusive of cisgender women and transgender women. Identities that may be considered for membership include non-binary, gender nonconforming individuals who are committed to the advancement of womanhood. Identities that will not be considered regardless of belief in womanhood are cisgender men, what we define as a person designated male at birth and identify as a man. No member is required to provide documentation regarding their gender. We welcome all women as they self-identify. Additionally, all gender expressions of students extended membership are welcome in Delta Phi Epsilon. This policy reflects Delta Phi Epsilon International Sorority’s commitment to antidiscrimination practices in relation to all trans women and non-binary individuals [potential new members, sisters (active and alumnae), volunteers, and

staff] and ensures their rights to express themselves and live authentically are respected and protected. The purpose of this policy is to establish an environment that is safe, welcoming, and free from stigma and discrimination for all potential new members, sisters, volunteer, and staff, regardless of sex, sexual orientation, gender identity, or gender expression.

Delta Phi Epsilon International Sorority is welcoming and inclusive of trans women and non-binary individuals. Any conduct which fosters a hostile environment for trans women and non-binary individuals will not be tolerated. Delta Phi Epsilon International Sorority will include trans women and non-binary individuals as members in all areas of the organization as long as they are willing to accept and share in the collective experiences of the sisterhood. While recognizing this is Delta Phi Epsilon International Sorority's Policy on trans women and gender non-binary individuals, we trust and empower each one of our Chapters to make decisions that is the best for their Chapters and the Sorority in their recruitment activities."

"GENDER IDENTITY WHEREAS, Sigma Sigma Sigma has always been a leader in the fraternal community in demonstrating a commitment to diversity, inclusivity and human dignity in making membership determinations, and WHEREAS, Prejudice and discrimination do not contribute to creating a perpetual bond of friendship, developing strong womanly character or promoting high standards of conduct; therefore, be it RESOLVED, Sigma Sigma Sigma has adopted this position statement to provide clarification regarding gender, gender identity, and gender expression of the Sorority's members, whether collegiate or alumnae; and therefore, be it RESOLVED, a potential new member who self-identifies as a woman shall be treated as a woman regardless of any other circumstances."
