FREEDOMS IN AMERICA UNDER ATTACK

LIBERTADES EN ESTADOS UNIDOS BAJO ATAQUE



America's political parties aside, we must recognize the stark reality that our Freedoms are under attack, and we must collectively work toward restoring respect for our Civil Rights and Personal Freedoms guaranteed us in the U.S. Constitution and specific legislation/court rulings to date. Americans are not sitting back idly while the current president and his chief appointees are conducting a revenge and retribution tour affecting most Americans as it relates to respecting the rule of law, freedom of speech, right to due process, birth rights, and access to asylum, for example.

The U.S. Constitution cannot just hang on the president's wall and in our national buildings while our national leaders fail to abide by its guarantees and mandates. Americans of both major political parties are witnessing and raising their voices against a perceived attack on our most relished freedoms. The relaxing anti-segregation and discrimination regulations in government contracting are gross violations that cannot be overlooked. The recent actions of the Trump administration reversing civil rights in government contracts demonstrate the lack of concern for equality and protections from discrimination we fought so hard to achieve over the past 60 years.

52.222-21 Prohibition of Segregated Facilities.

As prescribed in 22.810(a)(1), insert the following clause:

Prohibition of Segregated Facilities (Apr 2015)

Segregated facilities mean any waiting rooms, work areas, restrooms and washrooms, restaurants and other eating areas, time clocks, locker rooms, and other storage or dressing areas, parking lots, drinking fountains, recreation or entertainment areas, transportation, and housing facilities provided for employees, that are segregated by explicit directive or are in fact segregated on the basis of race, color, religion, sex, sexual orientation, gender identity, or national origin because of written or oral policies or employee custom.

We must be reminded that while the lifted requirement in federal contracts affects many American workers, opening the door to increased denial of civil rights, the legal protections for the rest of us remain in place with full legal effect!

What are the current Civil Rights laws remaining in effect that protect Americans from segregated facilities and other forms of discrimination?

- The Civil Rights Act of 1964 remains a cornerstone of anti-discrimination law in the United States. It prohibits discrimination based on race, color, religion, sex, or national origin in public accommodations, employment, and federally funded programs. Title VI of this Act specifically ensures that no person is excluded from participation in, denied the benefits of, or subjected to discrimination under any program or activity receiving federal financial assistance. Title VII: Bans employment discrimination and established the Equal Employment Opportunity Commission (EEOC) to enforce these provisions. The president has recently eliminated this office, which has made it more difficult to sue the government for violations. Legal firms are being targeted for extortion, such as agreements for pro bono services to the Trump administration, after being denied access to government



contracts and targeted for retribution.

Additionally, the Fair Housing Act of 1968 protects against housing discrimination, and the Americans with Disabilities Act (ADA) of 1990 prohibits discrimination based on disability in various areas, including employment, public accommodations, and transportation.

These laws collectively ensure that segregation and other forms of discrimination remain illegal, even as specific executive orders may change. We must remember and be grateful for the freedoms guaranteed to us as the result of civic activism throughout the Civil Rights Era.

Younger generations of Americans have never experienced the gross discriminatory practices of years before the civil rights era, and they are truly fortunate not to have experienced this level of racial hate and discrimination. Still, the current assault on free speech and assembly has all Americans worried today!

Republicans and Democrats are hearing criticisms at town hall meetings recently, with many of them getting lambasted for not challenging the infringements on civil rights issues and the president's dismissal of federal employees without due process! The firing of Inspector Generals and officials responsible for safeguarding our government, including nuclear defense systems, is clear evidence that not much serious thought is being given to the potential consequences.

Recent arrests and deportations of demonstrators and organizers of public speech related to the loss of Palestinian lives in Gaza have resulted in court actions preventing deportation, as is right!

The recent incident deporting immigrants to El Salvador's notorious gang prison and the use of the "Alien Enemies Act of 1798" during peacetime to conduct wholesale deportations of immigrants based on their national origin and alleged gang affiliation, thwarts immigration laws and due process, which must be guaranteed to asylum seekers including the undocumented. We are a nation of laws and cannot intentionally condemn immigrants to mass detentions in our country or other contracted countries to experience harsh, regimented, vile, and inhumane treatment solely for entering the country and avoiding customs. If the claim of gang affiliation and criminal offenses is the issue, then prosecute and deport them through the normal process, respecting judges in the process! Just a reminder note: No one is above the law!

Independientemente de los partidos políticos estadounidenses, debemos reconocer la cruda realidad de que nuestras libertades están bajo ataque y debemos trabajar colectivamente para restaurar el respeto por nuestros derechos civiles y libertades personales, garantizados por la Constitución de los Estados Unidos y por leyes y sentencias judiciales específicas hasta la fecha. Los estadounidenses no se quedan de brazos cruzados mientras el actual presidente y sus principales designados emprenden una campaña de venganza y retribución que afecta a la mayoría de los estadounidenses en lo que respecta al respeto del Estado de derecho, la libertad de expresión, el derecho al debido proceso, el derecho al nacimiento y el acceso al asilo, por ejemplo.

The Sum of All Fears

Unknown to most Americans there was a near nuclear accident on Jan. 24, 1961 near Goldsboro North Carolina kept secret until 2013. A B-52 bomber with two nuclear bombs broke apart in mid-air. One bomb

would have levelled the area and rendered it a wasteland. President John F. Kennedy decided it was best the country didn't know. This was a short time before the Cuban Missile Crisis, during The Cold War. Years later, but before the accident was declassified, novelist

Tom Clancy wrote an espionage thriller with a sinister plot of a villain and a nuclear bomb. **The Sum of all Fears** was released in 1991 after the first Gulf War initiated by Bush Sr. over Saudi Arabia's oil. The book was made into a movie in 2002 the year George W. Bush Jr. signed the No Child Left Behind Act.

Alleged child molester Boston archbishop Cardinal Bernard Law resigned over priest-child molestation during this era and Putin was named a corrupt politician by The World Social Statistics. Putin, like Trump excels in all forms of corruption amongst them is cronyism. Putin and Trump both appoint friends to government positions awarding contracts in exchange for political support. Trump's puppet congressmen have proven worse than Ayatollah Khomeini. Trump has systematically disrupted federal government services and hurled millions into a state of terror.

White middle age Americans are no longer pointing and accusing us of being illegal. Today, the MAGA red hat wearing, below average IQ, supporters fear losing their health care, social security and veterans' benefits. Their rallying cry is no longer racism and hate, but fear. LIBERTADES EN ESTADOS UNIDOS BAJO ATAQUE

La Constitución de los Estados Unidos no puede simplemente colgarse en la pared del presidente y en nuestros edificios nacionales, mientras nuestros líderes nacionales incumplen sus garantías y mandatos. Los estadounidenses de ambos partidos políticos principales están presenciando y alzando la voz contra lo que perciben como un ataque a nuestras libertades más preciadas. La flexibilización de las regulaciones contra la segregación y la discriminación en la contratación pública constituye una grave violación que no puede pasarse por alto. Las recientes acciones de la administración Trump, que revocan los derechos civiles en los contratos gubernamentales, demuestran la falta de preocupación por la igualdad y la protección contra la discriminación, por la que tanto luchamos durante los últimos 60 años.

52.222-21 Prohibición de Instalaciones Segregadas.

Según lo prescrito en el artículo 22.810(a)(1), insertar la siguiente cláusula:

PROHIBICIÓN DE INSTALACIONES SEGREGADAS (ABRIL DE 2015)

Instalaciones segregadas se refieren a cualquier sala de espera, área de trabajo, baño y aseo, restaurante y otras áreas de comedor, relojes de control de asistencia, vestuarios y otras áreas de almacenamiento o vestidor, estacionamientos, bebederos, áreas de recreación o entretenimiento, transporte e instalaciones de alojamiento proporcionadas a los empleados, que estén segregadas por directivas explícitas o que estén segregadas por motivos de raza, color, religión, sexo, orientación sexual, identidad de género u origen nacional debido a políticas escritas u orales o a las costumbres de los empleados. **Debemos recordar que, si bien la eliminación del requisito en los contratos federales afecta a muchos trabajadores estadounidenses, lo que abre la puerta a una mayor negación de sus derechos civiles, las protecciones legales para el resto de nosotros siguen vigentes y con pleno efecto legal.**

¿Cuáles son las leyes de Derechos Civiles vigentes que protegen a los estadounidenses de las instalaciones segregadas y otras formas de discriminación?

- La Ley de Derechos Civiles de 1964 sigue siendo una piedra angular de la legislación antidiscriminación en Estados Unidos. Prohibe la discriminación por motivos de raza, color, religión, sexo u origen nacional en lugares públicos, empleos y programas financieros con fondos federales. El Título VI de esta Ley garantiza específicamente que ninguna persona sea excluida de participar, se le nieguen los beneficios ni sea objeto de discriminación en ningún programa o actividad que reciba asistencia financiera federal. Título VII: Prohibe la discriminación laboral y estableció la Comisión para la Igualdad de Oportunidades en el Empleo (EEOC) para hacer cum-

plir estas disposiciones. El presidente ha eliminado recientemente esta oficina y ha dificultado las demandas contra el gobierno por infracciones. Los bufetes de abogados están siendo objeto de extorsión, como acuerdos de servicios probona con la administración Trump, tras negárseles el acceso a contratos gubernamentales y ser objeto de represalias.



denes ejecutivas específicas pueden cambiar. Debemos recordar y luchar para preservar las libertades que se nos garantizan como resultado del activismo cívico a lo largo de la Era de los Derechos Civiles.

Las generaciones más jóvenes de estadounidenses nunca han experimentado las graves prácticas discriminatorias de años anteriores a la era de los derechos civiles y son verdaderamente afortunadas de no haber experimentado este nivel de odio y discriminación racial, pero el actual ataque a la libertad de expresión y de reunión preocupa a todos los estadounidenses hoy.

Republicanos y demócratas han recibido críticas en asambleas públicas recientemente, y muchos de ellos han sido duramente criticados por no cuestionar las violaciones de derechos civiles y el despido de empleados federales por parte del presidente sin el debido proceso. Recientes arrestos y deportaciones de manifestantes y organizadores de discursos públicos relacionados con la pérdida de vidas palestinas en Gaza han resultado en acciones judiciales que impiden la deportación, ¡como es debido!

El reciente incidente de deportación de inmigrantes a la notoria prisión de pandillas de El Salvador y el uso de la "Ley de Enemigos Extranjeros de 1798" durante en tiempos de paz, llevar a cabo deportaciones masivas de inmigrantes por su origen nacional y su presunta afiliación a pandillas vulnera las leyes de inmigración y el debido proceso que debe garantizarse a los solicitantes de asilo, incluidos los indocumentados. 




Lou Lopez Sénéchal made history when she was drafted as the fifth overall pick by the Dallas Wings in 2023, becoming the first Mexican-born athlete to be drafted into the Women's National Basketball Association.

"I've come a long way – very grateful for my journey and all the steps I've achieved. [I'm] very grateful to be here," Lopez Sénéchal told ESPN reporter Holly Rowe after being drafted.

The Mexican-French wing was born in Guadalajara, Mexico, and lived there until the age of five, when her parents separated and she and her mother moved to Grenoble, France.

While playing basketball in the U.S. was not an initial consideration, at 19 and with the help of her stepdad, she applied to 280 Division I and II colleges and universities in the U.S., eventually accepting an offer at Fairfield University in Connecticut.

Lopez Sénéchal played for four years and graduated from Fairfield before transferring to the University of Connecticut. During her time at Fairfield, she helped lead the Stags to a Metro Atlantic Athletic Conference (MAAC) title in 2022 – the school's first in 24

years – and an appearance in the NCAA Tournament.

That same year, Lopez Sénéchal was also selected as the 2022 MAAC Player of the Year. She was also included in four all-conference teams from 2020-2023.

After transferring to UConn, she became a breakout star in the 2022-23 season, averaging 15.5 points per game, averaging 44% in 3-point attempts. Her collegiate career ended in a Huskies 73-61 loss to Ohio State in the NCAA Tournament, with Lopez Sénéchal hitting a team-high of 25 points.

She missed the 2023 season with the Wings, recovering from an injury. She debuted in May 2024 in the Wings' home win over the Chicago Sky. She appeared in 24 games last season, with a career-best of seven points and two assists against the Minnesota Lynx on June 17.

Lopez Sénéchal elected to sit out the 2025 WNBA season and currently plays for Hozono Global Jairis of the Liga Femenina de Baloncesto in Spain.

Her draft milestone came a year after Evina Westbrook became the first Mexican American to be drafted to the WNBA, and while she may be the first Mexican-born one to do so, she hopes this is only the beginning for Latinx women in the league.

"To be honest, I didn't know it was gonna be a one," Lopez Sénéchal said. "It means a lot, I hope not to be the only one."

Lou Lopez Sénéchal hizo historia al ser seleccionada como la quinta selección general del draft por los Dallas Wings en 2023, convirtiéndose en la primera atleta nacida en México en ser reclutada por la Asociación Nacional de Baloncesto Femenino (NFBA).

La aleta mexicano-francesa nació en Guadalajara, México, y vivió allí hasta los cinco años, cuando sus padres se separaron y ella y su madre se mudaron a Grenoble, Francia.

Si bien jugar al baloncesto en Estados Unidos no fue una de sus primeras opciones, a los 19 años, con la ayuda de su padrastro, solicitó plaza en 280 universidades de la División I y II del país, y finalmente aceptó una oferta en la Universidad de Fairfield en Connecticut.

Lopez Sénéchal jugó durante cuatro años y se graduó de Fairfield antes de transferirse a la Universidad de Connecticut. Durante su estancia en Fairfield, ayudó a liderar a los Stags a conseguir un título de la Conferencia Atlética Metropolitana Atlántica (MAAC) en 2022, el primero de la universidad en 24 años, y a participar en el Torneo de la NCAA.

Ese mismo año, Lopez Sénéchal también fue elegida Jugadora del Año de la MAAC 2022. Además, formó parte de cuatro equipos de la conferencia entre 2020 y 2023.

López Sénéchal decidió no participar en la temporada 2025 de la WNBA y actualmente juega para Hozono Global Jairis de la Liga Femenina de Baloncesto de España.

Su logro en el draft llegó un año después de que Evina Westbrook se convirtiera en la primera mexicanoamericana en ser reclutada por la WNBA. Si bien podría ser la primera nacida en México en lograrlo, espera que esto sea solo el comienzo para las mujeres latinas en la liga.


Leaky Waders 1-K Run

Felons With Firearms: Is It An American Dream?

In recent headlines, The Department of Justice wants to move towards restoring gun rights for convicted criminals after the Trump administration recently revived the federal firearm rights restoration provision for the famous actor Mel Gibson. A 1996 federal law that strips gun rights away from people convicted of domestic violence. Gibson was convicted of misdemeanor domestic violence in 2011 after pleading "no contest" to accusations of punching his girlfriend while she held a baby. Yet Donald Trump's administration reportedly forced out a pardon attorney for the Justice Department because she refused to restore Gibson's gun rights. Under the current federal law, individuals with felony convictions are prohibited from possessing firearms. Even long after they have served their time or paid fees. Historically, the process to restore an individual's right to lawfully own a gun is quite complex and usually unattainable after a felony. Trump aims to make the process easier nationwide as the ease of gun restoration policies differ from state to state, which creates a legally complex federal versus state landscape.

Proponents of restoring gun rights argue that the Second Amendment rights of individuals who have served their sentences deserve the opportunity to regain their civil liberties. They say that gun ownership can be part of the rehabilitation process that demonstrates successful re-integration into society.

Opponents of the administrative changes should question the motives



behind these swift moves and examine if they are driven by a commitment to citizens of the United States and their constitutional right to bear arms or possibly other political or ideological factors at play.

The question that most interests me is how we can adequately determine when and if a person is fully rehabilitated? How does the nature of the crime committed not play a factor in restoring one's right to own a firearm? I question if a person convicted of shooting another individual with a gun can be responsible with a gun in their hand again.

Is the administration hoping to ignite violent killings in our inner cities? As public safety concerns are already at the highest levels of concern, critics worry that giving convicted criminals legal access to firearms will drastically increase the amount of gun violence in this country, especially in a country plagued with mass shootings in places that used to be known as safe places like churches and movie theaters.

According to Everytown research, 125 people are killed per day by gun violence. The facts are we currently do not have effective screening processes for gun ownership and technology or even an accurate way to assess the potential risks posed by individuals with criminal records. What about the risk to public safety should the firearms fall into the hands of more individuals who should not have them? Is restoring the gun rights of convicted criminals the answer to making America great again? Please write to us with your comments, we would love to hear your thoughts.

DO IMMIGRANTS WITHOUT DOCUMENTS DESERVE TO BE DEHUMANIZED?

Since President Trump took office in 2025, at least one new immigrant detention facility has been contracted. The GEO Group, a private, for-profit company, announced a new contract with Immigration and Customs Enforcement (ICE) to reopen the North Lake facility in Baldwin, Michigan. This facility, which had been closed in 2022, will now house up to 1,800 detainees.²

The expansion of immigrant detention facilities, particularly those operated by private companies, has raised significant concerns about the well-being of detainees. Here are some of the reported impacts:

- **Inhumane Conditions:** Many private detention centers have been criticized for unsafe and unsanitary conditions, including inadequate medical care, overcrowding, and insufficient access to basic necessities.²
- **Mental Health Strain:** Prolonged detention and isolation can lead to severe mental health issues, including anxiety, depression, and trauma.
- **Forced Labor:** Some detainees have reported being compelled to work for minimal pay, often as little as \$1 per day, to maintain the facilities.
- **Family Separation:** Detention often results in the separation of families, causing emotional distress for both detainees and their loved ones.
- **Lack of Oversight:** Rapid expansion of detention facilities has sometimes outpaced the ability to properly oversee and regulate them, leading to more violations and reduced transparency.

These issues highlight the need for improved oversight and humane treatment of individuals in detention.

According to official data, the United States will pay around six million U.S. dollars to El Salvador to imprison around 300 deportees from the U.S. for one year. Immigrants considered to be gang affiliated have been sent to CECOT Mega Prison in El Salvador without Immigration Court Appearances or due process. Some asylum seekers claim innocence and non-gang affiliation. Families assert that they were sent to El Salvador simply because they have tattoos and undocumented status in the U.S.

Why it matters: The United States

Cruel and unusual punishment

The Constitution was amended to prohibit cruel and unusual punishments as part of the United States Bill of Rights as a result of objections raised by people such as Abraham Holmes and Patrick Henry. While Holmes feared the establishment of the Inquisition in the United States, Henry was concerned with the application of torture as a way of extracting confessions. They also feared that the federal government would misuse its powers to create federal crimes as well as to punish those who committed them under the new Constitution and thus use these powers as a way to oppress the people. Abraham Holmes, a member of the Massachusetts Ratifying Convention for the federal constitution.

Today, the Eighth Amendment to the U.S. Constitution remains a crucial safeguard against governmental abuse of power. Its



historical roots in English traditions are one key reason it upholds human dignity principles in American society.

Cruel and Unusual Punishments Protection against cruel and unusual punishments is at the heart of the Eighth Amendment. It ensures that punishments inflicted by the state remain humane and proportional to the offense committed.

The amendment does not explicitly define what constitutes unconstitutional, "cruel and unusual" punishments. This

can be difficult to establish, considering that there are many forms of punishment. However, the Supreme Court has interpreted it to encompass:

- Barbaric punishments
- Degrading punishments
- Punishments disproportionate to the crime



April is **SEXUAL ASSAULT** Awareness Month

April is recognized as Sexual Assault Awareness Month, a time to raise awareness and advocate for change. Accurate statistics on sexual assaults are difficult to ascertain due to widespread non-reporting. According to the Rape, Abuse & Incest National Network (RAINN), a person is sexually assaulted every 68 seconds in the U.S. Many survivors do not report these incidents due to fear, shame, or a distrust of the system.

Confusion about the definition of "sexual assault" can also contribute to underreporting. Sexual assault encompasses a range of behaviors, and varying definitions across different studies can leave victims uncertain about how to classify their experiences.

Victims face significant societal obstacles, including victim-blaming attitudes that often focus on their clothing or actions. This judgment can lead to feelings of shame and isolation, further compounded by a heavy social stigma. Many survivors also fear they won't be believed, leading to a lack of trust in the legal process. The normalization of sexual violence in U.S. culture, particularly in light of high-profile cases involving powerful individuals who face minimal consequences, exacerbates this fear. Marginalized communities, including people of color and LGBTQ+ individuals, often encounter additional barriers due to systemic discrimination.

To create safer communities, it is essential to acknowledge sexual assault and provide a supportive environment for victims. This includes ensuring access to medical care and emotional support throughout their healing journey.

Survivors—regardless of gender—need safe spaces to discuss their experiences and to seek protection from further harm. It is crucial for them to report incidents to law enforcement and seek medical attention promptly for any physical injuries, including Sexual Assault Forensic Exams (SAFES) to collect evidence and test for STIs and pregnancy.

Emotional support is vital in helping victims process their trauma. Survivors must be reassured that the assault was not their fault and that they deserve compassion and non-judgmental support from licensed professionals.

Long-term recovery often requires mental health support, including therapy and counseling to address trauma, PTSD, anxiety, and depression. Legal advocacy is also crucial to help survivors understand their rights and options as they navigate the legal system. Continuous social support from family, friends, and the community can make a significant difference in their healing process.

Resources for Survivors in Michigan

Michigan offers numerous resources to support survivors of sexual assault, providing confidential and compassionate assistance. Here's an overview of available resources:

Understanding Sexual Assault:

Sexual assault is defined as any sexual activity that occurs without consent. It is a crime with profound and lasting effects on survivors. Awareness campaigns aim to dismantle harmful myths and misconceptions surrounding sexual assault, promoting a culture of respect and consent. 

