# AMERICA'S PROMISE TO REMOVE HATE MUST BE FULFILLED! ¡LA PROMESA DE AMÉRICA DE ELIMINAR EL ODIO DEBE CUMPLIRSE!

As we reflect on recent events of the transition of power in America from one Presidential administration to another and the political aftermath of these events, we must focus on eliminating hate groups in America or risk further divisions and increased racial violence in the future. The January 6<sup>th</sup> insurrection proved that we are a fragile union, easily divided and misled. It also proved that racial big-

otry and injustice are alive and well. The planned insurrection and sparking of a Civil War in our capitol should serve as a wake-up call to everyone who believes in our democracy and desires to preserve it. As patriotic Americans, we must ensure the rule of law applies to everyone and prove that no one is above the law, including current or former Presidents. I have faith that our new leadership will begin to focus on racial disparities in our justice system.

Americans are divided by racial bigotry and hate based on differences and it is a condition that has existed for centuries. It is a curse that has been passed on from generation to generation and must be dealt with strategically. Hate groups and hate crimes are on the rise and extremism in America has evolved into a national movement supported by right wing extremist politicians attempting to make their positions on race a political platform. Southern states are engaging in the rapid recruitment of racist followers as leaders in these states are promoting greater control of elections by planned voter suppression measures that threaten future voting participation of black and brown citizens. Likewise, midwestern states too are drafting measures to limit Black and Brown populations influence in elections by targeting mail in voting, absentee registrations, early voting and more.

Michigan Republicans have demonstrated their support for extremism as they have failed to safeguard our state capitol from White Nationalists who actively engaged in a plot to kidnap and kill Governor Whitmer. We await the trials of extremist conspirators from these hate groups and a release of all the details of the plot. Republican leaders continue to deny that extremism is a problem and have failed to take action to curb the rise of unregulated militias and hate groups in our state.

According to the Southern Poverty Law Center there are at least 25 identified Hate Groups tracked and on the Rise in Michigan in 2020. The number of hate groups nationwide is even more alarming as it numbers in the hundreds. There are also more clandestine networks of hate-based groups, including politicians that have an agenda of exclusion based on race, religion, national origin, sexual orientation, etc. Individuals and groups are being identified by their actions and political positions daily. Sheriffs, City Council, School Boards, State Representatives join police officers who become discovered through their actions exposed as racists by news agencies. We must be vigilant and bring attention to persons and political party voting blocs that operate with extremist tendencies in their voting. We must demand more from our national and state leaders to eliminate hate groups from our population by whatever means necessary!

Mientras reflexionamos sobre los eventos recientes de la transición del poder en Estados Unidos de una administración presidencial a otra y las secuelas políticas de estos eventos, debemos concentrarnos en eliminar los grupos de odio en Estados Unidos o arriesgarnos a más divisiones y una mayor violencia racial en el futuro. La insurrección del 6 de enero demostró que somos una unión frágil, fácilmente dividida y engañada. También demostró que el fanatismo racial y la injusticia están vivos y coleando. La insurrección planeada y el desencadenamiento de una Guerra Civil en nuestro capitolio deberían servir como una llamada de atención para todos los que creen en nuestra democracia y desean preservarla. Como estadounidenses patriotas, debemos asegurarnos de que el estado de derecho se aplique a todos y demostrar que nadie está por encima de la ley, incluidos los presidentes actuales o anteriores. Tengo fe en que nuestro nuevo liderazgo comenzará a enfocarse en las disparidades raciales en nuestro sistema de justicia.

Los estadounidenses están divididos por la intolerancia racial y el odio basado en las diferencias y es una condición que ha existido durante siglos. Es una maldición que se ha transmitido de generación en generación y debe tratarse estratégicamente. Los grupos de odio y los crímenes de odio están en aumento y el extremismo en Estados Unidos se ha convertido en un movimiento nacional apoyado por políticos de extrema derecha que intentan convertir sus posiciones sobre la raza en una plataforma política. Los estados del sur están participando en el rápido reclutamiento de seguidores racistas, ya que los líderes de estos estados están promoviendo un mayor control de las elecciones mediante medidas planificadas de supresión de votantes que amenazan la futura participación electoral de ciudadanos negros y morenos. Del mismo modo, los estados del medio oeste también están redactando medidas para limitar la influencia de las poblaciones negras y marrones en las elecciones al enfocarse en el correo en la votación, los registros de ausencias, la votación anticipada y más.

Los republicanos de Michigan han demostrado su apoyo al extremismo ya que no han podido salvaguardar nuestro capitolio estatal de los nacionistas blancos que participaron activamente en un complot para secuestrar y matar a la gobernadora Whitmer. Esperamos los juicios de los conspiradores extremistas de estos grupos de odio y la divulgación de todos los detalles del complot. Los líderes republicanos continúan negando que el extremismo sea un problema y no han tomado medidas para frenar el aumento de milicias no reguladas y grupos de odio en nuestro estado.

Según el Southern Poverty Law Center, hay al menos 25 grupos de odio identificados que fueron rastreados y en aumento en Michigan en 2020. El número de grupos de odio en todo el país es aún más alarmante, ya que se cuentan por cientos. También hay más redes clandestinas de grupos basados en el odio, incluidos políticos que tienen una agenda de exclusión basada en raza, religión, nacionalidad, orientación sexual, etc. Los individuos y grupos son identificados diariamente por sus acciones y posiciones políticas. Los alguaciles, el ayuntamiento, las juntas escolares y los representantes estatales se unen a los agentes de policía que son descubiertos a través de sus acciones y expuestos como racistas por las agencias de noticias. Debemos estar atentos y llamar la atención sobre las personas y los bloques de votantes de los partidos políticos que operan con tendencias extremistas en sus votaciones. ¡Debemos exigir más de nuestros líderes nacionales y estatales para eliminar los grupos de odio de nuestra población por cualquier medio necesario!

## GILDA'S LAUGHFEST ANNOUNCES HEADLINERS FOR 2021 FESTIVAL

Gilda's LaughFest announced headliners participating during LaughFest's virtual festival, March 11-14. Headliners and events that are scheduled as part of the festival's premium all-access content (paid content) include: Ron Funches, Tom Papa, Justin Willman, Michelle Wolf, The Comedy Project's "3 Mics & a Movie!," and the stage performance "Bunny Bunny: Gilda Radner" directed by Emmy award winning director Teresa Thome.

This year's festival will feature a total of 30 events, plus social media content and contests. Much of LaughFest will continue to be free, with donations to Gilda's Club welcome, while premium all-access content is \$40.

**Funches** will bring his podcast "Gettin' Better with Ron Funches" to LaughFest's virtual stage on Saturday, March 13 at 7 p.m. In addition to his stand-up comedy credits, Funches has extensive acting credits, with roles on "Curb Your Enthusiasm," "Black-ish," "New Girl," "Transparent," "Powerless," and "Undateable." His voice has been used in roles with "Trolls," "Bob's Burgers," and "Adventure Time." Funches has also appeared on "Conan," "The Tonight Show," "Chopped," and "Cupcake Wars."

**Papa**, with over 20 years of stand-up comedy experience will perform Friday, March 12 at 9 p.m. In 2020, Netflix premiered Papa's fourth hour-long stand-up special "Tom Papa: You're Doing Great," which is a rebuttal to the current culture of feeling dread. Papa reminds viewers to "remember that you're doing great, life isn't perfect, it never will be, and that's OK." He also hosts the podcast Breaking Bread with Tom Papa and regularly appears on National Public Radio's "Wait Wait...Don't Tell Me."

**Willman**, a magician, comedian and host of the hit show "Cupcake Wars" on Food Net-

work, will perform on Thursday, March 11 at 9 p.m. In 2018, Willman premiered his six-episode magic series on Netflix entitled "Magic For Humans with Justin Willman." In March 2020, as Covid spread across the globe, Willman debuted "Magic For Humans @Home," a virtual show, which has garnered an audience of over 500,000 people.

"An Evening of Laughter and Conversation with Michelle Wolf," will take place at 9 p.m., Saturday, March 13. On the heels of her recent Netflix special, "Michelle Wolf: Joke Show," Wolf will be joining LaughFest with all new material. In 2017, Wolf debuted her first hour-long stand-up special, "Michelle Wolf: Nice Lady" on HBO, which earned her a Primetime Emmy nomination for outstanding writing for a variety special. She made international headlines as the much buzzed-about headliner of the 2018 White House Correspondents Dinner. Wolf's other television credits include being an on-air contributor and writer for "The Daily Show with Trevor Noah" and a writing supervisor and performer on "Late Night with Seth Meyers."

On Friday, March 12 at 10 p.m., Grand Rapids-based The Comedy Project will co-produce "3 Mics & a Movie!." Fans of Mystery Science Theater 3000, Riff Trax and, well, movies in general won't want to miss this live roast of the movie "The Hitch-Hiker" will be shown while comedians add alternate dialogue and sound effects. Closing the festival on Sunday, March 14, the stage play "Bunny Bunny: Gilda Radner" will be performed live. The play chronicles the relationship between Alan Zweibel and Gilda Radner. Zweibel, a writer on SNL in the first five years wrote with Gilda many of her familiar characters – Roseanne Rosannadonna, Baba Wawa and Emily Litella. # COMEDIAN CHRIS "CRAZY LEGS" FONSECA

Chris "Crazy Legs" Fonseca is a man of many talents. He's a writer, an actor, a ladies' man (yes, girls, he's available). And he is also probably one of the greatest sit-down stand-up comedians of all time.

Chris was born with cerebral palsy, but he has not let that get in the way of a comedy career that has spanned nearly 4 decades.

"I knew I wanted to be a comedian when I was in fourth grade. I was trying to be funny like the DJ's on the radio. My first onstage experience was for a sort of gong show in college. I took second place and I was hooked!"

Since then he has shared the stage with such big name entertainers as Stevie Wonder, Dave Chapelle and Sinbad just to name a few. He's been on The Arsenio Hall show, Late Night with David Letterman, The Tonight Show with Jay Leno and he even had a part on Baywatch that was written specifically for him. He just finished his 6<sup>th</sup> comedy album which was recorded live at Denver's Mercury Café. And he is getting ready to go back on tour now that venues are starting to open back up after being closed for almost a year.

"When the pandemic hit, I thought it was the end of my comedy career, touring specifically. But, I used the down time to reflect and write. I now feel I'm back at the top of my game! I have a fresh perspective and am purposely trying to stay away from writing COVID material. I don't want people listening to it a year from now saying, 'Oh, that's so 2020.'

"I know it's unusual to see a handicapped person onstage, and if I do well, the crowd may get something out of it besides the laugh. But, I'm not out there on any kind of mission to promote disabled people and demonstrate what they can or can't do. I'm a comedian, and I'm just trying to be funny."

You can watch Chris "Crazy Legs" Fonseca be funny in person at One Night Stan's, located at 4761 Highland Road, Waterford, Michigan on March 4 – 6. Shows start at 7:30 (with 10 p.m. curfew) Tickets are \$20.00 when purchased at the box office and there is a \$3.00 service fee when you buy online at [onenightstanscomedyclub.com](http://onenightstanscomedyclub.com). Safety protocols will be followed including mandatory temperatures taken at the door and masks to be worn at all times except when seated at your table. Tables are spaced 6 feet apart and only six people are allowed per table. For more information, please contact One Night Stan's at (248) 875-6524.

Chris "Crazy Legs" Fonseca es un hombre de muchos talentos. Es escritor, actor, mujeriego (sí, chicas, está disponible). Y también es probablemente uno de los mejores comediantes de stand-up de todos los tiempos.

Chris nació con parálisis cerebral, pero no ha dejado que eso se interponga en el camino de una carrera de comedia que ha durado casi 4 décadas.

"Sabía que quería ser comediante cuando estaba en cuarto grado. Intentaba ser gracioso como el DJ de la radio. Mi primera experiencia en el escenario fue para una especie de espectáculo de gong en la universidad. ¡Quedé en segundo lugar y me enganché! " Desde entonces ha compartido escenario con artistas de renombre como Stevie Wonder, Dave Chapelle y Sinbad, solo por nombrar algunos. Ha estado en el programa The Arsenio Hall, Late Night with David Letterman, The Tonight Show con Jay Leno e incluso tuvo un papel en Baywatch que fue escrito específicamente para él. Acaba de terminar su sexto álbum de comedia que fue grabado en vivo en el Mercury Café de Denver. Y se está preparando para volver de gira ahora que los lugares están comenzando a abrir de nuevo después de haber estado cerrados durante casi un año.

"Cuando golpeó la pandemia, pensé que era el final de mi carrera como comediante, de gira específicamente. Pero usé el tiempo libre para reflexionar y escribir. ¡Ahora siento que he vuelto a la cima de mi juego! Tengo una nueva perspectiva y deliberadamente intento evitar escribir material de COVID. No quiero que la gente lo escuche dentro de un año y diga: 'Oh, eso es 2020'.

# Spring Break's: Socially Distant

**Beach parties in Florida, Texas and Mexico made headlines a year ago for ignoring virus safety advice. Here's how the travel ritual will look different in 2021.**

Last year, Covid-19 crashed the spring break party, but not before mass gatherings on the beaches of Florida, Texas and Mexico flouted travel warnings and social-distancing advice. Ski areas had to shut down during one of the busiest periods of the season. Student trips for enrichment and sport were suddenly canceled.

Now, a year later, spring break is showing signs of life again, albeit in very different forms than the past — even as officials in one spring-break favorite, Florida, vow to fight any domestic travel restrictions reportedly under consideration by the White House as cases of more contagious variants surge there.

"We don't want to see a repeat of last year," said Steve Hayes, president and chief executive of Visit St. Pete/Clearwater, which promotes tourism in that Gulf Coast area, where crowds jammed the beaches last spring. "What we want is a picture that says, what a difference a year makes."

Stricter limits on group gatherings, mask mandates and restrictions at hotels, restaurants and bars in popular spring destinations diminish the odds of a repeat.

Virtual classrooms and workplaces have freed some students and families from the traditional spring-break schedule, a shift that may dilute 2021 traffic. This trend is already showing up in some ski areas that rely on visitors who drive there, like Lutsen Mountains in northern Minnesota, where weekday skier visits have doubled this year.

With colleges shrinking spring break and the arrival of the vaccine, largely prioritized to older Americans, the 2021 spring breaker may be significantly older than the stereotyped one.

Whether senior or college-age, spring break will be quieter this year. The seasonal escape "is pivoting to domestic drive markets, private vacation rentals or nothing at all," said Erika Richter, the senior communications director for the American Society of Travel Advisors, noting that multi-generational family trips are trending.

The seasonal itch to travel, of course, runs headlong into advice from the Centers for Disease Control and Prevention to postpone travel in order to avoid contracting or spreading Covid-19.

*Los límites más estrictos a las reuniones grupales, los mandatos de máscaras y las restricciones en hoteles, restaurantes y bares en los destinos populares de primavera disminuyen las probabilidades de que se repita.*

*Las aulas y lugares de trabajo virtuales han liberado a algunos estudiantes y familias del horario tradicional de vacaciones de primavera, un cambio que puede diluir el tráfico de 2021. Esta tendencia ya está apareciendo en algunas áreas de esquí que dependen de los visitantes que conducen allí, como las montañas Lutsen en el norte de Minnesota, donde las visitas de esquiadores entre semana se han duplicado este año.*

*Con las universidades reduciendo las vacaciones de primavera y la llegada de la vacuna, en gran parte priorizada para los estadounidenses mayores, el receso de primavera de 2021 puede ser significativamente más antiguo que el estereotipado.*

*El deseo estacional de viajar, por supuesto, se topa de lleno con los consejos de los Centros para el Control y la Prevención de Enfermedades de posponer los viajes para evitar contraer o propagar el Covid-19.*

# Visas and Immigration in 2021 Under the Biden Administration

The Biden Administration took office on January 20, 2021. Many executive orders have been executed since that date, some of which directly change the manner of handling immigration matters. However, the U.S. and the world are still dealing with the global pandemic and this directly affects submissions, filings, and consular appointments. This update provides a list of the latest updates to U.S. visas and immigration matters, as well as what we forecast for the months to come.

- **Immigrant Visa Ban:** The Immigrant Visa Ban that was imposed last year was revoked on February 24, 2021. Now employment and family based immigrant visas can again be issued by the U.S. Consulates. See: A Proclamation on Revoking Proclamation 10014 | The White House

- **Entry to the U.S. via a Land Port of Entry from Mexico and Canada:** The entry via land ports remains restricted to essential travel, those on work visas, U.S. citizens, U.S. permanent residents, and a few other limited exceptions. The entry restrictions are temporary in nature and as of now are expected to remain in effect through March 21, 2021. The date has been postponed several times and it is unknown if it will again be postponed. See: [https://help.cbp.gov/s/article/Article-1694?language=en\\_US](https://help.cbp.gov/s/article/Article-1694?language=en_US)

- **Air Travel from Mexico and Canada into the U.S.:** Currently there are no limits to air travel from Mexico and Canada.

- **Covid Travel Ban Restrictions:** Any travel from Brazil, China, U.K., Ireland, Schengen Countries, and Iran is subject to a National Interest Exception (NIE) waiver from the U.S. Consulate prior to traveling to the U.S.

- **Negative Covid Test:** All inbound passengers are required to obtain a negative Covid test within 72 hours prior to boarding the flight. This includes air travel from Mexico and Canada.

- **Local Quarantine Rules in the U.S.:** All travelers must also research local travel rules upon arrival in the U.S. For example New York City and San Francisco have additional quarantine rules upon arrival.

- **Visa Stamping Ban:** The Visa Stamping Ban that was imposed through an executive order from the prior administration for H-1B, L-1, J-1, and H-2B remains in effect. This ban expires on March 31, 2021. The Biden administration is not expected to extend this ban. This ban prevents the U.S. Consulates from issuing new visas in this category. This ban has prevented many executives and highly skilled workers from being able to enter the U.S.

- **Travel from the Middle East:** The U.S. has canceled the blanket travel ban from select countries in the Middle East.

- **H-1B Lottery:** The selection criteria will be the same as last year. The lottery starts on March 9, 2021 and goes to March 31, 2021. Winners will be announced on March 31 and then the employer has until June 30, 2021 to file the H-1B petition.

- **H-1B Adjudications at USCIS:** The H-1B Adjudications at the United States Citizenship and Immigration Services ("USCIS") are expected to return to 2016 standards, with deference given to prior adjudications, Visas and Immigration in 2021 Under the Biden Administration acceptance of multiple educational pathways to an H-1B occupation, etc.

- **USCIS Operational Efficiency:** Expected to be a priority going forward. The Administration is expected to ensure that USCIS operates at an efficient pace so that the backlogs of prior years are not repeated.

- **DACA:** The Deferred Action for Childhood Arrivals ("DACA") has been reaffirmed for both existing DACA recipients and new applicants.

- **Asylum:** The U.S. will again provide opportunities for applicants to apply and have a credible fear interview at the border. If they pass the credible fear interview, they will be allowed into the U.S. to await for their full asylum merits hearing before an Immigration Judge.

- **Comprehensive Immigration Reform:** Under the new Administrations some sort of immigration legislation is expected. Such new provisions are expected to address both labor market and humanitarian needs. The Administration announced a draft plan on February 18, 2021.

**E-2 Investor Visas:** In recent months Mexican investors have shown an increased interest in the E-2 non-immigrant visa. As the pandemic slowly subsides, it is hoped that the U.S. Consulate in Ciudad Juarez will be able to increase their volume of E-2 reviews. The firm has a robust E-2 visa practice.

**NAFTA TN Visas:** The United States- Canada- Mexico Agreement (USMCA) replaced the NAFTA Agreement. The new USMCA went into effect on July 1, 2020. However, the TN occupational list and regulations remained the same. Therefore for select occupations, the TN visa continues to be a quick and efficient way for an U.S. employer to get a Mexican or Canadian citizen on the U.S. payroll.

## Biden's 2021 Immigration Plan: A Summary

The last time there was a major immigration overhaul allowing people to become U.S. citizens was 1986, under President Ronald Reagan. Later, the United States continued to provide programs such as visas for victims of certain crimes, and programs such as Deferred Action for Childhood Arrivals (DACA) allowed categories of immigrants to stay in the country and work legally since 2012.

Advocates for immigration reform came close to advancing in their agenda in 2010, the DREAM (Development, Relief, and Education for Alien Minors) Act almost passed. President Joe Biden mentioned immigration reform during his 2020 campaign, and has now unleashed a new immigration reform proposal. Here is what we know about it so far.

### Democrats are willing to compromise

Texas Representative Henry Cuellar said the following, "Even though I support full, comprehensive immigration reform, I'm ready to move on piecemeal, because I don't want to end up with good intentions on my hands and not have anything. I'd rather have progress."

Thus far, the current proposed bill would create a pathway to citizenship for qualifying immigrants that would take them approximately 8 years. A few of the provisions Democrats are advocating for are:

- Additional funds to promote development in Latin America.
- Increased technology for the U.S.-Mexico border.
- More visas.
- Additional funding to assist with the cost of processing asylum applications.

Critics of the current bill say that Democrats might be able to focus on other separate bills that would also help immigrants legalize their status, such as:

- Bills for essential workers
- Bills that focus on younger immigrants brought to the U.S. as children (similar to the DREAM Act of 2010)
- U.S. citizenship bills for farm and agriculture workers

### Other immigration obstacles

Of course, the Biden administration isn't just working on immigration reform. Since January 20, 2021 President Biden has also worked on or proposed other ideas that would alleviate immigrants, refugees, and asylees.

Biden announced a plan to open detention facilities to process unaccompanied minors who seek refuge in the country. Though some hail this as an important step in ensuring teenagers can find refuge, detention centers have been criticized for their inhumane treatment of minors and lack of resources.

According to Yahoo! News, Biden is still using Title 42, a rule created during the Trump era, to turn away many young migrants because he has no other plan at the moment and doesn't want to encourage people to cross the border into the United States.

With detractors in the Republican Party and a divided Congress, it's going to be hard to pass a full immigration bill, but Biden has signed executive orders that have alleviated the fears of some immigration advocates. These orders target:

- The creation of a task force that will reunite families separated under the Trump administration.
- Potential changes to the public charge rule that will prevent the use of Medicaid and other government benefits to pose problems to people who want to become U.S. citizens in the future.
- Changes to how deportations will take place, such as targeting only people who have committed crimes instead of encouraging deportations of any immigrant in the country.



## Resumen del plan migratorio de Biden para el año 2021

La última vez que hubo una reforma migratoria que formó un camino hacia la ciudadanía fue en 1986 bajo el presidente Ronald Reagan. Después, los EEUU continuó con programas como las visas U para víctimas de algunos crímenes, y los programas como DACA (Acción diferida para personas que llegaron en su niñez) permitieron que algunos inmigrantes se puedan quedar en el país legalmente y trabajen desde el 2012.

Los defensores de la reforma migratoria casi obtuvieron una victoria en el año 2010 cuando el DREAM Act casi fue aprobado. El presidente Biden ha mencionado la reforma migratoria durante su campaña política del 2020 y ahora ha revelado una nueva propuesta para la reforma migratoria. Esto es lo que sabemos por ahora.

### Los demócratas están dispuesto a llegar a un acuerdo

El representante Henry Cuellar, de Texas ha dicho, "Aunque yo apoyo una reforma migratoria total, estoy listo para luchar poco a poco porque no quiero terminar con buenas intenciones y después no tener nada. Prefiero que haya progreso."

Por ahora la propuesta actual crearía un camino hacia la ciudadanía para inmigrantes que califiquen que tardará aproximadamente 8 años. Algunas de las provisiones por las cuales los demócratas luchan hoy son:

- Fondos adicionales para fomentar el desarrollo en América Latina
- Incremento en tecnología para la frontera EEUU-México
- Más visas
- Fondos para procesar las solicitudes de asilo

Los que critican a la ley actual dicen que los demócratas podrían enfocarse en proyectos de ley que podría ayudar a inmigrantes a legalizar su estatus migratorio como:

- Leyes para trabajadores esenciales
- Leyes que se enfocan en inmigrantes jóvenes que llegaron al país en su niñez (parecidos al DREAM Act del 2010)
- Proyectos de ciudadanía para trabajadores de granjas y agricultores

### Otros obstáculos migratorios

Igual, la administración de Biden no solamente está trabajando para reformar el sistema de inmigración. Desde el 20 de enero 2021. El presidente Biden también a trabajado en o propuesto otras ideas que ayudarían a inmigrantes, refugiados, o personas en busca de asilo.

Biden ha anunciado un plan para abrir instalaciones de detención para procesar a los menores de edad que buscan refugio en el país. Aunque algunos dicen que este es un paso importante para asegurarse que estos menores busquen asilo, los centros de detención han sido criticado por el trato inhumano hacia menores de edad en el pasado y por la falta de recursos.

Según Yahoo! News, Biden sigue usando Title 42 (Título 42), una regla creada bajo la administración de Trump, para denegar la entrada a migrantes menores porque no tiene otro plan por el momento y no quiere fomentar un incremento de migrantes a la frontera de los EEUU.

Con opositores en el partido republicano y un congreso dividido, será difícil aprobar una ley migratoria, pero Biden firmó órdenes ejecutivas que han aliviado los miedos de algunos defensores de derechos de inmigrantes. Estas órdenes tratan con:

- La creación de un comité que reunirá a familias separadas durante la administración de Trump.
- Cambios en reglamentos que causan problemas para personas que usan beneficios gubernamentales cuando quieren solicitar la ciudadanía (public charge rule, en inglés).
- Cambios en la manera de conllevar deportaciones, como el enfoque en deportaciones de personas que han cometido crímenes en vez de la deportación de cualquier inmigrante en el país.

# AUSTON MATTHEWS

HOCKEY SUPERSTAR

Maple Leafs center Auston Matthews wears his Mexican heritage proudly as he continues to make a name for himself and represent the Latin American community within the National Hockey League.

Nicknamed "Papi," Matthews was born in San Ramon, California, but his mother, Ema, was originally from Hermosillo, Mexico. Although the family moved to Scottsdale, Arizona when he was young, Matthews often reflects on the fond memories he has of going with his family to visit Hermosillo.

"I'm not really sure how to really describe it," he said in an interview with NHL.com. "They had a ranch about two hours away from their house in Hermosillo, so we'd go there and hang out there, and lots of animals, and just kind of do different stuff that we typically did not do in Phoenix."

Matthews was widely considered the top prospect of the 2016 draft and was selected first overall by the Toronto Maple Leafs. He became the first player in modern NHL history to score four goals in his NHL debut and scored 40 goals in his rookie season, settling the rookie record for the Maple Leafs.

His 2016-17 season performance also earned him the Calder Memorial Trophy, given to the top-performing rookie each season. He was also the only Leafs' player to participate in the 2017 NHL All-Star Game.

Matthews' story is not the typical path to hockey stardom, but his impact is undeniable in bringing a bigger interest in hockey in Mexico and other Latin countries. The Maple Leafs' alternate captain is a product of the USA Hockey National Team Development Program in the United States Hockey League. Prior to being drafted, he played for the ZCS Lions of the Swiss National League.

Following his debut season, Matthews set the unofficial NHL record for most consecutive games with a shot on goal to start a career. Although he suffered a shoulder injury, missing 20 games, Matthews finished the regular season with 34 goals, and helped lead the Maple Leafs to their second consecutive playoff appearance.

He has continued to be an instrumental player for the Maple Leafs in the 2018-19 and 2019-20 seasons, being named to his fourth straight All-Star appearance since being drafted. In 2018, he became the youngest player in NHL history to score five multi-point games to open a season.

In a 2020 interview with SportsNet, Matthews and his mom talked about an upbringing that is different than a traditional hockey player, and the impact that's had in the Latino community, his mom even pointing out that bars back home in Hermosillo now have hockey games playing.

"There's always kids at the rink and just getting stopped and stuff, but it's definitely different," Matthews said on being someone kids look up to. "You look at like Canada and you know, different provinces, Ontario for instance.... (there are) many guys that come from the area and so many guys to look up to that came from that area. But there aren't too many with Spanish backgrounds. So, it's pretty humbling to be somebody that anybody would look up to. Selfishly for myself, the whole Hispanic side of it, and the

Southwest region of the States, it's pretty sweet."

For now, Matthews is gearing up for the 2020-21 NHL season.

Vaccination is essential to making progress in the COVID-19 pandemic. Two COVID-19 vaccines have been authorized for emergency use by the U.S. Food and Drug Administration so far, and more are in development. Here's a look at the technology behind the vaccines.

#### MESSENGER RNA VACCINES

The first two COVID-19 vaccines authorized for emergency use by the FDA are made by Pfizer-BioNTech and Moderna. Both vaccines require two shots and use messenger RNA to trigger an immune response in the body.


The Pfizer and Moderna COVID-19 vaccines cannot cause COVID-19, as they do not use a live virus. The messenger RNA, or mRNA, teaches our bodies to make a protein to trigger an immune response.

Here's how it works:

1. The mRNA vaccine is administered to the upper arm muscle
2. The mRNA encounters the body's cells
3. The cells follow the mRNA's instructions to produce a new protein piece
4. The cell destroys the mRNA instructions now that it has used them, and displays the protein piece on its surface
5. Our immune system recognizes that the new protein doesn't belong on the outside of the cell and begins making antibodies

The mRNA never enters the nucleus of the cell, where our DNA is kept — so they do not affect or alter our DNA. While mRNA is a new vaccine technology, it has been in development for years as scientists have studied the flu, Zika, rabies and cytomegalovirus.

Both the Pfizer and Moderna COVID-19 vaccines are known to cause side effects, including pain and swelling at the injection site, fever, chills, tiredness and headache. These side effects mean the vaccine is working and that your immune system is responding as intended.
