# CHILDREN FACED SEPARATION, CAGES, ILLNESS, AND DEATH BY U.S. OFFICIAL'S ACTIONS



Recently, lawyers appointed by a federal judge to identify migrant families who were separated by the Trump administration reported that they could not locate the parents of 545 migrant children separated at the border by the Trump administration. The shocking report pulled sharply on my heartstrings as a parent. How devastating it must be to have your children forcibly separated when arriving at the "Haven" to which you were seeking refuge having left from the horrific conditions you were escaping from. It is unimaginable that our government continues to justify family separation policies under this administration.

I read that on Twitter, a DHS spokesperson said, "In the current litigation, for example, out of the parents of 485 children whom Plaintiffs' counsel has been able to contact, they've yet to identify a single family that wants their child reunited with them in their country of origin." How desperate their condition must be to not want their children deported back to the country and the conditions they fled from. The wonder is how many of them are still alive? Many from Central and South America were stranded in Mexico's camps of squaller and subjected to predators on the border.

Since the inception of the zero tolerance policy by the Trump Administration, over two thirds of immigrant parents have been deported back to Central America without their children. A faulty process that has required a physical search for the parents in their native countries.

When White House spokesperson Brian Morgenstern was asked about the report he said that many of the parents "have declined to accept their children back...It's not for lack of effort on the administration's part".

Lee Gelernt, deputy director of the ACLU Immigrants' Rights Project responded "There is so much more work to be done to find these families. Gelernt responded in rebuttal to Morgenstern's statement saying, "First, we have not even found these 545 parents so neither we nor certainly the administration can know whether they want to be reunited." He went on saying, "Second, in the past there have certainly been parents who have made the agonizing decision to leave the child in the U.S. because of the danger the child would face upon return. The humane and simple solution is for the Trump administration to allow the parents to return to the U.S. to reunite with their children but the administration is not allowing that."

On social media outlets immigrant parents give details of the nightmare of countless days in a cage surrounded by other parents all listening to their own child's unique cry and terror in their screams from a cage only a few hundred feet away.

As a parent, it would be heart wrenching to listen to my child cry in terror, loneliness and pain knowing there was nothing I could do to comfort them. The psychological trauma that these families have endured is disheartening.

Whether or not your vote is red or blue, as Americans we are well aware of the experiences these families have endured and in our



hearts we know it is absolutely inhumane yet, so many of us still support this treatment saying, "They should have never come here".

In June, it was reported that children in either custody at the border or in a detention center were rapidly dying of covid-19. Resident doctors placed signs outside the centers letting the people know of the alarming numbers of unnecessary deaths. In the meantime, the cages stayed overcrowded, unsanitary and few raised their voices to bring reforms. Social distancing was never an option for these caged children and families. The lack of hygienic products, proper PPE, clean clothes and preventative measures for more infection were all things CBP (Customs Border Protections) refused to be accountable for.

With an overwhelming number of 400,000 foster children in the United States still awaiting adoption, the risk of the lost immigrant children getting caught up in the foster system or even worse, the human traffic ring is unacceptable from an administration that preaches Christian and family values. America, we have got to do better than this! I encourage you to not just preach but take action and join the ACLU in effort to find the parents. Sign up to be a foster parent. Volunteer at your local adoption agency or contact your local DHS office to find out how you can help a child. God's children need our help!

### The importance of the Latino vote

Politicians and experts have had a difficult time successfully turning out the Latino vote. The diversity in our community poses a challenge to creating true unity among us. More than ever Latinos are working to discuss race and our national identity. Latinos are not race or a monolith.

**By Ingrid Cruz** Additionally, the Latino vote is split. A recent poll shows that Florida, a state where 20.5% of total voters are Latino/Hispanic, shows that 50% of Latinos support Biden, while 45% support Trump. The split between Latinos who support Trump or Biden varies by state. In either case, both the Republican and Democratic parties don't usually have a cohesive way to obtain support among the Latino community.

### Why elections are important

Elections aren't simply about electing the president. Potential members of Congress in both the House of Representatives and the United States Senate are also running for office. Members of Congress are responsible for writing and supporting bills that can be turned into law, bringing local concerns to the country's capitol, and influencing how federal budgets are written and spent.

Issues such as the environment, economy, and immigration tend to be some of the most important for Latino/Hispanic communities, and having members of Congress that pledge to fight for our needs is crucial to ensuring there are enough votes to pass laws that might benefit us, or veto laws that might make life much harder for immigrants.

This year there are also important ballot measures in Michigan. Voters will have a say on whether or not a warrant will be required to search through a person's electronic data or not.

### It's important to know your rights

In-person federal elections are on Tuesday November 3rd. Regardless of which state you live in, you must be registered to vote so you can cast your ballot. The state of Michigan allows you to register to vote on the same day, but it's best to do so as soon as possible. The requirements include:

- You must be 18 years of age or older on election day
- Not currently serving a prison or jail sentence
- You must be a citizen of the United States
- You must be a resident of your city or town for 30 days prior to elections

When you register to vote you also have to show proof of residency. Acceptable documents you can show in Michigan include:

- A Michigan state issued identification card or driver's license
- A recent and current utility bill
- Statement from your bank
- Government or work issued paycheck
- Other government issued document

You can register to vote online until October 19 at Michigan.gov/VoterRegistration, and can only register in person between October 19 and November 3rd. See Michigan.gov/Vote for additional information and to find your local clerk.

### Have a plan

COVID19 will likely still be present across the country. It's important that you make adequate plans so you can cast your ballot. Prepare for in-person voting to look different. Expect social distancing protocols, take your mask, hand sanitizer, water, and maybe even a snack. Lines may be long, but plan to stay until you cast your ballot.

### La importancia del voto latino

A los políticos y expertos les ha costado asegurar el voto latino. La diversidad de nuestra comunidad crea desafíos para crear unión entre nosotros. Más que antes los latinos también estamos hablando sobre nuestras identidades raciales y nacionales. No somos ni raza ni monolitos.

Además, el voto latino está dividido. Una encuesta reciente muestra que en Florida, un estado donde el 20.5% de votantes es latino o hispano, el



50% de latinos apoyan a Biden, mientras un 45% apoyan a Trump. La división entre latinos que apoyan a Trump o Biden varía entre estado. Sin importar el caso, ni el partido republicano o demócrata ha podido obtener apoyo de la comunidad latina de una manera coherente.

### Por qué las elecciones son importantes

Las elecciones no son solamente para elegir el presidente. También hay miembros potenciales del Congreso en la Cámara de Representantes y el Senado que busman asegurar tu voto. Los miembros del Congreso son responsables de escribir y appear protects de ley due podrían entrar en vigor, llevar las preocupaciones locales al capitolio del país, e influir cómo se escriben los propuestos fiscales y cómo se usan.

Los temas del medio ambiente, la economía, e inmigración suelen ser de los más importunes para la comunidad latina e hispana, y es importante que hayan miembros de Congreso que se comprometan a luchar por cosas que nos importan, ya que esto ayudará a que hayan suficientes votos para votar por leyes que nos ayuden, o que no vote por leyes que hagan que las vidas de inmigrantes no se pongan más difíciles.

Este año también habrán referendums importantes en Michigan. Los votantes podrán opinar sobre si el estado debería obtener una orden judicial para ver sus datos electrónicos o no.

### Es importante conocer tus derechos

El voto en persona se llevará a cabo el martes 3 de noviembre. Debes registrarte a votar en cualquier estado en el país. El estado de Michigan te permite registrar el mismo día, pero es mejor que te registres lo más rápido posible. Los requisitos incluyen:

- Debes tener 18 años o más el día de las elecciones
- No puedes estar en la cárcel o prisión
- Debes ser ciudadana/o de los EEUU
- Debes residir en tu ciudad o pueblo 30 días antes de las elecciones

Cuando te registres a votar debes mostrar comprobantes de residencia. En Michigan puedes usar documentos como:

- Una tarjeta de identificación o licencia de conducir del estado de Michigan
- Una cuenta reciente y actualizada de usos públicos (agua, luz, y electricidad)
- Cuenta de estado bancario
- Cheque de trabajo o del gobierno
- Otro documento otorgado por el gobierno

Tienes hasta el 19 de octubre para registrarte a votar en Michigan.gov/VoterRegistration, pero tendrás que registrarte en persona si lo haces entre el 19 de octubre y el 3 de noviembre. Véase Michigan.gov/Vote para información adicional y para encontrar a tu oficina electoral local.

### Ten un plan

COVID19 seguirá presente en el país. Es importante que hagas planes adecuados para que puedas votar. Prepárate para que el voto se vea diferente este año. Anticipa requisitos de distanciamiento social, lleva tu máscara, alcohol en gel, agua, y un refrigerio. Las filas estarán largas, pero quédate hasta que votes.


The Excellence in Equity Award recognizes individuals who impact the public sector field in Ottawa County and focus on the importance of equity through their practices, programs, policies and decision making.

Artist Kia Arriaga has returned to Southwest Detroit this season to create Ofrendas (Offerings) that bring ancient traditions of her ancestors to the forefront of today's culture in celebrating Dia De Los Muertos.

**By Primavera Flores** Born in Cuernavaca Morelos México and a member of the "Kalpulli Tlahuikayotl" dance group, Kia dedicated years to learning from her Aztec peers in Mexico about ceremonial dance, native history, language, philosophy and the art of her people. Inspired by a strong passion to preserve her Aztec roots, she has continued her work in the Detroit area by communicating ancient traditions and culture through her love for fine arts, food and dance.

As the granddaughter of a blacksmith and a metalsmithing/ceramics major from Wayne State University; Kia's inherited skills for craftsmanship and talent for elaborate designs in her Day of the Dead altars is undeniable in her handmade installations of metal and ceramic sculptures, paper flowers, stained glass and sand painting. Her artistic uniqueness in building the altars is defined by the care she takes in adding all the minor details to it that are the most meaningful and traditional in honoring a loved one who has passed. With each element meaning something heartfelt to the beloved, the living and to her ancestors.

Kia's displays often include a different type of ofrenda, not commonly known to most; that dates back to the indigenous "Tlamanalli" ofrendas of the 16th century. The altar is put together by using an Aztec symbol, shaped with her hands, on the ground and garnished by traditional flowers. The symbol is carefully filled in with grains from the earth, salt, colored sand, mulch, clay, seeds, grains and beans. This type of ofrenda is still practiced in Central Mexico today.

Outside of her multiple talents, Kia spends most of her time in the Latino community preserving and teaching the ancient traditions of the Aztecs by art, food and dance in effort to create cultural resistance and she stays active on social media posting information about upcoming pop-ups and events. Recently a recipient of the Kresge Artist Fellowships and Gilda Award for her art and indigenous contributions to Detroit, Kia stresses the importance of always remembering the origin of the Day of the Dead celebration and its influence from the Aztecs. She says "this culture still exists! We are trying to rescue all of these traditions and keep them, embrace them and just share it with everybody." History has taught society that the Aztecs were slaughtered, Kia says "We are still here!".

It seems only shadows remain friends of the poor and disenfranchised in Trump's America. In spite of repeated warnings of armed white militias extremists actively plotting terror in America, President Trump refuses to denounce them. The terrifying disclosure of white armed militia planning to kidnap and murder Michigan Democratic Gov. Gretchen Whitmer left the nation speechless. Disgusting, but it had been clearly foretold. There are thousands of white armed militias like Echo Company that invaded Oakdale CA in June 2020. These extremists are part of what has become known as the Boogaloo Movement. Intelligence, Anti-terrorism Director, JJ MacNab and John Donohue of the Global Anti-Hate Project and Heidi Beirich consider "White Extremism," the most dangerous threat to American democracy.

Proof of the existence of well organized, secret local groups, was made clear in the Kenosha, Wisconsin shooting of a protester by a self-marginalized white adolescent reportedly in love with guns and cops. Through researched articles and essays, I have alerted numerous publications and dozens of small rural newspapers in the Central Valley of California of the potential threats posed by these groups. My advisories have largely been ignored. Tragically, rural community newspapers usually serve to buttress local businesses, rich farmers and landowners. The editors of these papers function as ad-hoc gatekeepers and controllers of arguments over local issues. Their conservative views remain unchallenged because they refuse to offer opposing views equal space. In addition, magazines that boast Spanish names claiming to speak for the people in many cases, are actually only sources of income and celebrity for owners. They have become the hidden unnamed enemies of the poor and disenfranchised.

The Central Valley of California experienced its own version of a white militia armed demonstration that occurred in Oakdale CA in June of 2020. Interestingly this show of force was also ignored by white police officers and minimized by politicians. Dozens of white-armed men claiming to protect businesses from Black Lives Matter protesters defied police, who failed to detain, arrest, or charge them for brandishing weapons. There may not be a better example of how white privilege works in America than the act of turning a "blind eye" to lawlessness by extremists. This level of tolerance for lawbreaking would never have occurred if the armed men had been black or brown men claiming their freedom was in danger or protecting Mexican American owned businesses. Listening to radio talk show hosts like Rush Limbaugh and Sean Hannity, white valley residents claim their freedom is in danger and plan to supervise voting polls armed with AR-15's and other weapons.

Although voter intimidation is illegal politicians have yet to denounce carrying weapons to the voting polls of Newman or Stanislaus County. The condition is similar in other states including Michigan. I was denied an opportunity to volunteer as a poll supervisor because the white woman in charge of the Registrar's office refused to assign me that role. My complaints have fallen on deaf ears even after contacting the city council, county supervisors and congressmen Josh Harder. Strangely, but not surprisingly, my efforts to contact the only black city councilmen of Newman CA were ignored, until I wrote the local paper, called the West Side Index. Mysteriously, the city councilmen responded after weeks of si-

lence. Apparently Black and Hispanic citizens of the central valley cannot count on its local politicians and thereby its police to offer equal justice, due process of law or physical protection. As random gunfire becomes common in Newman so do shootings and suspicious drones. # Michigan unemployment dives as PUA Supplement ends

Michigan's unemployment took a serious nosedive as Pandemic Relief Funds known as Pandemic Unemployment Assistance PUA ended. Since no additional stimulus relief bill has been approved, people are forced to live without this subsidy or risk illness/potential death in the workplace upon returning to work, as Covid-19 cases also spiked in Michigan recently, following a challenge to the Governor's authority to extend emergency declarations pushed by Republican challenges.

According to a report by Mlive, nearly 87,000 fewer people received state unemployment assistance in Michigan, the U.S. Department of Labor announced on Oct. 22, one of the largest drops since mid-summer.

The insured unemployment rate dropped from 9% to 7% for the week ending in Oct. 3, which is the most recent data available for that statistic. Michigan went from about 388,000 people getting state unemployment pay to 301,000.

That marks the fewest number of people on state unemployment insurance in Michigan since March 21.



as COVID-19 concerns continue.

The school district's Board of Education voted unanimously Thursday to continue screen-to-screen learning at least through Jan. 22, according to board President Gabrielle Lawrence.

A decision whether to continue remote learning or move to an in-person or hybrid model will be made before the end of January, she said.

Lawrence supported continued remote learning as COVID-19 positive test rates in the region continue rising.

"We've always been very mindful that one of our major responsibilities as a school district is to protect the health of our students and staff," she said. , according to county Health Officer Linda Vail, but it remains at about 5%. Hospitalization numbers have grown since the end of September and they're now at the highest levels since April, according to the Ingham County Health Department.

Lansing School District officials constantly evaluate the severity of the virus in the region, Lawrence said, and they hope to announce any future decisions as to whether to resume in-person learning quickly.

But there's a caveat to the good news: The numbers don't actually mean that many more people have jobs, it just means they're not getting unemployment pay from the state

OPA said in a press release that it has been contacted more than 19,000 times about officers' conduct at these demonstrations since May 30 and has opened 126 investigations. Among the incidents, the office looked into a June 7 encounter in which demonstrators positioned their bodies to prevent officers on bicycles from leaving a barricaded area. A protester was arrested after refusing to move. Video of the incident shows an officer slamming the protester's head to the ground during the arrest, causing injury. OPA said it was excessive force due to the "lack of resistance on the part of the demonstrator and the lack of a physical threat to officers."

Nationwide protests erupted over the summer following the killings of Floyd and Breonna Taylor at the hands of police officers. While most protests were peaceful, some turned violent.

However, the Trump administration has been aggressively targeting Seattle and other Democratic cities over what it saw as nothing

more than "violent" and "lawless" riots.

## Michigan reports a record 3,338 new coronavirus cases in one day

More than 3,000 new coronavirus cases have been confirmed among Michigan residents in a single day.

Last month the Michigan Department of Health and Human Services announced 3,338 new COVID-19 cases and 35 more deaths. For comparison, the prior day saw 1,826 new cases and 18 deaths. The number of new cases is nearly double the state's previous record of single-day cases.

"The data shows we are continuing to see alarming increases in the incidence of COVID-19 infections in Michigan," Dr. Joneigh Khaldun, chief medical executive and chief deputy for health, said in a press release. "It is now more important than ever that people take this seriously. Wear a mask every time you are going to be around someone outside of your own household. Avoid large gatherings and maintain a safe distance from others. If rates continue like this, we risk overwhelming our hospitals and having many more Michiganders die."

Since the pandemic struck, Michigan has had 158,026 positive cases, 7,182 of which resulted in death. In addition, the state has had 17,586 probable cases and 340 probable deaths.

"While the data represents the date that the information was delivered to MDHHS from re-


porting labs, it does represent more current trends in disease occurrence," the MDHHS stated in an Oct. 24 press release. "In fact, more than 96% of the test results being reported today originated from specimens that were collected from individuals in the past five days."

The agency went on to state that as data is collected by the state's public health community that better describes cases, it is continuing to see clusters of COVID-19 associated with facilities, programs, and schools.

"These cases, along with a large number of community-acquired cases, have been contributing to the elevation in reports of confirmed COVID-19 infection," the MDHHS stated.

Rather than one peak and valley, the daily numbers through the months rise and dip like rolling hills.

The average daily death toll had declined from more than 2,000 per day in April to a low of 463 per day in early July. However, case counts shot up as people began to venture out in summer, and deaths soon followed. By August the virus was killing an average of more than 1,000 people each day.

Sun Belt states had serious outbreaks after Memorial Day when people flocked to beaches. By late summer, the hottest hot spots

were in the Midwest. In August and September, clusters appeared in newly reopened college campuses, particularly in the northeast and Midwest. By October, some Upper Midwest, Great Plains and Western states experienced record surges, including Minnesota, Wisconsin, Arkansas, the Dakotas and even Alaska.

By October, the average was about 800 per day, and several states reported record average highs in new infections and hospitalizations. The last time the country hit a new daily record for coronavirus cases — 76,533 on July 17 — just four states accounted for more than 40,000 of those cases: Arizona, California, Florida and Texas, according to a Washington Post analysis.

Last month, 11 states accounted for that same lion's share of cases. And in the past two weeks, 24 states have broken their records for single-day highs of cases.

More than 170 counties across 36 states were designated rapidly rising hotspots, according to an internal federal report produced Thursday for officials at the Department of Health and Human Services and obtained by The Post.



Altuve continued to excel from there on. On September 11, 2015 he recorded his 800th career hit, surpassing Biggio for the fastest Astro player to reach 800 hits. In the final game of that season, he also reached 200 hits for the second consecutive season, leading the American League, and becoming both the first Astros player and Venezuelan in history to accumulate multiple 200-hit seasons. He also led the AL in stolen bases (38) and made the MLB playoffs for the first time in his career when the Astros clinched a berth.

In that same year, Altuve was awarded his first Rawlings Gold Glove Award, which is awarded to players who have exhibited superior individual fielding performances at their respective fielding positions, and also received his second Silver Slugger Award.

Altuve was a key player in the Astros continued success and their appearance in the 2017 World Series against the LA Dodgers, bringing home the first title in franchise history.

In the Astros' 18-game championship run, Altuve batted .310/.388/.634, had 22 hits, 14 runs scored, seven home runs, 14 RBI, and nine extra base hits. He also established a franchise record for total hits in a postseason, and was named winner of the Babe Ruth Award as MVP of the 2017 postseason.

Altuve accumulated other awards that season, including Baseball America's Major League Player of the Year, becoming the first Venezuelan since Johan Santana to receive the award, and also the first second baseman and Astro to ever do so. For the second consecutive season, he won the Players Choice Awards for Major League Player of the Year and AL Outstanding Player, and won his fourth consecutive and overall Silver Slugger Award at second base.

In 2019, Altuve's role in what became known as the Houston Astros Sign Stealing Scandal for their use of technological aids to steal signs of opposing teams during the 2017 and 2018 seasons, gained national attention. With regard to his accused role of wearing a wire and

stealing signs, Altuve said, "I'm not going to say to you that it was good — it was wrong. We feel bad, we feel remorse, like I said, the impact on the fans, the impact on the game — we feel bad."

Teammate Carlos Correa also came out to defend Altuve's 2017 MVP title and his stance against the Astros' rule-breaking tactics.

Altuve became the first player since Buster Posey in 2012—and the eighth player overall—to win a batting title, MVP and World Series in the same season for 2017. He, along with Houston Texans defensive end J. J. Watt, was named co-winner of the Sports Illustrated Sports-person of the Year Award for his efforts in leading the Astros to their first World Series title and aiding in the recovery of the Greater Houston area in the aftermath of Hurricane Harvey. Altuve became the 18th Major League Baseball player to win the award in its 64-year history, and both the first Houston Astro and first Venezuelan player.

Altuve continues to be a key player for the Astros, winning the ALCS MVP Award in 2019, and leading the Astros to their fourth consecutive playoff berth in the 2020 season.



# Luis Fonsi & Daddy Yankee's 'Despacito' Video Makes YouTube History

Luis Fonsi and Daddy Yankee's "Despacito" has officially become the first video in YouTube history to surpass 7 billion views.

According to YouTube, the 2017 music video averages more than 1.4 million views a day (so far) in 2020 with Daddy Yankee currently No. 16 on the streaming platform's Global Top Artists chart.

The record-breaking news comes just days after Telemundo and Billboard announced that Fonsi and Yankee will receive the Billboard Latin Song of the Decade award for "Despacito" at the 2020 Billboard Latin Music Awards.

The top honor recognizes "Despacito" for its chart milestones, which include topping the Hot Latin Songs chart for a record 56 (non-consecutive) weeks, spending the most weeks at No. 1 for any title since the chart's inception in 1986.

The song's success also set the chart-topping longevity mark on Hot Latin Songs when it spent its 42nd week at the top on the Feb. 17, 2018-dated tally, surpassing the 41-week reign of Enrique Iglesias, Descemer Bueno and Gente de Zona's "Bailando" in 2014-15.

In addition, "Despacito" made history at the top of the Billboard Hot 100 chart in May 2017, tying the then all-time mark for weeks at No. 1 (16) set by Mariah Carey and Boyz II Men's "One Sweet Day" in 1996.

The Puerto Rican superstars Puerto Ricans performed at billboard Latin Music Awards last Oct. 21, live from the BB&T Center in Sunrise, Fla.



# Report: 1 in 5 U.S. Latino, Black Children Have Obesity



## Children of color continue to struggle with obesity.

Obesity rate continues to be significantly higher for Latino (20.7%) and black children (22.9%) than for white children (11.7%) ages 10-17, according to the new State of Childhood Obesity report from the Robert Wood Johnson Foundation (RWJF).

Obesity—and other chronic diseases—are more prevalent among those of color and those in poverty because discriminatory systems have disinvested in healthy policies and basic resources for them. In the midst of the current COVID-19 pandemic, which is worsened by obesity, it is more critical than ever to prioritize children's health. Latino children and young adults account for over 40% of the COVID-19 deaths among people ages 0-24, according to the CDC.

To prioritize children's health, leaders at all levels must rethink the discriminatory systems and policies that put children of color at risk for obesity, disease, poor health, and even death.

"We've seen these disparities for decades when it comes to child-

hood obesity rates," said Jamie Bussel, senior program officer at RWJF. "This year, we've also seen people of color and people with low incomes hit hardest by the COVID-19 pandemic. In both cases these outcomes reflect decades of disinvestment in specific communities and specific groups of people, often driven by the systemic racism and discrimination that are still so prevalent in our society."

## Childhood Obesity Trends

The national obesity rate for children ages 10-17 was lower in 2018-19 (15.5%) than in 2016 (16.1%), but the difference is not statistically significant, according to RWJF's report.

These kids are at greater risk for type 2 diabetes, high blood pressure, and other serious conditions.

## Here are some other key findings:

- One of seven children have obesity. One of five children of color have obesity.
- Obesity rates were significantly higher for Latino (20.7%), Black (22.9%), American Indian/Alaska Native (28.5%), Native Hawaiian/Other Pacific Islander (39.8%) children as compared to white children (11.7%).
- Obesity rates also were higher for children in households making less than the federal poverty level (21.5%) than those in households making at least 400% of the federal poverty level (8.8%). Among states:
  - 20 had obesity rates higher than the national rate of 15.5%.
  - Five had even higher obesity rates: Kentucky (23.8%), Mississippi (22.3%), South Carolina (22.1%), Tennessee (20.4%), and Arkansas (20.2%).
  - 30 states and Washington D.C. had obesity rates lower than the national rate, five of which were statistically significantly lower: Utah (9.6%), Minnesota (9.9%), Kansas (10.6%), Montana (10.6%), New York (10.7%), Colorado (10.9%), Hawaii (11.1%), and Nebraska (11.5%).

Fortunately, RWJF's State of Childhood Obesity report provides policies and recommendations for federal, state, and local leaders to create long-lasting changes to improve child-care settings, schools, and communities so all children can grow up healthy.

**La obesidad, y otras enfermedades crónicas, son más frecuentes entre las personas de color y las personas que viven en la pobreza porque los sistemas discriminatorios han desinvertido en políticas saludables y recursos básicos para ellos.**

**En medio de la actual pandemia de COVID-19, que se ve agravada por la obesidad, es más crítico que nunca priorizar la salud de los niños. Los niños y adultos jóvenes latinos representan más del 40% de las muertes por COVID-19 entre personas de 0 a 24 años, según los CDC.**

**Para priorizar la salud de los niños, los líderes de todos los niveles deben repensar los sistemas y políticas discriminatorios que ponen a los niños de color en riesgo de obesidad, enfermedades, mala salud e incluso la muerte.**

**"Hemos visto estas disparidades durante décadas en lo que respecta a las tasas de obesidad infantil", dijo Jamie Bussel, oficial senior de programas en RWJF. "Este año, también hemos visto personas de color y personas de bajos ingresos que fueron las más afectadas por la pandemia de COVID-19. En ambos casos, estos resultados reflejan décadas de desinversión en comunidades específicas y grupos específicos de personas, a menudo impulsados por el racismo sistemático y la discriminación que aún prevalecen en nuestra sociedad".**
