EXCLUSIVELY FRUIT PRIVACY POLICY

Your privacy and security are important to us. This Privacy Policy ("the Policy") describes how we collect and use your personal Information (as defined below). Please read this Policy carefully. This Policy forms part of our Terms and Conditions. By using our Website (www.exclusivelyfruit.com) and shop (shop.exclusivelyfruit.com), you are accepting and consenting to the collection, use, disclosure and other handling of your Information as set out below.

1 Information we collect

- 1.1 When you use the Website, we collect and retain information that you, as a customer or potential customer, provide to us through the Site, as well as information that is automatically or passively collected from you, your device or your browser (the "Information").
 - 1.1 When you use the websites, we collect and retain information that you, as a customer or potential customer, provide to us through the site, as well as information that is automatically or passively collected from you, your devise or your browser (the "Information").
 - 1.2 This Information you may provide includes:
 - 1.2.1 Contact and profile information including name, email address, postal address including post code, and telephone number.
 - 1.2.2 Account information, including your user name, password, log in details, transaction details.
 - 1.2.3 Credit card information, including the name on the card, card type, card number, expiry date and CV2 is collected and processed by our third-party payment processor. We retain limited credit card information for our records, but we do not store or retain complete credit card information.
 - 1.2.4 Your preferences, including ratings that you provide in relation to products available on our Website.
 - 1.2.5 Your communications to us including any problems you may report to us, queries or comments about our products or Website.
 - 1.2.6 Any other content or information you choose to provide.
 - 1.2.7 Details of your visits to the site, the resources you access and any data you download.

2 information that may be collected automatically

- 2.1 We, along with third parties, may also collect information about you, your computer or device and your use of our website via automated means (for more information about these technologies, see section 7). This information may include:
 - 2.1.1 Information about your visits to the Website, the resources you access, any data you download, and information related to the ways in which you interact with the Website.
 - 2.1.2 IP addresses (including the general information in such address, such as city, county and post code), unique device identifiers, other information about your mobile phone or other mobile device(s), browser types and browser language.
 - 2.1.3 Referral pages and links, URLs, number of clicks, pages viewed, how much time you spend on a page, your search queries and results.
 - 2.1.4 Information about your device, computer and/or browser you use as well as the device's operating system. This may include device hardware model, operating system version, or mobile network information.
- 2.2 We may also combine information that we collect from you with information we
 obtain about you from third parties and affiliates and information derived from any
 other service we may provide.

3 Information from Third Parties

- 3.1 We may obtain additional information about you from third parties such as marketers, partners, researchers and others; but only where we have checked that these third parties either have your consent or are otherwise legally permitted or required to disclose your personal information to us.
- 3.2 We use the information we receive from these third parties to maintain and improve the accuracy of the records we hold about you, and to offer you products that we believe you would be interested in.

4 How will we use your Information?

- 4.1 Our use of your Information will always have a lawful basis, either because using the Information is necessary to allow us to fulfil your orders and perform our contractual obligations to you, because you have consented to our use of your Information (e.g. by subscribing to emails) or because it is in our legitimate interests. We may use your Information as follows:
 - 4.1.1 To provide and manage your account;
 - 4.1.2 To provide and manage your access to our Website;
 - 4.1.3 To personalise your experience on our Website;
 - 4.1.4 To process your orders and supply our products to you;
 - 4.1.5 To provide you with order, billing and delivery information;
 - 4.1.6 To reply to communication from you;
 - 4.1.7 To supply you with emails that you have opted in to (to unsubscribe at any time email info@exclusivelyfruit.com);
 - 4.1.8 To provide you with offers, marketing materials and promotional materials, online and through other marketing channels such as third-party social networks e.g. Instagram and Facebook;
 - 4.1.9 To ask you for feedback and conduct market research;
 - 4.1.10 To analyse your use of our Website to allow us to improve it;
 - 4.1.11 To keep internal records.
 - 4.1.12 To protect against fraud, unauthorised transactions, security issues and other liabilities.
- 4.2 With your permission and/or where permitted by law, we may also use your Information for marketing purposes which may include contacting you by email AND/OR telephone AND/OR text message AND/OR post with information, news and offers on our products. We will not, however, send you any unsolicited marketing or spam and will take all reasonable steps to ensure that we fully protect your rights and comply with our obligations under the [Data Protection Act 1998] OR [GDPR] and the Privacy and Electronic Communications (EC Directive) Regulations 2003.

5 How will we share your Information?

- 5.1 We will only share your Information with third parties in accordance with this Policy or as otherwise required by law.
- 5.2 We may share your Information in the following ways:
 - 5.2.1 With trusted service providers, to perform or assist us in performing any of the functions listed in Section 4.
 - 5.2.2 We may provide analyses of our customers in the aggregate to prospective partners, advertisers and other third parties. We do this so that we and our business partners can understand our customers better and so we can keep bringing you first-rate services. We may also disclose, on an anonymous basis, statements made by our customers such as comments or feedback we receive on our products.
 - 5.2.3 As we continue to develop our business, we may sell, buy, merge or partner with other companies or businesses, or sell some or all of our assets. In such transactions, your Information may be among the transferred assets or may be shared with the other company or business for purposes of evaluating the transaction.

- 5.2.4 We may share your information with third-parties with whom we have a contractual relationship.
- 5.2.5 We may share your feedback or comments. If you post anything to our Website that can be viewed by the general public, we may share that with third parties.
- 5.2.6 We may use third-party Web analytics Services on this Website, such as those of Google Analytics. We may also share certain information about you and the device you use to access our Website in order to deliver tailored advertising. These service providers use technology to help us analyze how users use our Website and to deliver advertising. The information collected by the technology (including your IP address) will be disclosed to or collected directly by these services providers, who use the information to evaluate your use of the Website. - 5.2.7 We may share your Information when we believe in good faith that such sharing is reasonably necessary in order to investigate, prevent, or take action regarding possible illegal activities or to comply with legal process. We may also share your information in situations involving potential threats to the physical safety of any person, violations of this Privacy Policy or the Terms & Conditions; or to respond to the claims of violation of the rights of third parties and/or to protect the rights, property and safety of Exclusively Fruit, our employees, users, or the public. This may involve the sharing of your information with law enforcement, government agencies, courts and/or other organizations.
- 5.2.8 We may share your Information in any other circumstances where we have your consent.

6 Your Right to Withhold Information

- 6.1 You may access certain areas of the Website without providing any data at all.
 However, to use all features and functions available on Our Site you may be required to submit or allow for the collection of certain data
- 6.2 You may restrict our use of Cookies. Please see section 7 and our separate Cookie Policy.

7 Use of Cookies

- 7.1 A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added, and the cookie helps analyse web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.
- 7.2 We use traffic log cookies to identify which pages are being used. This helps us analyse data about web page traffic and improve our website in order to tailor it to customer needs. We only use this information for statistical analysis purposes and then the data is removed from the system.
- 7.3 Overall cookies help us provide you with a better website, by enabling us to
 monitor which pages you find useful and which you do not. A cookie in no way gives us
 access to your computer or any information about you, other than the data you choose
 to share with us.
- 7.4 You can choose to accept or decline cookies. Most web browsers automatically
 accept cookies, but you can usually modify your browser setting to decline cookies if
 you prefer. This may prevent you from taking full advantage of the website.

8 Marketing

8.1 We will only use your email address for marketing when permitted by law. You can
opt out of receiving future communications at any time. You may also unsubscribe from
receiving all marketing emails by writing to us or emailing us using the Contact Details
below.

9 Security

- 9.1 Our security and privacy policies are periodically reviewed, and we will continue to enhance our security procedures as new technology becomes available. Whilst we cannot ensure or guarantee that loss, alteration, unauthorized access or improper use of Information will never occur, we use all reasonable efforts to prevent it.
- 9.2 While we make every effort to ensure that your Information is secure on our system, you should bear in mind that submission of information over the Internet is never entirely secure. As a result, we cannot guarantee the security of any information you transmit to us and you do so at your own risk.
- 9.3 It is advisable to log out and close your browser when you have finished your user session to help ensure others do not access your personal information if you use a shared computer or a computer in a public place.

10 Data Retention

- 10.1 We retain personal information we collect from you where we have an ongoing legitimate business need to do so (for example, to comply with applicable legal, tax or accounting requirements).
- 10.2 When we have no ongoing legitimate business need to process your personal information, we will either delete or anonymize it or, if this is not possible (for example, because your personal information has been stored in backup archives), then we will securely store your personal information and isolate it from any further processing until deletion is possible.

11 Your Rights

- 11.1 You have the right to ask for a copy of any of your personal data held by us (where such data is held). Under the GDPR, no fee is payable and we will provide any and all information in response to your request free of charge. Please contact us for more details at info@exclusivelyfruit.com.
- 11.2 If you wish to request deletion of your personal information, you can exercise this right by contacting us using the contact details below. In addition, you can object to processing of your personal information, ask us to restrict processing of your personal information or request portability of your personal information. You can exercise this right by contacting us using the contact details provided below. Similarly, if we have collected and processed your personal information with your consent, then you can withdraw your consent at any time.
