'Florida Friendly' gardening Kanuga home is first in city

When Jon and Sherry Derrevere bought their Kanuga Road home in 2020 they set

about turning the building and yard into a showcase of the beauty and uniqueness of the property.

Sherry envisioned an outdoor space that conserves water, provides a habitat for birds, butterflies and bees, and offers family and friends a serene place to relax.

She wanted to honor the history of the home and yard, and reached out to several arborists to try to save a large oak tree in the backyard. Unfortunately, all those experts recommended the removal of the tree.

Sherry consulted experts on native plants and took every opportunity to learn

about how to create an environment that attracts butterflies. She joined the Native

Plant Society and most of the plants and shrubs now in her yard are drought-tolerant natives. She avoids using herbicides and pesticides and uses minimal irrigation.

What Sherry was doing on her own initiative coincided with the aims of a three-decades-old partnership between University of Florida and Florida Department of Environmental Protection that recognizes people who manage their yards in a responsible manner and protect Florida's water resources.

What began as Florida Yards and Neighborhoods, funded by DEP since 1993, is now the Florida Friendly Landscaping

President's column

Code requirement changes in the works with our help

You probably recall the code hubbub of last autumn — or read about it in my September and November columns — wherein the West Palm Beach code officer

After several residents were cited and fines issued — and the ensuing

uproar — the city placed a temporary hold on all parkway code enforcement, the idea being to look at the current code and determine if and how it needs to be revised.

The city asked for

representatives from Flamingo Park to participate in the process. Horticulturist Joel Crippen, master gardener Carolyn Reikenis and I are those representatives.

If you would like to share any concerns or make suggestions, please contact one of us. This is our opportunity to make our voices heard.

Our committee met approximately a month ago and we have compiled a list of suggestions for the city to consider when drafting a new code. City staff and community representatives are all in agreement that the focus of the code should be on safety and visibility, rather than mandating any specific landscape material.

The current code addresses

Why leash your dog? It's city and county law!

It was only two Flyers ago, (March/April) where we wrote an article that we hoped would not only educate, but hopefully change the behaviors of, some dog owners who do not leash their pets.

I've recently learned of a third incident in three months where dog owners did not have their pet on a leash when walking, and another person felt threatened. And the dog owner didn't seem to care about the city and county leash law.

I would not be writing this today were it not for residents appealing to me as an FPNA board member to ask the board to find a new way to get this message across.

For the record, all dogs must be on a leash if you are walking it off your property. This includes sidewalks, streets, parkways, public parks (other than dog parks) and any public right of way.

There is no provision for "voice command" in the West Palm Beach or Palm Beach County ordinances (14-31 and 98-22, Section 4-4a respectively).

We didn't mention sidewalks last time but we must communicate this fully: The sidewalks are city property (hence city rights of way).

I do a lot of walking throughout the whole neighborhood — all the time. Where do I see folks walking their dogs? — on the sidewalks.

Is it not enough to ask residents to obey the law? But also to ask them for courtesy?



Historic Roosters reopens

Five years after a devastating fire at this popular gay bar, Roosters reopened after a \$2.5 million makeover. The May 19 grand reopening featured several speakers and a very proud owner, A.J. Wasson.

In 2021, a year after the fire, the city of West Palm Beach listed this icon on the local Register of Historic Places. In making the historic case, it was stated that the "site is the location of the oldest still operating gay Bar in Palm Beach County."

On June 4, Roosters was celebrated again at a reception and panel discussion as part of the Pride Month exhibition at the Richard and Pat Johnson Palm Beach County History Museum.

Doggie station facts and thanks

Flamingo Park arranged some years ago with the city to have five doggie-bag stations installed at critical points throughout the neighborhood — and strategically next to one of our own corner trash cans.

As a reminder, they are on Lake Avenue at Kanuga Drive, Biscayne Drive and Upland Road; and on Georgia Avenue at Biscayne and at Upland.


Each of these stations has a station-tender (as it were) who adds the biodegradable bags when they run out. The bags are purchased by a volunteer who gets reimbursed and gives the bags to the station-tenders.

During the past 12 months, we have spent approximately \$1,000 on these bags!



ground cover and plant material. It does not include trees. Planting or removing trees in the parkway does, however, require a permit.

The committee is also requesting that staff look at reducing the fines in the code. The current fines are severe and can create financial hardship.

Once the city drafts a new citywide code, staff must hold public meetings before it is adopted. We will keep you informed of those dates, which will also be publicized by the

After the code is finalized, there will be educational programs and email notifications advising residents of the new code.

The fact that the city recognizes the need to revise the code and has asked for our input is very positive. It shows they are listening and trying to help us meet this challenge. As we move forward, we will keep you updated.

On another note: With the approach of our 2026 Garden Tour and with so many proud

gardeners in our neighborhood, as well as new residents to Flamingo Park and Florida, we are starting a regular *Flyer* feature that focuses on our gardens. The aim is to feature residents' gardens or answer questions from Flyer readers about what works, or doesn't, in our particular planting conditions.

I hope there is interest and you will be sending in questions. In the absence of new questions, we will pick a topic. We've kicked it off with a look at a garden recognition program (story, Page 1).

Last, but not least, our monthly social hours ("Flamingles") are in dire need of hosts for the months of July and August. These events are a wonderful way to meet new neighbors and catch up with old ones. This has been a Flamingo Park tradition for many years.
