# **MISSION GATE UPDATE**

#### November 2024

As you may know, some of the cabins at Fort Good Shepherd Ranch of Mission Gate sit on the banks of the Meramec River. Fort Good Shepherd is a 54-bed facility for men re-entering society from prison. It occupies 130 acres, with five large homes and individual cabins. On Sunday, November 3rd, the area around Cuba and Steelville, MO was flooded with more then 10 inches of rain over three days. On Tuesday, Novem-



ber 5th, the river overflowed the banks, flooding 14 cabins and forcing 14 men out of their homes and into common living areas or other housing on campus. To show you the force of the water we had a 500 gallon propane tank, a picnic table and railroad ties all floating down the river. Our activity center and tool shed were also flooded. Praise God, all our residents and animals were safe! However, we are concerned that what was once a very rare occurrence is happening now more frequently. This is the second largest flood in the history of this part of the river cresting at more than 28 feet above the normal water level.

Unfortunately, our insurance does not cover the damages to these smaller cabins. Therefore, we need you help; 10 out of the 14 cabins were affected by this natural disaster. Resulting in an estimated cost of \$40,000 for renovations and remolding. This will help get 10 men back in their homes. The morale of our men is currently high, but it will soon become a strain on everyone. Our displaced residents are doubling up and sleeping on sofas. The other four cabins received significant damage where they were shifted off their foundations. We have decided to demolish them since they are so close to the river's edge. By the time you receive this newsletter, we will have already had three workdays and countless hours of work from our staff, residents, and the community with more workdays to come.

What does this mean for our future? We are praying about constructing a new bunkhouse on higher ground which would take 9 to 12 months to complete. It would be located next to the Wilderness Lodge where nine other men currently reside. Kevin O'Brien, one of our board members who owns Agape Construction, is planning to donate architectural design services as well as carpentry labor to help frame the new building. Mission Gate will be responsible for all building materials, appliances, electrical, plumbing, etc. Please pray if there is any way you can help with this project as we continue to change lives from crime to Christ!

All of this was unexpected and of course unbudgeted, and as we said, insurance does not cover any of the cost. As of now, we know we need \$40,000 to remodel the 10 cabins, which by the grace of God is much less than it could have been.

We are asking you to:

- Please pray and ask the Lord if He is leading you to help financially with the cost of our initial remodeling of the 10 cabins;
- Please pray for the dozen men who will still be displaced after we complete the first project, and for our new Christian men who have already been approved to come but have yet to be released from prison.
- Please pray for guidance for our Board as we decide what to do about a new bunkhouse, and consider whether you can assist us in the future if the Lord leads us to move ahead with that project;

Needless to say, this is a difficult time for us, but the Lord is already bringing good out of it. Our community is pulling together, and the faith of our staff and residents is rising to the surface. He is a good God who always keeps His promises, and we know that He will lead us through this test and support us as we serve Him!
