

Ongoing Garbage Management Dispute in Natchitoches Parish

Natchitoches Parish is facing a significant dispute over garbage management between Parish President John Salter and the Parish Council, regarding whether to continue outsourcing waste disposal to Waste Connections Bayou, Inc., or to bring operations inhouse. Salter argues that internalizing waste services could save taxpayer money and improve local road infrastructure. However, on August 19, 2024, the Parish Council voted to extend Waste Connections' contract for three more years, a decision Salter did not endorse, resulting in a halt to waste services on August 31, 2024. However, on August 19, 2024, the Parish Council voted to extend Waste Connections' contract for three more years, a decision Salter did not endorse, resulting in a halt to waste services on August 31, 2024. The City of Natchitoches also has a contract with Waste Connections Bayou, Inc., that is tied to the parish's disposal site. If the parish changes its disposal site, it could lead to increased costs for the city, which would be passed on to city residents. Salter has reassured residents that his plans would not affect City of Natchitoches garbage services and called for public engagement at council meetings. The situation has been compounded by frequent quorum issues within the council, notably during a failed special meeting on July 1, 2025, where insufficient attendance hindered decision-making. Councilman Braxton, Cheatwood, and Allen state that a special meeting was called for July 1, 2025, on the holiday weekend, and Allen was currently in California. Other council members had already made plans and were unable to attend. Braxton states that this was a ploy to have two council members who consistently agree with all of Salter's requests call a special meeting, in hopes that one member would be available. He would then be able to approve and pass his requested agenda items. Some council members have raised questions about the financial details justifying the contract renewal with Waste Connections and whether proper bidding procedures were followed in past purchases. Agenda items included awarding bids for solid waste equipment and granting the President the authority to sign all necessary documents. According to Chairperson William "Bill" Allen, Salter has sent bids to purchase garbage containers that he has already purchased on May 8. He states, "Why vote to allow Salter to do what he had already done?" He states that Salter does what he wants, regardless of the vote, and then refuses to sign the contracts. He further states that Salter wants to go back to the police jury form of government and continues to bully his way through to get what he wants. Cheatwood stated, "Although at the monthly meeting held on June 16, 2025, the requests to purchase equipment were voted down, Salter called a special session to revote." Residents are encouraged to attend and voice their concerns at parish council meetings.



From One Suit to 12 Doors: This Baton Rouge couple buys the block with faith, integrity

In the heat of a Baton Rouge afternoon, a group of boys—third, maybe fourth graders—gravitate toward the front windows of *The Master's Touch*, a men's clothing store. Inside, suits hang in perfect rows: bold plaids, sharp pinstripes, deep navies and maroons under spotlit beams. Pocket squares in regal folds, monk strap shoes in polished repose. The boys take it all in: the way the light catches cufflinks; the way Mr. William Bates, the owner, wears style like it's stitched into his skin; his car; and his beautiful wife, Mrs. Maria. The boys return throughout the month to see what's happening in the store.

For the Bates's, their business is a kind of ministry.

William is an executive pastor at Living Faith Christian

Center and a businessman. Maria is a nurse and an uncompromising believer in Divine instruction. Together, they are the founders of *The Master's Touch*, a thriving haberdashery, and its sister real estate enterprise, Bates Real Estate Inc.

Their journey began with a single suit—and a \$499 dilemma—that unlocked the beginning of their faith-filled mission to follow God's instructions.

Within a conference room at their newly renovated commercial complex, Maria Bates recalled Christmas 2007, when she wanted to buy an exquisite suit William desired. "As his wife, I always want to spoil him, so I started looking and asking God to help me find it. We had two young children. He was a new pastor, and I was new in nursing. We just couldn't afford a \$499 suit," Maria said. *Continued on page 7...*

A Suit, A Store, A Whisper from God

Maria searched department stores for the suit to no avail. Ultimately she took the SKU number, scoured the Internet, and found the seller who had the suit at a steep discount, but couldn't sell it to her without a wholesale license.

"I asked God why did He bring me to this suit and I could not purchase it," Maria said. Her voice charged with the memory. God instructed her to get a business license and to buy suits and accessories from the manufacturers. "He told me everything to do," she said, and she wrote the vision in detail, put it in an envelop, and packaged it with a different suit from JCPenney. Christmas Day, William opened the envelop, but never wore the suit.

They agreed to obey God and days later, while driving, William was given *The Master's Touch* as the name for the men's store: "It wasn't Kingdom. It wasn't secular," said William, "but it was still Kingdom."

Between work, family time, and ministry, William sold suits, ties, shoes, and handkerchiefs from their home until it became inundated with inventory, late night fittings, and customer pickups. It was the start of the Great Recession of 2008 and *The Master's Touch* needed to move.

While driving down Monterrey Drive, Maria had an unmistakable feeling that a shuttered photography studio in a vacant business complex was meant to be theirs. "God told me that was our store," she admitted. With that conviction she hunted the internet until she found the landlord: Mr. Larry K. Sullivan. The space was dilapidated and, although he agreed to rent it, he would not make renovations. The Bateses cleaned the place with their own hands. Gutted floors. Painted the walls. William studied build-outs, lighting, and store layouts. They purchased racks, lighting, and moved inventory. They used \$50,000 personal credit cards and their income; then, Maria found an online bank who offered a \$25,000 unsecured line of credit which they repaid just before that bank closed under the weight of the recession. They redesigned the store with the kind of excellence that made people stop mid-step. *Continued on Page 8...*

Buying the Block

Fast forward to December 2022. Bates Real Estate Inc. purchased the business plaza: 12,989 square feet, 1.2 acres of land, five existing tenants, and seven empty commercial units. With a half a million dollar commercial loan and owner-financing, the Park Forest Business Plaza was their first real estate deal and their first commercial holding. They invested another \$80,000 in electrical rewiring and infrastructure upgrades across the entire complex, including new AC systems, doors, windows, ceilings, floors, and outdoor lighting.

Between structural upgrades, environmental surveys, architectural plans, and city board approvals (including a 10-year property tax lock), every technical hurdle was met—often with the help of business development programs. They leveraged a city grant for underground surveys and environmental panels—saving what would've been tens of thousands of dollars.

"Most folks start with a house. Maybe a duplex," William said. "We started with 12 doors..." We felt like God would fill this space up."

Today, 31 months later, those 12 units are full. Not with predatory lenders, but with community-facing businesses: Vina Nail Salon, AA Tax Services, House of Fades Barbershop, Bluebird Massage Studio, Beautiful Music Productions, Sophisto ladies boutique, a Chosen Financial--a Prudential firm offering investments and insurance, Knot Just Hair Beauty Parlor, The Blooming Aesthetics Bar, even a late-night comfort food spot, Midnight Munchies. And of course, the flagship: *The Master's Touch*.

The plaza itself is a case study in quiet transformation. They replaced desolation with development. Maria explained how businesses like payday loans, predatory lenders, and liquor stores suppress the community, especially one that is 77% Black like Park Forest.

"The beautiful thing is that because we live in this community, we are concerned about the value that we bring," William said.

"When you own the block, you get to decide what goes in it. That's power. That's stewardship." Williams said, and he has turned down prospective tenants who didn't align with the vision. On one occasion a representative from a white-owned property firm scouted a unit. On a phone call, she referred to men working nearby as "thugs." William said he interrupted her call, saying, "Those people are not thugs...Those are men. Those are Black men. They're not thugs. You nor your (partners) cannot rent here."



Red Beans and Rice Cookoff to be part of Natchitoches-NSU Folk Festival July 19

NATCHITOCHES – This year's Natchitoches-NSU Folk Festival on July 19 will include a Red Beans and Rice Cookoff. Professionals and hobbyists alike can compete to demonstrate their cooking skills. Registration and the cooks' meeting will take place at 8 a.m. in the N-Club Room inside Prather Coliseum. Cooking officially begins at 8:45 a.m. The Festival will be held in the air-conditioned Prather Coliseum located at 220 South Jefferson Street on the Northwestern State University campus in Natchitoches.

Tasting and judging will begin at 12:30 p.m. with winners to be announced at 2:15 p.m. First place will be awarded to the categories Pork Sausage, Other Protein Sausage and People's Choice. The category Other Protein Sausage may include sausage made from chicken, beef, duck, turkey, wild game, etc. There is no fee to compete in the Cookoff. Red beans must be cooked on-site outside of Prather Coliseum, although beans may come pre-soaked.



Competitors are provided a 10' x 20' cooking space outside Prather Coliseum where they will make their temporary kitchens using either propane burners or contained cookfires in order to prepare a minimum of two gallons of their finest red beans and rice. Cooking with charcoal is allowed. Running water is available to competitors, but all ingredients and supplies must be brought on site by the head cook. Chefs are not allowed to use any pre-made mixes or roux, though proteins and broth/stock may be prepared in advance, with all proteins being kept on ice until use. Red beans and rice must be cooked on site and contestants are responsible for all serving and sampling dishes and utensils, as well as all items needed to prepare their dishes and workstations. "A Buck A Cup" red beans and rice sale to the public for the People's Choice category will begin at 1 p.m. Festival attendees will be invited to purchase the red beans and vote on which red beans and rice they most enjoyed. Chefs participating in "A Buck A Cup" must provide their own bowls, spoons and napkins.

In addition to the cook-off, this year's Natchitoches-NSU Folk Festival will include the Louisiana State Fiddle Championship, three stages of live music, over 75 crafts people, Louisiana cuisine food vendors, dance lessons, informances, narrative sessions, on-site demonstrations, and much more. Admission to this family friendly event is only \$10 for an all-day all event pass, after 5 p.m. passes are only \$6, and children 12 and under are admitted free all day.







But when we surrender all to him and seek his face, he is a rewarder to those who diligently seek him. The Apostle Paul encourages us about that in Hebrews 11:6. And I wouldn't take nothing for my journey now.


