I, Shirley Jean Oyer am an American and a member of We the People... sovereign body politic of the United States of America, acting for and on behalf of Benjamin Judd Gerber with "power of attorney".

**PREAMBLE**

(for the Constitution for the United States of America)

We the People of the United States in Order to form a more perfect Union establish Justice, insure domestic Tranquility, provide for the Common Defense, promote the general Welfare, and secure the Blessings of Liberty to ourselves and our Posterity, do ordain and establish this Constitution for the United States of America.

All authority and jurisdiction throughout the entire union of the United States of America trickles down from the Constitution create by We the People...sovereign body politic of the United States of America.

No one or agency of government can have authority or jurisdiction over its creator, We the People...sovereign body politic of the United States of America.

Sovereignty rests with the People:

Chisholm v. State of Georgia In the Supreme Court case of Chisholm v. Georgia, the justices rejected Georgia's claim of sovereignty and concluded that the people, not state governments, are sovereign.

The Supreme Court gets its authority from the Constitution of the United States of America

All others' courts, federal, state, city, and municipal gain their jurisdiction from the above. All agencies of government, federal, state, city, and municipalities also gain jurisdiction from the above.

Kansas Bill of Rights, Sec 2 Political Power; privileges:

All political power is inherent in the people, and all free governments are founded on their authority and are instituted for their equal protection and benefit. No special privileges or immunities shall ever be granted by the legislature, which may not be altered, revoked or repealed by the same body; and this power shall be exercised by no other tribunal or agency.

There is no jurisdiction gained over a member of "We the people...sovereign body politic of the United States of America" unless they have injured another. There has to be a signed complaint from an injured party for any court or agency to obtain jurisdiction over a member of "We the people...sovereign body politic of the United States of America".

Comes now, Shirley Jean Oyer for and on behalf of Benjamin Judd Gerber, a member of We the People...sovereign body politic of the United States of America to lawfully challenge the conduct of unknown Police Officer, Judge Christina Dunn Gyllenborg and District Attorney Jameson O'Connor for extorting a plea deal without jurisdiction or authority of law, utilizing "Fiction of Law" as the authority relied upon. To establish "personal and subject matter jurisdiction" for the court to exercise its authority a "Complaint" signed by an "injured party" must be present. The common practice of "fraud on the court", by naming the "STATE OF KANSAS" as Plaintiff, establishes this "Fraud" is present.

To be a member of "We the People...sovereign body politic of the United States of America" one must be born in one of the Union states and have 1 parent born in one of the Union states.

I, Shirley Jean Oyer, was born 7-15-41 in the Union State of Missouri, Certificate of Live Birth Number 124-41-039225, Mother Eleanor Emma Reinagel Hoshaw, born in St Louis, Missouri and Father, John Jacob Hoshaw, born in Kansas City, Missouri. Both parents were born in a Union State as stated on passport # 5496066051.

I, Benjamin Judd Gerber, was born 10-07-1976 in the Union State of Kansas, Certificate of Live Birth Number 115-76-027026. Mother, Judith Lorain Lanningham, born in Jackson County Missouri and Father, Arnold William Gerber II, born in Kansas City Kansas. Both parents are born in a Union State as shown by my application for Passport NO. 421815151 issued by the State Department of the United States of America.

## **FACTS OF THE CASE**

1. On the morning of December 12, 2023 Benjamin Judd Gerber was parked around 91<sup>st</sup> & Metcalfe, Overland Park, Kansas. He had telephoned me for a ride but before this could happen, a police officer wearing a gun and displaying a badge from a police department took him out of his truck. No police report has been introduced in this case, I was told by the Overland Park Police that I could not have a copy and that one would have to be subpoenaed by an attorney. Benjamin Judd Gerber expressed to me that this police officer was laughing and making fun of him and trying to get him to say things that he would not say. This police officer then threatened him into blowing into a tube saying that if he didn't do as asked, blood would be taken. At this point, Benjamin Judd Gerber's 4<sup>th</sup> and 5<sup>th</sup> Amendments of the United States Constitution and the Kansas Bill of rights Sec. 10 rights against self-incrimination have been violated. Benjamin Judd Gerber was then kidnapped and had his property stolen (truck was towed)
2. Benjamin Judd Gerber then expressed to me that he remembered being taken somewhere for processing and being transported to Johnson County Detention Center. Apparently Benjamin Judd Gerber thought that wherever he was taken for processing didn't have a holding cell. This happened around 1:00 am. My, Shirley Jean Oyer's, memory of that morning is a little bit fuzzy. Later Benjamin Judd Gerber was sent by the Johnson County Detention Center to the hospital on a medical emergency.
3. This officer was acting without authority to remove Benjamin Judd Gerber from his truck as this police officer had no complaint signed by an injured party, he had no warrant supported by a complaint signed by an injured party and he had no indictment from a grand jury supported by a complaint signed by an injured party.

From this point forward everything is "Fruit of the Poisonous Tree".

4. I, Shirley Jean Oyer, who holds "limited power of attorney" for conducting legal affairs for and on behalf of Benjamin Judd Gerber, presented an "Amicus Curiae Brief" to be filed in his case. The clerk said that she would have to get the Judge's permission to file this document. Later the clerk sent an email saying that the judge did not give her permission to file. This conduct established "Obstruction of Justice" 18 U.S.C 1503. Because the Judge refused to file the "Amicus Curiae Brief" establishes a violation of the 5<sup>th</sup> Amendment Right to "due process of law" by the suppression of evidence.
5. Benjamin Judd Gerber requested a trial by jury and was denied. This was a violation of Kansas Bill of Rights, Sec. 5, Trial by jury. The right of trial by jury shall be inviolate, and establishes a violation of the 6<sup>th</sup> Amendment Right to trial by jury in a criminal case.

6. Benjamin Judd Gerber was once again threatened (in front of two witnesses, Benjamin Jedd Gerber's mother and Shirley Jean Oyer) to accept and sign a plea agreement or face 41 months in prison.

#### **14<sup>th</sup> AMENDMENT**

**SEC 1. Citizenship; privileges or immunities; due process clause.** All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the Unites States and of the Sate wherein they reside.

Benjamin Judd Gerber was not born in the United States or naturalized in the United States and subject to the jurisdiction thereof and is not a citizen of the United States. He was born in the independent country of Kansas.

No American can be born in the United States or the United States of America, as these are titles of an organization ordained and established by, We the People...sovereign body politic of the United States. This organization is made up of 50 independent countries for specific purposes.

See **Title 28 U.S. Code § 297** - Assignment of judges to courts of the freely associated compact states

**(a)**

The Chief Justice or the chief judge of the United States Court of Appeals for the Ninth Circuit may assign any circuit, district, magistrate, or territorial judge of a court of the Ninth Circuit, with the consent of the judge so assigned, to serve temporarily as a judge of any duly constituted court of the freely associated compact states whenever an official duly authorized by the laws of the respective compact state requests such assignment and such assignment is necessary for the proper dispatch of the business of the respective court.

**(b)**

The Congress consents to the acceptance and retention by any judge so authorized of reimbursement from the countries referred to in subsection (a) of all necessary travel expenses, including transportation, and of subsistence, or of a reasonable per diem allowance in lieu of subsistence. The judge shall report to the Administrative Office of the United States Courts any amount received pursuant to this subsection.

#### **CONCLUSION**

If the above is not refuted, it will stand as truth.

The unknown Police Officer, Judge Christina Dunn Gyllenborg or District Attorney Jameson O'Connor need to present a complaint signed by an injured party within 30 days or this cause of action should be dismissed in its entirety. Benjamin Judd Gerber should

be released immediately and all bails, fines, towing fees and other expenses for unlawful incarceration should be returned to Plaintiff/Defendant.

My Agent shall have full power and authority to act on my behalf but only to the extent permitted by this Special Power of Attorney. My Agent's powers shall include the power to:

1. Institute, supervise, prosecute, defend, intervene in, abandon, compromise, arbitrate, settle, dismiss, and appeal from any and all legal, equitable, judicial or administrative hearings, actions, suits, proceedings, attachments, arrests or distresses, involving me in any way.

I hereby grant to my Agent the full right, power, and authority to do every act, deed, and thing necessary or advisable to be done regarding the above powers, as fully as I could do if personally present and acting.

My Agent shall not be liable for any loss that results from a judgment error that was made in good faith. However, my Agent shall be liable for a willful misconduct or the failure to act in good faith while acting under the authority of this Power of Attorney. No person who relies in good faith on the authority of my Agent under this instrument shall incur any liability to me, my estate or my personal representative. I authorize my Agent to indemnify and hold harmless any third party who accepts and acts under this document.




