ESSENTIAL JOB TASKS:

• Identifies potential hazardous materials on future Transportation Improvement Program projects and Operations and Maintenance projects by reading engineering roadway plans

- and performing site survey visits while also providing guidance and recommendations for compliance on these projects
- Provides technical expertise, guidance, and project support to engineering staff, project
 engineers, and others regarding hazardous materials compliance, policies, legislation, trends,
 standards (e.g., American Society for Testing and Materials), and regulations
- Conducts site investigations/surveys using sound scientific methods, gathers evidence, analyzes data, prepares reports, makes recommendations, and consults and coordinates efforts with other agencies (Federal, State, and Local) to assure compliance with statutes, rules, regulations, and policies governing environmental (Hazardous Materials, Resource Conservation and Recovery Act, National Environmental Policy Act, etc.) issues
- Prepares various levels of environmental documentation (Lead-Based Paint Reports, Preliminary Initial Site Assessment Reports, Phase I Reports, Asbestos Reports, etc.)
- Manages projects, conducts analysis, coordinates agency interests, and provides technical expertise to help the organization get authorization for construction by coordinating environmental outcomes with interested parties
- Develops and formally documents environmental recommendations/mitigation based on findings for the clearance of project sites
- Provides technical reviews of Hazardous Materials Specialists/Consultants documents/reports; provides information to the public and other agencies
- Stays current on technical and non-technical environmental information; represents MCDOT on committees and planning groups
- Develops project scopes and budgets; manages consultant contracts; defines issues and implements solutions
- Makes presentations and provides regional leadership in environmental issues

Working Conditions

Must be able to work in a standard, indoor office environment. Must be able to work outdoors in a roadway project environment or an isolated desert environment. Must have the manual dexterity of hands and body to operate office equipment; motor vehicles, hiking/walking in varied terrain outdoors. Must be able to manage frequent interruptions, time pressures, high work volumes, multiple and complicated tasks, unscheduled tasks, team-oriented activities, prompt decision-making, and interaction with government officials and the public. Must constantly maintain concentration, accuracy, ethical behavior, and a professional demeanor. Must be able to file and lift/carry/push and/or pull 25 pounds.
