We have 3 applications for Heritage Defense funds from three different organizations and each has sent verified proof that it has 501 (c)3 status.

They are in order received and were received by the deadline.

Sons of Confederate Veterans Camp 2282, the 34th Texas Cavalry based in Mineral Wells. Their book committee is putting together Volume 1- Confederate Pioneers of Palo Pinto County. Artist John Paul Strain as been contacted to illustrate the book cover. Total cost of the project is \$8,000.00. The camp is requesting \$3,000.00. The book draft is more than 40% compete. Publication is expected in August 2019. Two of the men on the Book Committee are experienced writers and have had similar works and other books of Confederate history published.

Suggestions from Committee have been \$250.00 \$300.00 or \$400.00 (or offer another amount)

From UDC, Major George B. Erath Chapter 2679, Stephenville for repair and cleaning of one section of the Old Dublin Cemetery in Dublin. About 30 or so graves involved. The grunt work will be with the help of 2nd Texas Frontier District SCV Camp 1904, DeLeon. The bio-cleaner is \$40.00 a gallon, the repair kits for the grave marker is \$75.00 each. 5 graves equals about \$450.00. Total project is \$800.00, the request is for \$250.00

Suggestions from the Committee have been for \$150.00 or \$200.00 (or offer another amount)

Sam Davis Christian Youth Camp in Clifton Texas is requesting help with a scholarship and/or supplies. This is a week-long camp and campers remain there for the week. They are immersed in Confederate and bygone eras of everything from dancing to leather crafts to historical classes often presented by different SCV Camp members. A \$500.00 scholarship for one camper provides housing, food, teaching materials and camp chaperons for the boys and girls who attend. Also \$400.00 in craft supplies. \$200 for boys and \$200 for girls is requested for a total of \$900.00

Suggestions from the Committee have been for \$500.00 or \$400.00 (or offer another amount)

Heritage Fund Project to be set up:

A. Certificate of Deposit in the amount of \$5,000.00 as base fund. Interest is retained to grow account. A 2/3rds ballot vote of Assembly at Annual meeting is required to allow interest to be withdrawn. Funds cannot drop below start up amount nor can any withdrawal cause forfeit of interest earned on CD.

B. Checking Account-\$1,500.00 interest bearing, if possible, will be used to fund each year's selected Project(s). Going forward, no more than 2/3rd's of money collected from all fundraisers will be put in this account.

C. Savings Account- \$(remainder)Going forward no more than 1/3rd of the money collected from all fundraisers will be put in this account. Withdrawal from Savings only when necessitated by Projects approved by Assembly. (January-5-2019)
