Cooled Semen Contract for the 2026 breeding season.

I, _____ hereby agree on this _____ day of _____
to breed the mare, _____ Registration # _____
APHA/AQHA (circle one) to the stallion, MJP Blazin Irish, AQHA Registration #6294668,
using cooled semen during the 2026 breeding season (April 1st - July 1st).

- 1) The 2026 breeding fee is **\$1,200**. The non-refundable **\$500** deposit is due with the return of this contract. The remaining **\$700** is due at the time of the 30 day heartbeat check. A copy of both sides of your mare's registration papers must be submitted with this contract. The owner recorded on the mare's registration papers will be the owner recorded on the Stallion Breeding Report. This contract and the mares papers must be mailed to the address listed at the top of this page.
- 2) Standing the 2026 season at the University Of Pennsylvania's Hofmann Reproduction Center, a division of the New Bolton Center in Kennett Square, PA.
**Mare owners interested in having their mares bred on site should contact the Hofmann Center directly.

Collection & Shipping Days: Monday, Wednesday, & Friday.

Cooled Semen Fees : \$350 will be the cost of collection (subject to change at the discretion of the University of Pennsylvania). This fee must be paid before any semen will be shipped. It is the MARE OWNERS responsibility to arrange pick-up directly from the Hofmann Center, or to have a FedEx or UPS airbill. The cost of shipping will be billed to the mare owner via their account with UPS or FedEx or credit card.

Cooled Semen Requests : MUST be made BY PHONE to the number listed at the top of this page (Karina Evans) by 3:00 PM the day BEFORE semen needs to be collected.

- 3) Payment Options: All booking/stallion fees can be paid via Money Order/Cashiers Check or Personal Check (if personal check bounces, a return check fee of \$35 will be charged) made out to KEE Performance Horses LLC. If you desire to submit payment via Venmo or PayPal please reach out to Karina.



- 4) Live Foal Guarantee: A live foal is described as a newborn foal which stands and nurses without assistance. If a foal is stillborn, or a mare absorbs/aborts a predetermined pregnancy there are return privileges IF the stallion owner is notified within 30 days and receives a statement, from the veterinarian, confirming this. The LFG will only apply to the mares that are certified in foal by a licensed veterinarian. If the mare does not conceive, or deliver a live foal, the mare will have rebreeding privileges the following season with NO re-breed fee the following year. The stallion owner may approve a substitute mare to use the rebreeding privilege. This is only acceptable if the original mare is deceased or deemed unfit for breeding. If the mare does not settle after the second breeding season, there will be a re-breed fee of \$250 every year after that.
- 5) A Breeder's certificate will be issued for the foal conceived as a result of the breeding, only after all expenses have been paid in full, the foal is born, and the birth has been reported to the stallion owner. After the mare is confirmed in foal, the stallion owner must be notified with the mares name and breeding date or the mare will not be listed on the Stallion Breeding Report. If the mare ends up being in foal and the stallion owner was not notified, the mare owner will have to pay a late fee of \$50/mare.
- 6) Karina Evans/KEE Performance Horses LLC, nor any of her employees shall be liable for damages as a result of damage to the semen or as a result of the mare failing to settle. KEE Performance Horses LLC/Karina Evans' sole liability under this contract is in the event the stallion should die or become unfit for breeding purposes. In that case, this contract shall terminate and any money paid on the stallion fee, except the non-refundable booking fee and shipped semen fees, shall be refunded to the mare owner.
- 7) Once signed by both parties, this document will become a legally enforceable contract, binding upon both parties. The parties acknowledge that the agreement shall be entirely governed by, construed, and enforced under the laws of the State of Pennsylvania. In the event that there is any dispute, all disputes of every kind between the parties to this agreement shall only be submitted to arbitration and any award made by the arbitrators shall be considered final and binding. This contract is non-transferable and cannot be sold.
