### **NW Wisconsin Lakes Conference**

Sponsored by Wisconsin Lakes, Burnett Co Lakes & Rivers Association, Minong Flowage Association, Wild River Sports, Shell Lake Marine and Washburn County Lakes and Rivers Association, an excellent NW Wisconsin Lakes Conference took place, June 16, at Hayward High School. I recommend that you take every opportunity to attend these conferences. The price of admission includes a light breakfast and a boxed lunch plus coffee and soft drinks all day.

The umbrella theme of the conference was communication and activism among the lake

residents. This requires understanding barriers to individual behavior change and community concerns.

Dr. Randy Lehr (Professor of Environmental Science and Management at Northland College and Co-Director of the Burke Center for Freshwater Innovation) presented my favorite program on limnology (the study of inland lakes and streams.) He provided an overview on how lakes function and age, how humans affect lakes and how different activities help restore and protect lakes. He talked about the life cycle of lakes and reservoirs and how they change over time and how the changes affect the lake environment. His comments about aging lakes are consistent with the changes in the Flowage from, among other things, a stumpy, weedy bottom to a more muddy, weedy bottom and the need for such habitat enhancement as “fishsticks.”

Dr. Chris Ferguson of UW-Stout gave a practical presentation about property value increase on “cleaner” lakes. According to a recent study on the Chetek lake chain, there is a 50% increase in property value for a home on “clean” water versus on a “green” lake.

### **Dan Yankowiak, Natural Resources Property Supervisor**

Dan will be leaving his DNR assignment for the Flowage and become top dog at Copper

Falls State Park. We very much appreciated Dan’s competence and availability when he worked with us on the Flowage and we will miss him. Good luck, Dan!

### **Flowage Trolling**

The Chippewa Flowage will remain a lake allowing trolling by one-line per angler, three lines maximum per boat and this will also be the regulation for trolling on all lakes in Sawyer County (except the seven lakes which previously allowed each angler to troll with a maximum of three lines.) On May 24, the Natural Resources Board approved the amendment to NR 20.06 (1) to require that “trolling is restricted to the use of one-line per person with a maximum of three lines in a boat in Florence, Iron, Lincoln, Oneida, Sawyer, Sheboygan, Vilas and Waupaca Counties.” This trolling 3 lines per boat, 1 line per angler regulation DOES NOT take affect until the DNR says it becomes the regulation. This likely will become the regulation next spring but it is still 2 lines maximum trolling per boat and 1 line per angler presently.

Be considerate neighbors! Be careful out there! See you on the lake and at the picnic.



# CLEAN BOATS CLEAN WATERS UPDATE

The Clean Boats Clean Waters Program has been operating at the Flowage's four public ramps since May 5. By this time in the season many anglers contacted by our boat monitors have already talked to a monitor at least once. However, monitors still need to be on the ramps doing their jobs through the full season. Each ramp must have 200 hours of coverage through 2017, and each contact made during that time is reported and added to a state-wide data base.



CFAPOA has a crew of seven monitors working Friday, Saturday, Sunday and holiday shifts. Winter Dam has had the most coverage to date, with two monitors from Winter High School, Amelia Bodo and Lauren Stanley sharing duties there. Our other monitors come from Radisson (Matt Biller), Hayward, (Alex Clute and Katy Clark), or are member of the CFAPOA and live right here on the Flowage. Jerry Smith and Paulette Matthews are our members working their second year for the program, and providing mentoring for our new monitors.

Inspection data has been entered up to date through July 1. Here are some notable statistics about CBCW on the Flowage this 2017 season to date:

- CC North: 86 hours spent, 682 people contacted, and

318 boats inspected

- CC South: 74 hours spent, 578 people contacted, and 242 boats inspected
- Winter Dam: 146 hours spent, 590 people contacted, and 301 boats inspected
- Hay Creek: 125 hours spent, 1020 people contacted, and 435 boats inspected

That means that in the first half of our focus period, your Clean Boats Clean Waters program has:

1. Spent 431 hours educating boaters, inspecting boats and collecting data
2. Contacted 2,870 people about Aquatic Invasive Species and how to limit their spread
3. Inspected 1,296 boats

During the second half of our focus period we will be increasing our coverage at CC North and South and working on bringing our resort inspection and education programs on line. If you would like to help with volunteer or paid monitoring please contact Barb Salomon (715 462-4209) or Diane Hulke (715 972-0087), program co-coordinators for the CFAPOA. Remember that the CFAPOA, like all Wisconsin CBCW grantees, must contribute 25% of program value to match state grant funds. Your volunteer time or monetary contributions are most welcome. Thank you for your support of our monitors and their work.

## *Fishing Has No Boundaries*

On May 19 & 20, 2017, FHNB – Hayward hosted for the 30th year, a two day event on the shores of the Chippewa Flowage at the Lake Chippewa Campground. During the event, hundreds of volunteers gathered together to assist 116 anglers with various disabilities to enjoy this unique fishing experience. We caught at least 250 fish during the event, and even more when you think about all that were caught and released.

Fishing Has No Boundaries – Hayward offers evening meals, adaptive equipment, and much more to ensure everyone has a wonderful time during the FHNB event weekend.

The community involvement for the event is outstanding; all the watercraft used during the weekend is donated by community individuals and business owners. The 2018 event is scheduled for **May 18 & 19, 2018**.

# Trolling Regulation Decision

As stated in the Merriam-Webster Dictionary the definition for the word compromise is “a settlement of differences reached by mutual concessions”. The definition of concessions is “an act of conceding or yielding”. The previous definitions apply to the Spring Hearings held this past April when Rick Olson, a member of the Conservation Congress, made the effort to give Sawyer county the ability to decide its own fate concerning trolling. If more “yes” votes had been cast in Sawyer County, the regulation would have had read 3 lines per angler no maximum. The “no” votes were the majority; therefore, Sawyer county did decide to be included with the other 7 counties on the ballot for more restrictive trolling. The definitions also apply to the action taken by the Natural Resource Board in Madison and our board to best represent our property owners concerning the trolling regulation for 2018 and into the future. Please keep these definitions in mind when reading the following paragraphs. The Natural Resource Board in Madison reached a decision in May on the trolling regulation and is as follows; 1 line per angler and 3 lines maximum per boat on the Chippewa Flowage starting in 2018. This is a permanent ruling as decided by the Natural Resource Board in Madison.

The Compromise Trolling proposal of 1 line per angler and 2 lines maximum per boat was in its sunset year in 2017...

meaning that it would NOT continue, therefore, it would NOT continue unless there was a regulation to replace it. In 2014 when the Compromise Trolling Proposal was introduced, Sawyer County had been included with several other counties which also included the following six; Florence, Iron, Vilas, Oneida, Lincoln and Sheboygan, the 7th county, Waupaca was added to the Spring Hearing questionnaire in 2017. However, it appears there was an omission on the part of the Sawyer County DNR, fish biologist, Max Wolter, to not continue to include Sawyer County with the other seven counties on the 2017 Spring Hearings questionnaire. The counties had previously either not allowed trolling on all prospective lakes in their counties or named specific lakes where trolling was allowed, of which Sawyer County fell into the latter with seven lakes that allow trolling. Why suddenly in the stroke of a pen was Sawyer County no longer included with the other seven counties with a more restricted form of trolling? Quoted directly from an email Max sent out on January 4th, 2017, “I have decided to propose allowing anglers to fish their 3 allowed lines in whatever means they decide for all waters in Sawyer County”. To Max’s defense, the DNR in Madison was pushing for simplified rules which reduces his ability to manage each body of water individually, major restructuring of DNR departments, reductions

in funding, the elimination of DNR positions and new job descriptions. The timing of all these changes reduced personnel and left some DNR employees without a job or with new responsibilities. It is possible that he felt those pressures as he too has an interest in our area as he chose to reside here and raise his family. We as board members and citizens, look forward to our continued cooperative relationship with Max and all departments of the DNR both locally and in Madison.

Let’s now go back to our definitions in the first paragraph and apply them. CFAPOA board members take their property owners interests very seriously and try very hard to represent all views. The majority wanted no trolling of any kind, which still left the grey area with vertical line position for wardens during the sucker fishing season. This grey area, was in the beginning, the sole catalyst for the rule change pertaining to trolling. There were those that supported trolling but with the use of electric trolling motors only or some felt the use of gas motor trolling with a restricted number of lines was acceptable, but some wanted 3 lines per angler no maximum per boat. The Compromise Trolling proposal was just that, a compromise not only for the property owners who live on and pay taxes on their property, but for the tourists and serious fisherman or outdoors enthusiasts who enjoy the wildlife and wilderness aspects

of the Chippewa Flowage. But also, to those fisherman that choose motor trolling as their preferred method of fishing. To make concessions on each point of view brought us to the 1 line per angler and 3 lines maximum per boat, as the 2 lines maximum left out one person in the boat if there were three people fishing. We truly looked at all sides of the issue as our board consists of those with varying points of view... the perfect formula for the most productive boards...constructive debates lead to compromise.

There are social aspects that have equal importance

to the biological aspects of a lake. The Chippewa Flowage is consistently in the top ten most popular lakes in Wisconsin. The serenity its wilderness offers is one of its most striking features as it offers an escape from the fast pace of today's world. This fact in turn helps bring people into the Hayward area to shop, eat in our local restaurants, enjoy the festivities, helps to create jobs in our area, helps bring our youth back to our area for employment and keeps our local businesses open. This influx of tourist spending adds much needed sales tax monies to help defray the costs of local

government, therefore, reducing our tax liabilities as property owners. "Balance in all things in life is the key to a successful life".

# CFAPOA Loon Ranger Update – Second Quarter

The CFAPOA Loon Rangers once again volunteered for a second summer of participation in the Northland College - Sigurd Olson Environmental Institute Annual Lakes Monitoring Program (ALMP) managed by the Loon Watch Program. Chippewa Flowage Loon Rangers have been counting loons since April and May with many interesting observations. The collected information are compiled at the end of the year and submit to Loon Watch along with observations from 225 other Wisconsin lakes including 22 Sawyer County lakes.

In addition to the ALMP the CFAPOA Loon Rangers are completing the implementation and documentation of a \$1,500 Xcel Energy Foundation Environmental Grant that included: another year of ALMP

monitoring; the purchase of ESRI Geographic Information Software; and the Artificial Nesting Platform project. Required grant documentation was submit to the Xcel Energy Foundation on July 5, 2017 after Loon Rangers constructed, planted and placed seven ANP's throughout the Chippewa Flowage.

Although, we were not successful at convincing nesting loon pairs to use the platforms this year we did observe that 5 of the 7 ANP sites had loons nesting within a few feet of the floating nesting platforms. Unfortunately, due to two heavy rainfall events during loon nesting season all 5 of the nearby natural nest sites were washed out so our hope is that next spring the loons will see the merit in using the ANP's that are designed to float with rising water levels. Mike Meyers,

retired WDNR biologist and Iron County Conservation Department employee and loon expert, Zach Wilson, have advised CFAPOA Loon Rangers that when it comes to convincing loon pairs to nest on ANP's that patience is paramount along with placing the ANP's in known nesting site locations along with providing good vegetative cover on top of the floating ANP's. We look forward to next spring's loon nesting season and we hope the sturdy and reusable ANP's will spell success by providing some relief from rising water levels that are often associated with a reservoir like the Chippewa Flowage.

Some additional observations reported by Loon Rangers so far this year include;




This photo shows an ANP that David Staber monitors and maintains in Third Bay, Crane Lake.



As previously mentioned two significant rain events caused rapidly rising reservoir levels which resulted in flooding out nesting loons. The timing of the rainfalls actually impacted the same nesting pairs twice because after the first failure the loons nested a second time and were washed out again. Most appear to have given up after the second washout. Successful nesting appeared to have been associated with those loons that nested early in mid to late April and those that constructed nests on higher shorelines or floating bogs.

Volunteering to observe loons can be rewarding but it does come with disappointment occasionally. As we make our rounds to count loons we get use to recognizing individual loons who stay within their respective territories. Often times when a loon or chick is missing or a nesting loon is off the nest with no chicks we seek to find the answers to why. So far this year, rising water has taken a toll, egg predators such as raccoons have dined on loon eggs, and eagles have swooped in to grab chicks off the water from unsuspecting loon pairs. One such incident occurred when volunteer, Jim Dier, was taking photographs of a territorial pair and their single chick that was hatched from a nest near Pork Barrel Island. Suddenly out of the trees swooped an eagle who snatched the chick off the water. Nature has a way of reminding us that every day we are on the Chippewa Flowage is a great day. Take care and be safe on the water.



**Murky Waters.** The water after the storm on June 11th was rushing over Flowage Road and washed out sections of the road on each side of the bridge, as well as another section of the road near Post. The rushing water caused a lot of mud and debris to be evident for nearly a week.

# Chippewa Storage Reservoir Forecast

**Elevation as of June 14, 2017:** 1312.79 ft.

**Season of the Year<sup>1</sup>:** Summer 2017

**Typical Summer Target Low Elevation<sup>2</sup>:** 1310.5 ft. (2.5 ft. draw-down)

**2017 Projected Summer Low Elevation:** 1310.0 ft. (3.0 ft. draw-down)

## Comments

- The winter draw-down was limited to 4.56 ft., much less than the forecasted draw-down depth, due to minimal snowpack and an early arrival of spring. Significant rains over the last month have increased inflows into the reservoir and allowed for the reservoir elevation to remain at a high level while maintaining a strong discharge rate from the dam.
- The reservoir began to refill from winter draw-down in late-February due to early snowmelt and the reservoir was drawn down additionally in March to its winter maximum on March 28. The reservoir level was restored to the 1312.50 ft. elevation on May 4. Ice-out on the reservoir was much earlier than normal.
- Based on the current reservoir level, inflow rates, and the anticipated needs for water downstream, Xcel Energy intends to draw down the reservoir to elevation 1310.0 ft. (3 ft. draw-down) this summer.
- If above average precipitation occurs during the summer months and inflows into the reservoir remain high, the target elevation may be adjusted slightly upward. Should drought conditions occur this summer, reservoir levels may be reduced due to lack of significant inflow.
- Current projections are to maintain the reservoir elevation above 1312.0 ft. through the end of June. Discharge from the dam is currently 4,872 cfs. Should electrical generation needs increase in June due to hot weather or unanticipated power plant outages, additional water could be removed from the reservoir to increase generation at downstream hydro plants.
- The required minimum discharge (250 cfs) from the dam will be maintained at all times with increases in outflow at times during the summer season for downstream river flow augmentation.
- Xcel Energy will notify the public in the event that reservoir levels are anticipated to decrease below the 1310.0 ft. elevation.

# INVASIVE SPECIES COMMITTEE REPORT aka Purple Loosestrife Patrol


## *A brief history of the Adopt-A-Shoreline program*

The first Full lake purple Loosestrife survey was conducted on the Chippewa Flowage in 1998, again in 2008 as part of the Chippewa Flowage Aquatic Plant Management Plan. Erik Olson, working with the LCO Ojibwe Community College and our CFAPOA volunteers, (he referred to us as citizen scientists) completed the survey. Erik turned over responsibility for gathering yearly data and coordinating the control of purple loosestrife to yours truly.

The important part of this story is our Adopt-A-Shoreline volunteers. We have six new names to appreciate: Lynn, Mike, and Gage Muench (my neighbors across the bay) Linda Treland and Phyllis and Mike Gardner. Welcome and thank you!! This year's survey marks the third full-lake survey done in roughly 20 years – a great long-term database that will allow managers to answer many questions. This information will allow managers to determine the extent of the species, the effectiveness of different management strategies, and will influence future management decisions regarding this invasive species in the Chippewa Flowage.

A training class will be held on July 17 at the Town of Hunter Town Hall (9316 N County CC; junction of HWY CC and Twin Bay Rd.) at 4 PM. Call me if you have any questions (715 462-4818 home; 715 558-6408 mobile). We will go over purple loosestrife identification, survey protocol, and datasheets. This will also be an opportunity to ask questions. Also if you have any questionable weeds to identify, bring them along.
