Privacy Policy

Empowered Forward is committed to protecting the privacy of your personal information. Our Privacy Policy sets out the way we handle personal information, including the use and disclosure of personal information and rights to access your personal information. We collect only information that is directly relevant to effective service / course delivery.

Empowered Forward values and respects the privacy of the people we deal with. Empowered Forward is committed to protecting your privacy and complying with the Privacy Act 1988 (Cth) (Privacy Act) and other applicable privacy laws and regulations.

This Privacy Policy (Policy) describes how we collect, hold, use and disclose your personal information, and how we maintain the quality and security of your personal information.

What is Personal Information?

“Personal information” means any information or opinion, whether true or not, and whether recorded in a material form or not, about an identified individual or an individual who is reasonably identifiable. In general terms, this includes information or an opinion that personally identifies you either directly (e.g. your name) or indirectly.

What Personal Information Do We Collect?

The personal information we collect about you depends on the nature of your dealings with us or what you choose to share with us. The personal information we collect about you may includes, but is not limited to:

- Name
- Address
- Date of Birth
- Email Address
- Phone Number
- Credit Card Details
- Payment Details
- Medical Information
- Employment Information

The above list of personal information is non-exhaustive and serves as a list of examples only. Under certain circumstances, Empowered Forward may also need to collect sensitive information about you. This might include any information or opinion about your racial or ethnic origin, political opinions, political association, religious or philosophical beliefs, membership of a trade union or other professional body, sexual preferences, criminal record, or health information. If we collect your sensitive information, we will do so only with your consent, if it is necessary to prevent a serious and imminent threat to life or health, or as otherwise required or authorised by law, and we take appropriate measures to protect the security of this information.

You do not have to provide us with your personal information. Where possible, we will give you the option to interact with us anonymously or by using a pseudonym. However, if you choose to deal with us in this way or choose not to provide us with your personal information, we may not be able to provide you with our service / course or otherwise interact with you.

How do we Collect Your Personal Information?

We collect your personal information directly from you when you interact with us, or provide information to us via the below means (including, but not limited to):

- Phone
- In person
- Online
- Surveys or questionnaires
- At Empowered Forward hosted events
- Subscriptions to mailing lists
- Applying for a position with us as an employee, contractor or volunteer
- When registering or booking a service / course to be provided by Empowered Forward for your workplace, company or organisation
- Online bookings / ticketing systems

The above list is non-exhaustive and serve as examples only.

Collecting Personal Information from Third Parties

We may also collect your personal information from third parties or through publicly available sources, for example from event and ticket booking systems / providers, your workplace, company or organisation. We collect your personal information from these third parties that is required to provide service / course to you.

How Do We Use Your Personal Information?

We use personal information for many purposes in connection with our functions, activities, services / courses; including the following purposes:

- Delivery of a service / course, or offering to you or to your workplace, company or organisation
- To improve the quality of the service / courses that we offer
- Internal administrative purposes
- Marketing and research
- Contacting you about upcoming events, service / course

The above list is non-exhaustive and serve as examples only.

Disclosure of Personal Information to Third Parties

We may disclose your personal information to third parties in accordance with this policy in circumstances where you would reasonably expect us to disclose your information. For example, we may disclose your personal information to:

- event and ticket booking systems / providers
- payment systems / providers
- accounting software
- marketing providers
- professional service / courses advisors
- Mental Health First Aid Australia

The above list is non-exhaustive and serve as examples only. We may also provide your personal information to a third party if the disclosure is required or authorised by an Australian law or court / tribunal order. Disclosure of personal information by Empowered Forward to a third party may also occur if it is deemed by Empowered Forward that there is a threat or risk to the safety and wellbeing of yourself and/or others.

Transfer of Personal Information Overseas

Some of the third-party service / course providers we disclose personal information to may be based in or have servers located outside of Australia. Where we disclose your personal information to third parties overseas, we will take reasonable steps to ensure that data security and appropriate privacy practices are maintained. We will only disclose to overseas third parties if:

- we reasonably believe that the overseas recipient is subject to a law or binding scheme that is, overall, substantially similar to the APPs; and the law or binding scheme can be enforced
- the disclosure is required or authorised by an Australian law or court / tribunal order
- the disclosure is to a system that is used by Empowered Forward to enable to provision of services / courses
- the disclosure is required or authorised by an Australian law or court / tribunal order

Protecting Your Personal Information

Empowered Forward will take reasonable steps to ensure that the personal information that we hold about you is kept confidential and secure, including by:

- Having a robust physical security of our premises and databases / records
- Taking measures to restrict access to only personnel who need that personal information to effectively provide service / courses to you
- Having technological measures in place (for example: anti-virus software, fire walls)

Online Activity

The Empowered Forward website uses cookies. A cookie is a small file of letters and numbers the website puts on your device if you allow it. These cookies recognise when your device has visited our website(s) before, so we can distinguish you from other users of the website. This improves your experience and the Empowered Forward website(s). We do not use cookies to identify you, just to improve your experience on our website(s). If you do not wish to use the cookies, you can amend the settings on your internet browser so it will not automatically download cookies. However, if you remove or block cookies on your computer, please be aware that your browsing experience and our website's functionality may be affected.

Website Analytics

Our website uses analytics service / courses to help us better understand visitor traffic, so we can improve our service / courses. Although this data is mostly anonymous, it is possible that under certain circumstances, we may connect it to you.

Direct Marketing

We may send you direct marketing communications and information about our service / courses, opportunities, or events that we consider may be of interest to you if you have requested or consented to receive such communications. These communications may be sent in various forms, including mail, SMS, fax and email, in accordance with applicable marketing laws, such as the Australian Spam Act 2003 (Cth). You consent to us sending you those direct marketing communications by any of those methods. If you indicate a preference for a method of communication, we will endeavour to use that method whenever practical to do so. You may opt-out of receiving marketing communications from us at any time by contacting us using the details set out in the “How to Contact Us” section below.

In addition, we may also use your personal information or disclose your personal information to third parties for the purposes of advertising, including online behavioural advertising, website personalisation, and to provide targeted or retargeted advertising content to you (including through third party websites).

Retention of Personal Information

We will not keep your personal information for longer than we need to. In most cases, this means that we will only retain your personal information for the duration of your relationship with us unless we are required to retain your personal information to comply with applicable laws, for example record-keeping obligations.

How to Access and Correct your Personal Information

Empowered Forward will endeavour to keep your personal information accurate, complete and up to date. If you wish to make a request to access and / or correct the personal information we hold about you, you should make a request by contacting us and we will usually respond within 10 days.
