-Parties need to be booked two weeks in advance through the City of Altoona.

-Payment in full and the completed Application is due at Altoona City Hall – Administration – 1301 12<sup>th</sup> St. Suite 100, Altoona, PA 16601 - when the reservation is made. Checks made payable to the City of Altoona or Cash is acceptable.

-Vouchers (10) will be provided to the Applicant for the day of the Party in advance.

-Set up can take place ½ hour in advance of the Party and clean up ½ hour after the Party – no later than 7:00 p.m. The Pavilion must be cleaned and the Party must be off of Prospect Pool property by pool closing time – which is 7:00 p.m.

-The Applicant must sign the “Hold Harmless Agreement” (attached).

-No outside entertainment or vendors are permitted.

-The Applicant can bring their own food, snacks, cake, etc. for the Party.

-The applicant must clean up the trash in the Pavilion area, remove all decorations and use the trash cans provided before leaving. Otherwise, additional fees will be charged.
