#### I. Introduction

#### A. Purpose

The purpose of this Program Manual is to ensure the integrity of the OPT Certified Grass-Fed Organic Livestock Program by providing guidance for consistent administration and Application of the Program through on-site audits and associated Certification processes.

#### B. Terms

The Organic Plus Trust Inc. ("OPT") Certified Grass-Fed Organic Livestock and Handling Program© (hereinafter called "the OPT Grass-Fed Program", "the Program", or "this Program") corresponds to, and supplements, the Certification requirements of the National Organic Program ("NOP") for Livestock and Handling.<sup>2</sup> As used throughout this Program Manual, "Organic" means certified Organic under the NOP. To meet the requirements of this Program, each Livestock Production and Handling Operation ("Operation") must be certified Organic by an NOP-Accredited Certifying Agent ("ACA"). Once ACAs are Accredited by OPT, they are referred to as "OPT Certifiers." Only OPT Certifiers can Certify that Operations have met the requirements of the OPT Grass-Fed Program.

#### C. Definitions

The governing definitions for this Program are those appearing at 7 C.F.R. §205.2 and those in Appendix A of the OPT Grass-fed Program standards. When the word is denoted with an initial capital letter, it is defined in Appendix A. Unless specified otherwise, these definitions apply to each Application of the OPT Grass-Fed Program Standards and governance requirements imposed on or by OPT Certifiers.

#### II. Governance Guidelines for Certification Services and Certificates of Compliance

#### A. Eligibility for Certification

Operations achieving Certification by OPT Certifiers under the OPT Grass-Fed Program shall be described as "OPT Grass-Fed Certified" (or "OPT GF-Certified") or having received "OPT Grass-Fed Certification" throughout this Program Manual.

#### 1. Operations

This OPT Grass-Fed Program is open to any Livestock Production or Livestock product Handling Operation, that is presently certified Organic by an ACA under the U.S. Department of Agriculture's National Organic Program ("NOP"), or eligible to concurrently be Certified under the NOP and the OPT Grass-Fed Program.

2. Livestock

Eligible Livestock are solely those animals under the ownership of the applicant Operation at the time of the initiation of the OPT Grass-Fed Program per Section II(B)(1)(b) of the Standards.

3. Dairy and Meat Products

Eligible dairy or meat Livestock products are solely those which derive from animals of an OPT Grass-Fed Certified Operation and which are Handled in accordance with Section XII of the OPT Grass-Fed Program Manual and section X of the Standards.

# **B.** Governance of the Transition Period and the Prohibition on Commingled Livestock

1. Dairy Animals

The OPT Certifier shall ensure each applicant Organic Dairy Livestock Production Operation is provided with Notice:

- a. Of the Transition requirements referred to at III(3) of The OPT Grass-Fed Dairy Standard prior to initiation of the Transition period, and the OPT Certifier shall ensure that its records demonstrate the Operation successfully completed the required Transition period; and
- b. That the OPT Certified Operation may not operate a non-OPT certified dairy Livestock Production site in conjunction with, or at the same Production site, as an OPT GF-Certified Operation; and
- c. That non-OPT Certified and OPT Certified dairy Livestock or product shall not be commingled and must be physically separated and identified except that Organic Livestock may be placed at an OPT Grass-Fed-Certified Operation under the terms set forth in Section III(3) of the OPT Grass-Fed Standard; and
- d. That a Handler Processing non-OPT GF products in conjunction with, or at the same Production Site as OPT Certified products be identified as a Split Operation

and there must be a written Segregation policy describing how OPT GF-Certified products are segregated from non-OPT GF Certified products.

2. Meat Animals

The OPT Certifier shall ensure each applicant Organic Meat Production Operation is provided with Notice that:

- a. The OPT Grass-Fed Organic Livestock Standard does not permit Transition of meat animals.
- b. Meat animals must be born at or purchased from an OPT Certified Grass-Fed Operation.
- c. Split Operations must always maintain physical Segregation and/or identification of the two groups of animals and their products. The Operation must maintain a written Segregation policy describing how OPT GF-certified Livestock are segregated from non-OPT Livestock and/or products.
- 3. Split Operations

Livestock raised in any OPT Grass-Fed Certified Operation must be Segregated from non-OPT Livestock at all times.

a. Parallel and Split Operations

OPT Dairy Animals of the same species are not eligible as Parallel Production Operations. Meat operations may be Parallel and/or Split Operations. OPT Grass-Fed Certified Livestock and non-OPT Certified Livestock must be separate and distinctly managed.

It is incumbent upon the OPT Certifier to determine if and how the Operation has excluded the animals or products under non-OPT Certified Production at the Operation that are not compliant with the OPT Grass-Fed Program.

#### C. Certification Services Governance

Certification Services are delivered under this Program (1) in general accordance with the process set forth in NOP Guidance No. 2601 (Mar. 20, 2024) styled "The Organic Certification Process," and specifically (2) the Certification Services Agreement and this Program Manual.<sup>3</sup>

### D. Application for Certification Services

An Application for Certification Services under The OPT Grass-Fed Program may be submitted to any OPT Certifier in a form and upon a procedure established in the applicable OPT Certification Service Materials or the OPT Ancillary Materials. An Application shall always bear a date and the signature of the Operation's Responsible Person attesting to the accuracy of the information provided.

### E. Certificates of Compliance Issued by OPT Certifiers

1. General

Each Certificate of Compliance with the OPT Grass-Fed Program ("OPT Grass-Fed Certificate") awarded by an OPT Certifier to an Operation shall be issued using the OPT GF Certificate generator of the OPT Web Portal. The OPT GF Certificate may be modified to contain marks of the OPT Certifier if such modification is accepted by OPT prior to use.

2. OPT Certification Term<sup>4</sup>

The OPT Grass-Fed Certification term shall be continuous, may run concurrent with the Operation's Organic Certification period and include an expiration date no later than fifteen months from the date of issuance. Certification issue date shall resume from the date of expiration of the most recently expiring certificate or start on the date of the Certification decision for initial applicants.

a. Initial Certification

The first time an Operation is Certified under The OPT Grass-Fed Program, the Operation should apply for and receive an OPT Grass-Fed Inspection concurrent with the Operation's Organic Inspection and Certification.

If the initial Application for Certification is submitted for Inspection on a timeline *not concurrent* with the Operation's Organic Inspection, the Certifier shall:

i. Perform an out-of-sync On-Site Inspection and issue a certificate starting at the date of Certification decision; or

ii. Request that OPT conduct a desk audit of the Operation and provide to OPT all necessary Certification materials in order to conduct the audit. OPT will issue a certificate starting at the date of Certification decision. A desk audit may be requested by the Certifier or the applicant Operation.

In either case, the Operation must apply to the Certifier for renewal within the following calendar year in order to harmonize the Certification Terms of the Organic and OPT Grass-Fed Programs.

b. Renewal of Certification

Renewal of an OPT GF-Certified Operation's Certification may be granted upon timely completion of the requirements set forth in the applicable OPT Grass-Fed Certification Service Materials, provided that renewal of Certification shall in all cases occur prior to the original date of expiration or by the date any applicable period of extension has elapsed.

A renewal Certificate of Compliance may be issued for the new Certification term upon the OPT Certifier's review and acceptance of an Operation's signed renewal Application materials.

A renewal Certificate of Compliance shall bear the date of renewal issuance and a new expiration date following the rules of Continuous Certification.

An On-Site Inspection must occur at least once per calendar year<sup>5</sup>. If the Operation does not successfully achieve or renew Certification, the OPT Grass-Fed Certificate may be suspended.

An OPT Certifier must immediately report all Certification decisions, including denials, suspensions, surrenders and revocations, to OPT via the OPT Portal. A certified Operation's surrender acknowledgement of their Organic certification may provide sufficient documentation as the surrender acknowledgement of their grass-fed certification.

There is no restriction on how soon a renewal inspection may occur. A Certifier may choose to perform a renewal Inspection early in the Certification period in order to harmonize the OPT GF Certification Term with the Operation's Organic Certification Term.

If a certifier loses its Accreditation to the OPT Grass-Fed Organic Livestock Program OPT shall be responsible for ensuring that Inspection and Certification occurs for affected Certified Operations.

3. Extensions to Expiration Dates

In extenuating circumstances, OPT Certifiers may extend the period in which an OPT Grass-Fed Certificate of Compliance is valid:

- a. The date of expiration appearing on an OPT GF Certificate of Compliance may be reset for up to sixty days upon a determination by the OPT Certifier that the OPT GF-Certified Operation has demonstrated that Good Cause exists, or the OPT Certifier on its own determination finds that Good Cause exists, for resetting the date of expiration; and
- b. The new date of expiration entered under 4(a) may be reset for an additional thirty days, upon a determination by the OPT Certifier that Exceptional Circumstances exist, provided that in either case, the OPT Certifier timely alerts OPT of the reset date of expiration date; and
- c. In no event shall an OPT GF Certificate of Compliance be valid for more than eighteen consecutive months from the date of first issuance; and
- d. An expired or surrendered OPT GF Certificate of Compliance is invalid, and all rights thereunder are extinguished.

#### F. No Appeal of Expired or Voluntarily Surrendered Certificates

A denial of a request for resetting the expiration date by extension may be appealed under Policy Manual Section XVI. However, an OPT Grass-Fed Certificate of Compliance rendered invalid by expiration or voluntary Certificate surrender is final and may not be appealed. The sole remedy for an expired or surrendered OPT GF Certification is to reapply for OPT GF Certification.

#### G. Consequences of Expiration

If an OPT GF Certificate of Compliance is allowed to expire it is, on the next business day, invalid. Thereafter, products of that OPT GF-Certified Operation, including Livestock of a Production Operation or processed products of a Handler, may not be transacted bearing the Licensed Trademarks or other marketing designations suggesting Certification to this OPT Grass-Fed Program or compliance therewith *except* that:

- 1. products that have entered the stream of commerce prior to the next business day after expiration shall not automatically be considered invalidly labeled and absent circumstances posing irreparable harm to the OPT Grass-Fed Program or human, animal, or environmental well-being, no action by the OPT Certifier is required; and
- 2. OPT may, in its sole discretion, make an irreparable harm determination on its own recognizance, or upon request from a materially affected party, including an OPT Certifier.

#### III. Governance of the Source and Identity of Livestock Requirements

#### A. Use of the Farm Herd List

The principle administrative tool for ensuring compliance with the OPT Grass-Fed Program's source and identity of Livestock requirements is accurate compilation and use of the Farm Herd List. OPT Certifiers shall ensure that each OPT GF-Certified Operation adds animals, following initial Certification, to its Farm Herd List solely with those *born at or purchased* from OPT GF-Certified Operations unless the exception appearing at Section III(B) of the OPT Grass-Fed Program Manual is applicable. If the exception is applicable, the subject animal may be the offspring of an animal that is Organic or the offspring of a dairy animal that at the time of birth is at an OPT GF-Certified Operation that is in Transition under the OPT Grass-Fed Program.

#### B. Governance of the "Commercially Unavailable" Exception

The "Commercially Unavailable" exception to the requirement that all animals must be born on or obtained from an OPT GF-Certified Organic Operation applies to dairy animals. An OPT Certifier should consider all the facts and circumstances in deciding whether animals with the Operation's Animal Attributes are available commercially, meaning reasonably obtainable in an amount of time and of the quality and quantity needed to fulfill the needs of the Livestock Production Operation. The OPT Certifier must confirm that the OPT GF-Certified Operation has reasonably avoided reliance upon this exception.

Reasonableness shall be assessed by initially considering the applicable factors set forth in NOP Guidance 5029 (March 4, 2013) ("Seeds, Annual Seedlings, Planting Stock in Organic Crop Production") except, OPT GF-Certified Operations may properly consider the cost of an animal and its transportation cost separately when choosing the source of the replacement animals. Welfare implications of transportation of an animal is also a relevant factor. Such concerns must be reported to, and documented by, the OPT Certifier. Other factors may be advanced by an OPT GF-Certified Operation and considered by an OPT Certifier and in the event such factor is relied upon by the OPT Certifier in determining the applicability of the exception, the OPT Certifier shall document its reliance and explain its reasoning. Documented reliance on such additional factor(s) will be evaluated by OPT on a case-by-case basis.

#### C. Appealability of Commercially Unavailable Determinations

OPT Certifier determinations that the Commercially Unavailable exception is inapplicable are appealable by the OPT GF-Certified Operation.

#### **IV. Grazing Requirements**

With regard to determining compliance with the grazing requirements for weaned animals older than six months, OPT Certifiers should use the same principles and practices as those set forth in the NOP Guidance No. 5017 (Series 5017-1 to 5017-7), "Dry Matter Intake Information for Access to Pasture"  $(2011)^6$ .

If the NOP templates for determining DMI are used by the OPT Certifier, the templates should be adapted to reflect the specific grazing requirements of Section IV of the OPT Grass-Fed Program Standards. Each form or template developed by an OPT Certifier shall be submitted and accepted by OPT in accordance with the Certification Services Agreement.

#### V. Livestock Diet: Background and Allowed, Restricted and Prohibited Feedstuffs

#### A. Background

1. Application of Organic Principles under the OPT Grass-Fed Program

Section V of the OPT Grass-Fed Standards categorizes Feedstuffs as *allowed*, *restricted*, and *prohibited*. These terms are to be applied in a manner generally consistent with the NOP's Application of the same terms. OPT Certifiers must verify that all Forage, Feed, and Feed Supplements are permissible in identity, content, and quantity under The OPT Grass-Fed Program, and shall use the same oversight mechanisms that are generally used to discharge the same duties under the NOP.

2. Hybrid male sterile crops, such as Japanese millet, Sterile Corn, Sorghum/Sudangrass and other C4 crops that are not intended to produce Grain, may be grazed and harvested without restriction, provided that the crop purity is maintained. Producers should make an effort to ensure cross pollination does not impact the purity of the sterile crop and, if purity cannot be maintained then time of harvest shall adhere to Standard section V(A)(2)and(3).

- 3. OPT Certifiers may rely upon:
  - NOP Instruction No. 2615, "Organic System Plans, Organic System Plan Updates, and Notification of Changes" (Mar. 20, 2024)
  - NOP Guidance No. 5025, "Commingling and Contamination Prevention in Organic Production and Handling" (July 22, 2011)

§ 205.103, § 205.201, § 205.406(a) and OILC Course NOP-140 Recordkeeping.

a. Restatement of Organic Principles

The centrality of the use of proper Feedstuffs to the OPT Grass-Fed Program bears some restating of NOP's Organic requirements. OPT GF-Certified Organic Producers must provide Livestock Feed pursuant to 7 C.F.R. §205.237, which states that agricultural ingredients included in the ingredients list for Livestock Feed products must be certified Organic. Pasture and range used for Feed and Forage must be also Organic. All Forages, Feed, and Feed Supplements must be listed in the Organic System Plan ("OSP"), as required at 7 C.F.R. §205.201(a)(2). Certifying agents must verify that all Forages, Feed ingredients, formulated Feed products, bulk Feed products, Feed Supplements, and Feed Additives fed to Organic Livestock comply with the USDA Organic regulations (7 C.F.R. §205.402(a)(1); §205.237). These NOP Practice Standards are binding under the OPT Grass-Fed Program.

b. Specific Provisions of the NOP Dairy Whole-Herd Transition Allowance.

Under the NOP, a unified group of dairy Livestock Transitioning to Organic all at the same time on a farm is exempt from the 100% Organic Feed requirement in that these Transitioning cows can be fed crops and Forage from land in its third and final year of Transition to Organic if that land is included in the farm's ACA-approved OSP. The crops and Forage fed must have been grown only on land free of prohibited substances for at least the 24 months prior to harvest/use of the Feed. **Under the OPT Grass-Fed Program, such crops and Forage may not contain Grain.** In other words, these "third-year Transitional" non-Grain crops and Forage may be consumed by dairy animals in an OPT Grass-Fed Certified dairy Operation up until the last 90 days of this third year of Transition to Organic, at which point only Organic crops and Forage that meets the OPT Grass-Fed Program requirements of this Section can be fed to cattle.

#### c. Use of a Written Supplement to the OSP and Detailed Records Review

The OSP is not only a collection of NOP Practice Standards but is also a predictive tool. Records need to be assessed against seasonal patterns and OPT Certifiers shall ensure that each OPT GF-Certified Operation's OSP specifically details sources, composition and amounts of allowed and restricted Feedstuffs in compliance with the OPT Grass-Fed Program. If the OPT Certifier does not require the OPT GF-Certified Operation to submit and rely upon a written plan, the OPT Certifier must provide a review of the grazing practices and Feed purchase and use records that is sufficient to substantiate a finding that ongoing and future compliance is reasonably certain.

#### **B.** Grain Prohibition

This Program establishes additional requirements for Organic<sup>7</sup> Dairy Livestock Production under which each Organic Operation enlarges the duration of the animal's grazing time to ensure its Feed comes solely from foraging, stored Forages and minor amounts of additional plant-based materials and nutrient vitamins and minerals. Unlike the federal NOP Practice Standards, the OPT Grass-Fed Dairy and Meat Standards *exclude* Grain and Grain-derived Feed and Feed products from the diets of Livestock.

#### C. Allowed Feedstuffs

Allowed Feedstuffs are listed in Section V(A) of the OPT Grass-Fed Standard.. Boot Stage and Late Boot Stage as defined in Appendix A are also described below. Targeted Grass stage development in Late Boot Stage<sup>8</sup>

It is recommended to target the latest stage of seedhead development to support grass-fed production. The goal is to limit the amount of starch level present in the seedhead and to maximize forage quality. During the emergence of the seedhead at the late-boot stage, the plant gradually produces a fibrous stem to extend the seedhead. During this process, the protein and energy level of the forage lessens, while the fiber content rises.


Cutting at the late-boot stage produces high-quality hay. Fiber digestibility is still significantly high, and all other nutritional parameters, including sugars, fatty acids and protein level.

The boot stage can be identified by running your fingers up and down the stalks of the plant and feeling for the bulge. You can even open the leaf sheaths to see the forming seed head within. During the boot stage, the tips of awns (stiff, bristle-like structures, often growing from the tip of a seed) begin to emerge from the sheath (Figures A and B).

As the seed head forms within the stalk, it can resemble a leg within a boot. During late boot stage, much of the seed head is visible outside of the sheath, but the seed stalks have not yet begun to flower (Figure C).



#### D. Allowed and Unrestricted Supplemental Feedstuffs

Supplemental Feedstuffs that are allowed by The OPT Grass-Fed Program without restriction are listed in Table 1 of the Standards. Certifiers shall follow NOP 5030 Guidance Evaluating Allowed Ingredients and Sources of Vitamins and Minerals For Organic Livestock Feed.

#### E. Allowed but Restricted Feedstuffs

1. Allowed but Restricted Meaning

The Supplemental Feedstuffs that may be fed in limited amounts to Livestock Certified under The OPT Grass-Fed Program are cited in Table 2 of this section. The OPT Certifier's duty is to ensure the restrictions are observed by records and direct observation of the OPT GF-Certified Operation.

2. Assessing Compliance with the Restricted Feedstuffs Section of The OPT Grass-Fed Program

*Restricted* feedstuffs are different than *prohibited* feedstuffs because it is the feeding practice that determines whether the use of the feedstuff is permissible. This means either that the restriction is properly observed by the operator or the restriction's relaxation was properly determined. This is not as simple as finding *prohibited* feedstuffs during an inspection.

Under the OPT Grass-Fed Program, Allowed but Restricted Feedstuffs may be consumed at any time of the year provided the mandatory preconditions to deploying restricted Feedstuffs is satisfied. OPT Certifiers shall ensure that written plans, detailed records, and direct observations during inspection substantiate a finding that ongoing and that future compliance with the restrictions is reasonably certain. In particular, OPT Certifiers should make specific findings that:

- a. Each use of restricted Grain-free Feedstuffs, even if routine, is necessary to *support Livestock nutritional stability and rumen welfare*; and
- b. The amount of Allowed but Restricted Energy Feedstuffs was strictly limited to supplemental amounts for a combined maximum of 5 lb. per day for cattle<sup>9</sup>; and
- c. The binding restrictions on the allowed daily amount in Table 2 of this section are demonstrably observed.
- 3. The phrase "to support nutritional stability and rumen welfare" used in this section provides the OPT Certifier with discretion to address the aggregate impact of the daily use of restricted Feedstuffs. The purpose is to determine whether the restricted Feedstuff frequency harms the Livestock or circumvents the purpose of the restrictions. Sometimes it is difficult to assess whether a restricted practice masks substandard management practices regarding OPT Grass-Fed Program requirements, e.g., best Pasture management practices. Overuse of restricted Feedstuffs could be a material predictor of such deficiencies. However, at present OPT does not impose any aggregate use limitation. Thus, it is entirely permissible to routinely use the restricted Feedstuffs but not overuse them. The touchstone of the OPT Grass-Fed Certification assessment is whether the OPT Certifier believes the authorization is being abused.

#### F. Assessing Compliance with the OPT Restrictions on Use of Supplements

### 1. Adapting the NOP Approach

The OPT Grass-Fed Program treats Feed Supplements, Feed additives, and vitamins or mineral products in the same manner as the NOP *except*, under this program such products are intended to be as free of Grain as is possible. NOP Guidance No. 5030, "Evaluating Allowed Ingredients and Sources of Vitamins and Minerals for Organic Livestock Feed" (March 4, 2013) ("Supplement Guidance") sets forth the basic legal framework for assessing Livestock Feed Supplements and vitamin and mineral products.

2. Identifying the Contents of Supplements Prior to Inspection

To facilitate the Application of this framework, OPT Certifiers should require all Feed Supplements, additives, vitamin, or mineral product Supplements<sup>10</sup> to be listed in the OPT GF-Certified Operation's Application or a supplemental OSP before the On-Site Inspection is performed.

3. Use of Grain Carriers in Livestock Supplement and Vitamin Products

Organic and non-Organic Livestock Supplements, vitamin, and mineral mixes ("Feed Supplement products"), whether available commercially over the counter or customblended, that contain Grain or Grain-derived Carriers are allowed provided they are fed according to labeled feeding instructions.

The OPT Certifier shall confirm that the Operation's use of the Supplement product containing Grain or Grain-derived Carriers is not intended to circumvent the prohibition on the use of Grain in the Certified animal's diet.

### G. Restrictions on Implementing the Temporary Health and Welfare Exception

In accordance with the OPT focus on animal well-being, an OPT GF-Certified Operation, upon a documented finding of compromised animal health or welfare, may temporarily disregard the daily restrictions on the amount of non-Grain Supplemental Feedstuffs.

1. OPT Certifiers shall implement this subsection in accordance with the practices described in NOP Instruction No. 2615, "Organic System Plans, Organic System Plan Updates, and Notification of Changes" (Mar. 20, 2024), § 205.103, § 205.201, § 205.406(a) and OILC Course NOP-140 Recordkeeping.. Adapting the principles of these documents to the OPT Grass-Fed Program should ensure that the

authorization to disregard the daily restrictions on restricted Feed sources is not abused or being used to mask a more systemic failure of management practices.

# H. Implementing the OPT Grass-Fed Program Feed Prohibitions, Assessing the Need for Animal or Animal Product Disqualifications

1. Consistent with NOP

Prohibited Feedstuffs or feeding practices shall be assessed in the same manner and in accordance with the oversight mechanisms currently used by ACAs in assessing whether disallowed Feedstuffs are used on Organic Livestock Operations. The principal method of oversight is the annual On-Site Inspection. However, OPT Certifiers should stress to responsible parties at OPT GF-Certified Operations that they have a duty to disclose the occurrence of prohibited Feedstuff consumption.

2. Intentional Violations

Intentional feeding of prohibited Feedstuffs or Feed Supplements, or intentional failure to comply with grazing requirements, shall result in disqualification of each affected animal. Such intentional actions shall result in suspension.

3. Inadvertent Violations

Inadvertent feeding of prohibited Feedstuffs or Feed Supplements, or inadvertent failure to comply with grazing requirements through operator oversight or negligence, may result in disqualification of each affected animal. Such negligent or inadvertent actions may result in decertification proceedings.

4. Proof and Specific Findings

OPT Certifiers are directed to determine the extent of the departure from the Program's requirements and make a specific finding thereon, specifically including a determination of intentional or negligent Noncompliance. Proof sufficient to demonstrate grounds for disqualification or decertification may come from records of the OPT GF-Certified Operation, the absence of required records, or other clear and convincing evidence in possession of the OPT Certifier. The finding, and the grounds upon which it is based, must be entered into the Certification record of the OPT GF-Certified Operation.

5. Mandatory and Permissive Disqualification of Animals and Animal Products

If the OPT Certifier finds *intentional* Noncompliance, disqualification of animals and animal products is mandatory and de-Certification proceedings shall be initiated. If the OPT Certifier finds *unintentional* Noncompliance, disqualification of animals and

animal products is mandatory and de-Certification proceedings are discretionary and may be initiated. If the OPT Certifier finds the unintentional Noncompliance to be no more than *De Minimis*, neither disqualification of animals or animal products is mandatory and de-Certification proceedings are not required. The impact on the OPT GF-Certified Operation's Certification shall be determined separately by the OPT Certifier.

6. An OPT Certifier should not consult with OPT when considering whether to disqualify animals or animal products or decertify an OPT GF-Certified Operation to ensure any appeal of the decision to OPT is untainted and free of pre-decisional bias.

#### I. Variances from Program Standards

- 1. OPT Certifiers may recognize Variances from Organic requirements that are issued by the NOP or other federally authorized entities and that apply to an OPT GF-Certified Operation. Such Variances may relieve parties from duties or responsibilities arising under the OPT Grass-Fed Program if the Variance in question addresses OPT-related duties and such duties are directly impacted by the issued Variance.
- 2. Only the OPT may determine and issue a Variance for the OPT Grass-Fed Program that does not directly and unavoidably arise from NOP action, or a subsidiary governmental entities' action that NOP accepts or recognizes.
- 3. Types of Variance Petitions
  - a. Variances for Individual OPT GF-Certified Operations

OPT-issued Variances may be granted by OPT upon submission of a Petition from an affected person in a form and upon a procedure that is set forth in Section XVII of this Program Manual.

b. OPT Certifier Variance Requests

OPT Certifiers may submit Petitions seeking a Variance that would authorize it to apply the Variance to any Operation it certifies. In this circumstance the OPT Certifier shall demonstrate that the conditions underpinning the Variance request are sufficiently applicable to all the Operations to which it intends to apply the Variance and that such an authorization will serve The OPT Grass-Fed Program's best interests by conserving administrative resources.

The key determination that an OPT Certifier must make prior to applying the general Variance to a specific Operation will be confirmation to the OPT that the mandatory preconditions for the Application of the Variance to a specific Operation are met.

The OPT Certifier must submit a list of the Operations to which it believes the general Variance would apply and the required confirmation that the requisite facts were found by the OPT Certifier. The OPT Certifier shall update an existing list each time a new Operation is added.

#### VI. Exclusion of Milk or Meat from Disqualified Livestock

To ensure Livestock products from disqualified animals (or the animals themselves) do not enter the stream of commerce bearing the Licensed Trademarks or other indicia of OPT compliance, the following listed actions should be taken. OPT Certifiers may decide measures in addition to, or in alignment with, the following actions to ensure the integrity of the meat and milk supply.

# A. Disqualified Dairy Animals Must be Removed from the OPT GF-Certified Operation

The OPT GF-Certified Operation is required to notify its OPT Certifier of any occurrence of ingestion of non-compliant Feed. The OPT Certifier must determine if the animal(s) ingesting the non-compliant Feed is disqualified, and if the answer is yes, then the OPT Certifier must provide a written Notice of Disqualification identifying the specific animal(s) to the Certified Operation. That Certified Operation has up to 21 days to remove a dairy animal from the Operation following receipt of the Notice of Disqualification, and this animal must be segregated during this term.

#### B. The Milk of Disqualified Dairy Animals Must be Segregated

During the 21-day period following disqualification and before removal of the animal, any milk obtained from the disqualified animal shall be segregated from milk from compliant animals per section V(E)(2) of the standards.

#### C. Disqualified Meat Animals May Remain on Site if a Split-Operation Exists

A disqualified meat animal under the OPT Grass-Fed Program need not be removed from the site, provided that:

1. The Producer operates a Split Operation, and the animal was removed from the OPT Grass-Fed Certified Operation; and

2. The OPT Certifier determines the records clearly account for this outcome and demonstrate the animal did not thereafter enter the stream of commerce bearing a Licensed Trademark or other marketing indications of compliance with the OPT Grass-Fed Program.

#### VII. Livestock Welfare, Healthcare and Living Conditions Requirements

#### A. Welfare Practices

- 1. The OPT Grass-Fed Certification Program requires livestock welfare practices that exceed those outlined in the NOP regulations. Third party animal welfare certification is encouraged, however the OPT Program understands that third party certification may not be accessible to all operations becoming certified to this standard.
- 2. The option noted in section VII(A)(3) is applicable when an Aggregator handles the marketing of the certified products and conducts an animal care evaluation for each operation they contract with. A list of approved Aggregators will be published via email or in the OPT portal for certifier reference. Certified operations must submit an annual affirmation noted in Appendix B of the Standards verifying a continued contract with the Aggregator.
- 3. The option referenced in section VII(A)(4) requires the certified operation include a licenses Veterinarian to verify the approved animal care protocol is practices. OPT recommends that farmers seeking this option use the Farmers Assuring Responsible Management ("FARM") Animal Care Program as a resource to develop their protocols. Animal care protocols must be submitted by the Certifier to the OPT Program for approval. The affidavit noted in Appendix C of the Standards must be annually verified by the Certifier.
- 4. The option referenced in section VII(A)(5) refers to Operations exempt from the compliance requirements. We are using USDA Economic Research Service (ERS) definition a Small Farm as a data driven benchmark to categorize a Small Farm. The goal is to offer an exemption to small operations who have a strong, direct customer base that offers a level of accountability to animal welfare concerns. Operations marketing their OPT certified products to a Direct To Consumer Market must provide verification per Appendix D of the Standards.

If an OPT GF-Certified Operation is considered out of compliance with the welfare requirements it shall receive a Notice of Noncompliance from its OPT Certifier.

#### VIII. Livestock Healthcare

#### A. No Specific Additional Practices

At present, there are no OPT-specific healthcare practices (as that term is construed by the NOP) that differ from those imposed on Livestock Operations under the NOP Organic standards except, Feedstuff identity, quantity and availability requirements may vary depending on assessments of rumen health and nutritional stability at OPT Grass-Fed Certified Operations.

#### B. No Prohibition on OPT Action in the Event of NOP Inaction

The absence of a specific difference between the NOP and the OPT Grass-Fed Program does not in all cases mean the outcome of review of a healthcare practice will be identical. Nor does it mean that NOP acceptance of a practice or OPT Certifier decision necessarily and in all cases means OPT acceptance of the same practice or decision. As noted in the Federalism Principles Section in this Program Manual, the OPT may act in the absence of action by the NOP on matters and questions arising under apparently identical standards. *See:* Appendix E, Section II.

#### C. No Denial of Healthcare

The requirement that Livestock never be denied necessary healthcare for the purpose of maintaining an animal's programmatic status under the NOP, is identical under the OPT Grass-Fed Program: under the OPT Grass-Fed Program healthcare may not be denied preserving OPT status or eligibility.

1. The same assessment and oversight mechanisms used by the OPT Certifier and accepted by the NOP to discharge the duty duties under the NOP are sufficient here.

#### IX. Livestock Living Conditions

#### A. No Specific Additional Practices

At present, other than increased grazing requirements, there are no OPT-specific Livestock living condition requirements (as that term is construed by the NOP) that specifically differ from those required by the NOP Organic Livestock standards, except that bedding provided to OPT GF-Certified Livestock cannot contain Grain. The same oversight mechanisms that are used by the OPT Certifier to discharge the same duties under the NOP are appropriate, and findings of compliance for Certification under the NOP are sufficient to demonstrate compliance with The OPT Grass-Fed Program.

#### B. No Prohibition on OPT Action in the Event of NOP Inaction

The absence of a specific difference between the NOP and The OPT Grass-Fed Program does not in all cases mean the outcome of review of a living condition or related practice will be identical. Nor does it mean that NOP acceptance of a practice or OPT Certifier decision necessarily and in all cases means OPT acceptance of the same practice or decision. As noted in the Federalism Principles Section in this Program Manual, the OPT may act in the absence of action by the NOP on matters and questions arising under apparently identical Standards. *See:* Appendix E, Section II.

#### X. Pasture Management Plan

#### A. Written Pasture Management Plan

The OPT Certifier shall require each applicant Operation to submit a written Pasture management plan and shall assess the correlate OPT Grass-Fed Livestock Standards that ensure its efficacy at the time of inspection. Taken together, these written materials, their corresponding records and their verification by direct observation should demonstrate that the Pasture management practices assure the available vegetative cover on an annual basis is sufficient to allow the Operation to meet the grazing requirements of the OPT Grass-Fed Program.

OPT Certifiers should generally rely on the Guide for Organic Livestock Producers<sup>11</sup>, and within it:

- "Guide for Organic Livestock Producers" (November 2012)
- "CAP-138 Resource Inventory Supplement Livestock Production" (April 16, 2015).

All forms and templates or written guidance provided to OPT GF-Certified Operations shall be submitted to the OPT for review and approval.

#### XI. Recordkeeping

#### A. No Specific Additional Practices

Although the OPT Grass-Fed Program imposes additional grazing requirements and specific limitations on the identity, quantity and frequency of Feedstuffs, Supplements, Feed Additives and vitamin products, and specific practices regarding disposition of non-

compliant animals and milk, and Split Operations, the purpose, form, and substance of recordkeeping is identical to that required for Organic Certification under the NOP.

#### **B. Reliance on NOP Guidance**

OPT Certifiers should follow NOP § 205.103, § 205.201, § 205.406(a) and OILC<sup>12</sup> Course NOP-140 Recordkeeping. Thus, the same recordkeeping practices that are accepted by OPT Certifier to discharge the same duties under the NOP are appropriate, and findings of compliance for Organic Certification under the NOP, provided any additional records required by The OPT Grass-Fed Program are maintained, are sufficient.

### C. No Prohibition on OPT Action in the Event of NOP Inaction

The absence of a specific difference between the NOP and The OPT Grass-Fed Program does not in all cases mean the outcome of review of a recordkeeping practice will be identical. Nor does it mean that NOP acceptance of a practice or OPT Certifier decision necessarily and in all cases means OPT acceptance of the same practice or decision. As noted in the Federalism Principles Section in this Program Manual, the OPT may act in the absence of action by the NOP on matters and questions arising under apparently identical Standards. See: Appendix E, Section II.

### D. Operation Reports

OPT Certifiers should note that OPT may require an Operation Report be filed for any or all OPT GF-Certified Operations.

### XII. Handling of Products from OPT Grass-Fed-Certified Operations

OPT GF-Certified Handlers are required to maintain the integrity of products comprised of milk or meat from OPT GF-Certified Operations. OPT Certifiers should use the following guidelines.

### A. Supplementation of Organic System Plan with OPT-Specific Practice Standards

At present, Organic Handlers that also Handle Livestock products under the OPT Grass-Fed Program shall be found in compliance by OPT Certifiers, provided each OPT GF-Certified Operation's Organic System Plan ("OSP") is supplemented with specific practice standards governing the Handling of products comprised of agricultural ingredients from OPT GF-Certified Operations.

#### **B.** Applicable NOP Provisions

The OPT-specific Handling practices are not intended to be novel. Section 7 C.F.R. §205.201 requires that the OSP describe the management practices and physical barriers employed to prevent commingling of Organic and nonorganic products on an Organic or a Split Operation. Protective practices to prevent Organic products from contacting prohibited substances that could compromise the integrity of the Organic products are required under 7 C.F.R. §205.272. The same practices regarding receipt, storage, Segregation, contact with non-compliant materials and commingling that govern Organic Operations are sufficient to demonstrate compliance with The OPT Grass-Fed Program, provided they are separately identified as OPT-compliant practice standards. *See:* 

- NOP Guidance No. 5025, "Guidance Commingling and Contamination Prevention in Organic Production and Handling" (July 22, 2011); and
- NOP § 205.302 and SOE preamble (88 FR 3548 begins on p. 3600) and OILC Course NOP-210 Keep it Organic When Handling and Processing..

#### C. No Prohibition on OPT Action in the Event of NOP Inaction

The absence of a specific difference between the NOP and the OPT Grass-Fed Program does not in all cases mean the outcome of review of a Handling practice will be identical. Nor does it mean that NOP acceptance of a practice or OPT Certifier decision necessarily and in all cases means OPT acceptance of the same practice or decision. As noted in the Federalism Principles Section in this Program Manual, the OPT may act in the absence of action by the NOP on matters and questions arising under apparently identical Standards. *See:* Appendix E, Section II.

#### XIII. Composition and Labeling of Products from OPT Grass-Fed Certified Operations

The OPT Certified Grass-Fed Organic Livestock Program authorizes the use of its Program Seal on qualified products by a Licensing Agreement executed between the OPT and the OPT GF-Certified Operation. In addition, OPT GF-Certified Operations may refer to the use of OPT GF-Certified ingredients or contents directly on a product's packaging or label.

#### A. OPT Certifier Review and Approval of Labeling Claims

OPT-Accredited Certifiers are authorized to conduct initial label reviews and make final determinations regarding whether a consumer-facing product label or packaging and marketing claims made there on are compliant with the OPT Grass-Fed Organic Program. The purpose of review is to ensure that each reference to the OPT Grass-Fed Program to consumers is accurate, truthful, and non-deceptive and comports with the goals and mission of the OPT to a reasonable certainty. OPT Certifiers may submit labels to the OPT for consideration and decision as warranted.

#### **B.** Percentage Labeling Claims

- 1. Use of 100% Term
  - a. The term "100%" may not be used except in accordance with the NOP regulations.
  - b. Moreover, the term "100%" should not be used:
    - i. On packaging or labeling of an OPT Grass-Fed Certified product in the same phrase with the word "Organic" (or it would risk violating the binding federal Organic product classifications and that have been expressly adopted by the OPT).
    - ii. In the same phrase with the term "Certification" or "Certified" except to indicate the product's ingredients are sourced solely from OPT GF-Certified Production Operations (e.g., "100% Certified Grass-Fed Organic Farms"); and
    - To suggest the OPT Grass-Fed Program verifies an animal is "100% Grass-fed." Thus, "100% Certified Grass-Fed Organic Farms" is acceptable, but "100% Certified Grass-Fed Organic Cows" is not acceptable.
  - c. We discourage the use of the term 100% in reference to OPT Grass-Fed certification. Any claims of 100% must be accurate claims. Claiming a 100% grass-fed diet as a result of OPT Grass-Fed Organic certification is inaccurate given allowances for non-grass based feeds which may be fed per Section V. Livestock Diet Allowed, Restricted and Prohibited Feedstuffs. Likewise it is imperative to avoid claims of 100% if they are in conflict with the requirements set forth in NOP 205.301(a).
  - d. Operations may use the term 100% at their own risk per the following guidelines:

- Romance copies on the packaging or labels suggesting that OPT Certification verifies a 100% Grass based diet is not acceptable. "100%" should not be used to suggest the OPT program verifies an *animal* is "100% grass-fed." Thus, "100% Certified Grass-Fed Organic Farm(s)" may be acceptable but "100% Certified Grass-Fed Organic Cows" is not acceptable. Examples of claims:
  - 1. Prohibited:
    - a. 100% certified grass-fed [generic products i.e. dairy, meat, milk, yogurt, etc.]
    - b. 100% Grass-fed [generic products i.e. dairy, meat, milk, yogurt, etc.]
    - c. 100% certified grass-fed [sheep, goats, cows]
  - 2. Allowed at operator risk:
    - a. Certified 100% Grass-Fed [Farm, Ranch, Operation, Dairy Farm]: *Allowed as long as certified operation is not a split operation*.
    - b. Certified Grass-Fed [Farm, Ranch, Operation, Dairy Farm]: *Allowed as long as certified operation is not a split operation.*
    - c. Certified 100% Grass-fed (no modifier): *Allowed as long as product is in conformance with NOP 205.301(a)*
    - d. 100% Grass-fed (no modifier): *Allowed at operator risk and should be factual*
  - 3. The above is not an exhaustive list of allowed and prohibited examples of the term 100%. If certifiers need additional case-by-case guidance, please contact OPT to discuss.
- C. "Certified Grass-Fed Organic" Multi-Ingredient Products

If a multi-ingredient product is composed of 95%-99% OPT Grass-Fed Programcompliant ingredients it may be labeled "**Certified Grass-Fed Organic** [ingredient described]" *provided*, the remaining content of the product must comply with Organic requirements and in no case shall it contain an ingredient *in a form Certified* to the OPT Grass-Fed Program and in the *same form but not Certified* to the OPT Grass-Fed Program

D. "Made with Certified Grass-Fed Organic Ingredients"

If a multi-ingredient product is composed of 70%-94% OPT Grass-Fed Programcompliant ingredients it may be labeled "Contains Certified Grass-Fed Organic [ingredient described]" or "**Made With Certified Grass-Fed Organic** [ingredient described]," *provided*, the remaining content of the product must comply with Organic requirements and in no case shall it contain an ingredient *in a form Certified* to The OPT Grass-Fed Program and in the *same form but not Certified* to The OPT Grass-Fed Program.

#### XIV. Use of the OPT Licensed Trademarks

The requirements and governing principles for the use of the OPT Licensed Trademarks are set forth in a separate licensing agreement between the sellers of consumer-facing products and the OPT. OPT Certifiers do not enter into licensing agreements on behalf of OPT. Upon OPT Certification of an Operation using the Seal (see Program Manual section XIV(B)), please inform OPT with their exact Operation name and contact information.

#### A. Required Licensing Agreement between Certified Operations and OPT

The OPT Certified Grass-Fed Organic Seal ("the Seal") and claim may be used only on consumer-facing products by Certified Operations that have entered into a licensing agreement with OPT and pay their licensing fee to OPT.

#### **B.** Licensing Fee

An OPT Seal licensing fee is applicable solely to Certified Operations that place the OPT Certified Grass-Fed Organic Seal on consumer-facing packaging. The fee is assessed by and remitted directly to OPT as authorized under the licensing agreement. OPT may request verification from the Certifier that the sales figures are accurate.

#### C. OPT Certifier Role in Enforcement

- 1. OPT Certifiers must:
  - a. Notify each OPT GF-Certified Operation that it may use the OPT Certified Grass-Fed Organic Seal ("OPT Seal") solely after entering into a licensing agreement directly with OPT;
  - b. Report to OPT-those OPT GF-Certified Operations that intend to use the OPT Seal;

- c. Report to OPT any misuse of the OPT Seal that is observed during the Certification term; and
- d. Provide a list of OPT GF-Certified Handling/Processing Operations to the Program Director and routinely update their status.
- 1. OPT may suspend or revoke any Seal licensing agreement but shall do so directly with the counterparty and without intervention of the accredited OPT Certifier. Such suspension will not immediately affect the OPT Grass-Fed Organic Certification of the Operation.

#### XV. Complaints from Applicants, OPT Grass-Fed Certified Operations, and Third Parties

#### A. General

Each OPT Certifier may maintain its existing process for disposition of complaints it receives from applicants, OPT GF-Certified Operations and third parties regarding an OPT GF-Certified Operation or the OPT Certifier itself. The following procedures should be, at a minimum, observed.

#### B. Complaints Regarding OPT Certifiers and OPT Grass-Fed Certified Operations

Any person may submit a complaint to an OPT Certifier or OPT alleging an OPT GF-Certified Operation or an OPT Certifier has failed to or has negligently discharged a required duty, provided that the person alleges he or she is materially and adversely affected by the actions complained of. A person may include a legal entity that is not an individual.

- 1. An unsigned, or anonymous complaint should generally not be accepted unless sufficient indication of its merit is apparent on the face of the complaint.
- 2. An OPT Certifier may choose to forward a complaint filed against the OPT Certifier to OPT but need not do so. If the OPT Certifier chooses not to forward the complaint, it shall provide Notice to the complainant that the complainant may appeal the final action taken by the OPT Certifier to the Program Director.

# C. Complaints Regarding Misuse of Licensed Trademarks or Misrepresentation of Products

Any person may submit a complaint to an OPT Certifier or OPT alleging a person or entity is misusing the OPT Certified Grass-Fed Organic Seal or misrepresenting OPT GF-Certified products in the marketplace. A complainant does not need to allege he or she is materially and adversely affected by the actions complained of. An unsigned, or

anonymous complaint will generally not be accepted unless sufficient indicia of its merit appear on the face of the complaint. The following procedure should be observed.

- 1. All complaints *received* from third parties, in whatever form, should be submitted or forwarded to OPT.
- 2. All complaints *initiated by* OPT Certifiers or OPT GF-Certified Operations shall be submitted to OPT in writing, be signed by the complainant and state facts alleging the misconduct with sufficient particularity to permit a meaningful investigation as well as a meaningful response by the target of the complaint.
- 3. All complaints will be assessed on a case-by-case basis unless the allegation involves a factual nexus that is shared by multiple OPT Certifiers or OPT GF-Certified Operations.
- 4. OPT will acknowledge receipt, investigate, and seek any rebuttal information from affected parties that is reasonably available. Appropriate action will be taken, in writing, upon development and review of the fullest record possible.

#### D. Confidentiality

OPT shall treat each complaint received as Confidential Information unless a failure to publicly disclose or act would immediately endanger human or animal health and wellbeing or threaten immediate and irreparable economic harm on an uninvolved third party. Confidentiality may not be appropriate on other grounds and shall be assessed on a case-by-case basis.

#### E. Cooperation of OPT Certifiers and OPT Grass-Fed Certified Operations

OPT Certifiers and OPT Grass-Fed Certified Operations are required to cooperate with OPT regarding any investigation. A failure to meaningfully cooperate may result in adverse consequences to the OPT Accreditation or OPT GF Certification, as appropriate.

#### F. Notice of Non-Compliance to OPT Grass-Fed Certified Operations

OPT Certifiers should follow any NOP-acceptable process for the assessment and disposition of Noncompliances at applicant Operations. The OPT Certifier has the discretion to determine whether a Noncompliance may be helpfully characterized as "major" or "minor" provided that, in no case shall the plain meaning of specific language in the OPT Standards or unambiguous guidance in the Program Manual be disregarded.

#### XVI. Appeals of Certification Decisions

Each OPT Certifier may maintain its existing process for disposition of appeals of Adverse Actions it takes with regard to applicants or OPT Grass-Fed Certified Operations. Certifiers should generally follow NOP Instruction No. 4002: "Enforcement of the USDA Organic Regulations: Penalty Matrix" (Mar. 20, 2024). The following procedures should be, at a minimum, observed.

- **A.** Appeals of Adverse Actions taken by OPT Certifiers under the OPT Grass-Fed Program shall be submitted in writing to the OPT Certifier having taken the challenged action. The appeal may be shared with OPT at the discretion of the OPT Certifier.
  - 1. The OPT Certifier shall thereafter timely render a decision on the appeal in writing, a copy of which shall be submitted to OPT; and
  - 2. If the appealing party is dissatisfied with the outcome, it may submit an appeal of the decision to OPT and shall serve a copy of the appeal on the OPT Certifier who shall thereafter forward to OPT any portions of the OPT GF Certification and appeal record necessary to the proper disposition of the complaint; and
  - 3. If the OPT Certifier shares the substance of the appeal with OPT before disposition, it shall waive any claim hereunder that Or may not hear the appeal.
- **B.** Appeals of adverse OPT Accreditation decisions taken by OPT shall be directly submitted, in writing, to OPT.
- C. Examples of Adverse Actions that may be appealed include:
  - 1. Proposed suspension of OPT Grass-Fed Certification or Accreditation;
  - 2. Proposed revocation of OPT Grass-Fed Certification or Accreditation;
  - 3. Denial of OPT Grass-Fed Certification or Accreditation;
  - 4. Combined OPT Grass-Fed Program Notice of Noncompliance and proposed suspension or revocation;
  - 5. Cease and desist Notice;
  - 6. Denial of reinstatement; and
  - 7. Failure to properly discharge a complaint lodged against the OPT Certifier.

This list is not exhaustive and is subject to change.

#### XVII. Petitions

#### A. Variance

Any OPT Grass-Fed Certified Operation, or any OPT Certifier may Petition the OPT to grant a Variance from any OPT Grass-Fed Program provision on facts specific to that party or as it is generally applied to each OPT GF-Certified Operation affected by the Standard to which the Variance request is directed. OPT shall prepare a summary of the request for submission to the OPT Certified Grass-Fed Organic Livestock Program Steering Committee for review and decision. Variance requests require submission of clear and convincing evidence of the need for the Variance. Petitioners for a Variance should consider the procedures and grounds set forth in NOP Guidance No. 2606 (Nov. 20, 2015) for assistance. The Petition shall be lodged with the Program directly at admin@organicplustrust.com.

#### **B.** Program Amendment

Any OPT Grass-Fed Certified Operation, or any OPT Certifier may Petition the OPT to amend any Standard in its program or add or delete any Standard. Petitions to amend in the foregoing manner shall include facts generally applicable to every OPT GF-Certified Operation under the program and state with specificity the proposed alternative and the consequences of any failure to act. The Program Director shall prepare a summary of the request for submission to the Steering Committee for review and decision if and when the Petition is requested to be acted on outside of the update schedule outlined in section VI of Appendix D.

#### B. Submission

Petitions for an OPT Grass-Fed Program Variance shall be lodged with OPT directly via email at admin@organicplustrust.com or the Web Portal and shall state with sufficient particularity the grounds for granting the Variance or for amending the Standards. Each Petitioner agrees to the following statement.

#### "To my best knowledge and belief:

- This Petition includes all information and views upon which the Petition relies; and
- This Petition includes representative data and/or information known to the Petitioner which are unfavorable to the Petition; and

- *I have taken reasonable steps to ensure that any representative data and/or information which are unfavorable to the Petition were disclosed to me.*
- If I received or expect to receive payments, including cash and other forms of consideration, to file this information or its contents, I received or expect to receive those payments from the following persons or organizations: [Name].
- I verify that the foregoing is true and correct as of the date of the submission of this *Petition.*"

### Appendix C

### **OPT ACCREDITATION PROGRAM BACKGROUND<sup>13</sup>**

#### I. A Public "Benefit" Company that Extends Organic's Reach

- A. The Organic Plus Trust Inc., ("OPT") is organized as a "public benefit" company. OPT's charter dedicates it to the public benefit of improvement in human, farm animal, and environmental health by expanding upon existing federal Organic Production and Handling Standards and verification tools to meet business and consumer preferences.
- **B.** Existing federal Organic Certification standards and NOP Accreditation performance requirements are the OPT's conformance baseline. OPT's principal activity is the cooperative development of Production and Handling Standards and supply chain oversight mechanisms that extend, expand, and bolster the existing requirements for Organic Operations and ACAs.
- **C.** Funding for the OPT's work is expected to primarily derive from small administrative fees and a licensing program for the use of its Licensed Trademarks.
- **D.** OPT is not directly affiliated with an ACA and is not an OPT-Accredited Certification body ("OPT Certifier").

#### II. The OPT Standards Modules

- A. Starting with federal Organic requirements allows OPT to develop its own Standards in a highly targeted, consumer sensitive manner. These Standards are referred to as "modules" because they presently are designed to supplement existing Organic Certifications.
- **B.** OPT modules are published under a Creative Commons copyright license for no fee.<sup>14</sup> The OPT Grass-Fed Program Manual<sup>©</sup> may be used under the Creative Commons copyright.
- **C.** The Program Manual will be updated periodically, with the most recent version located in the "Documents" section of the OPT website and in the OPT Web Portal.
- **D.** OPT develops its Standards by an open and inclusive process that involves diverse opinions. OPT conducts ongoing review of each module's Standards by stakeholder

open forums and Advisory Committees and through a standards development process as outlined in Appendix D.

E. A module-specific Steering Committee oversees Standards development and maintenance.

#### VI. The OPT Module: "The OPT Certified Grass-Fed Organic Livestock Program<sup>TM</sup>"

- A. The absence of a consistent national Production standard for "Grass-fed" Livestock product marketing claims and the lack of full supply chain verification programs led to the development of the "OPT Certified Grass-Fed Organic Livestock Program<sup>TM</sup>" (hereinafter "The OPT Grass-Fed Program").
- **B.** The development of the Production, Handling and Accreditation Standards Program lasted approximately two years and included many stakeholders in the "Grass-fed" Livestock movement including two ACAs: The Northeast Organic Farming Association of New York ("NOFA-NY") and Pennsylvania Certified Organic ("PCO").
- C. To market products under the OPT Certified Grass-Fed Organic Livestock Program<sup>™</sup>, the involved Production and Handling OPT Grass-Fed Certified Operations must be both certified Organic under NOP and Certified to a specific OPT Standard.
- **D.** The OPT Certified Grass-Fed Organic Livestock Program<sup>™</sup> module is in a style and format that tracks NOP regulations.
- **E.** The OPT will conduct OPT Accreditation assessments of ACAs and support the OPT Certified Grass-Fed Organic Livestock Program Steering Committee in its management of the ongoing Production, Handling, and Accreditation Standards development processes. *See* below.

#### **IV. The OPT Accreditation Program**

- **A.** OPT Grass-Fed Certification Services are provided solely by ACAs that have received a module specific to Accreditation by OPT. OPT is not a certifying body and conducts no Certifications.
- **B.** All federal requirements applicable to—Accreditation, inspection and Organic Certification through ACAs will be maintained and be fully operative in the OPT Grass-Fed Certification process, including all ethical responsibilities.
- **C.** An OPT module specific OPT GF Certificate of Accreditation will be provided to ACAs that are accredited by OPT. An OPT Grass-Fed Certificate of Compliance will

be used for each OPT GF-Certified Operation to ensure consistent identification of compliant products throughout the supply chain.

#### V. The OPT Accreditation Program

- **A.** Only ACAs are eligible to seek Accreditation to provide Certification Services for the OPT Certified Grass-Fed Organic Livestock Program<sup>™</sup>.
- **B.** The OPT Accreditation Program does not replicate the cost and effort of a federal certifying agent Accreditation by NOP: it builds on it. Existing NOP Accreditation regulations and policies are incorporated into the OPT Certification Services Agreement.
- **C.** The initial assessment, ongoing oversight, and reassessment of an OPT Certifier are described below.
  - 1. Application for Accreditation

To determine the eligibility of an ACA for OPT Accreditation, OPT requires submission of an Application that includes:

- a. Proof of Accreditation as a federal Organic certifying agent (ACA) under the NOP;
- b. Designation of the scope of OPT Accreditation sought (Producer or Handler);
- c. Copy of any Grass-fed practice standards for Producers or Handlers currently in use or anticipated for use under the OPT Grass-Fed Program; and
- d. The ACA's Certification services policy manual or program manual.
- 2. Required OPT Grass-Fed Program Training

OPT Certifiers are expected to be able to fully implement the latest published edition of the OPT Grass-Fed Program Manual and Standards. OPT expects applicant ACAs to participate in any OPT-offered online training webinars. The training has three purposes. First, it seeks to familiarize OPT Certifiers with the module's unique requirements that extend certain Organic practices or restrict the use of certain accepted materials or practices. Second, it is an opportunity to discuss the underlying program Standards and the general terms of service. Third, it is a forum for other questions ACAs might have regarding the OPT and its Certified Grass-Fed Organic Livestock Program<sup>TM</sup>.

3. Possible Site Visit and Additional Information

If, after the training is completed, and all requested documents are in the OPT possession, and before the Certification Services Agreement is executed, any additional information is needed or in the rare case where a site visit is deemed necessary, the applicant shall be notified in writing. Such a visit would be conducted at the applicant's expense.

- 4. OPT Accreditation Decision and Duration of OPT Accreditation
  - a. If OPT finds, on the basis of the Application that the applicant does not meet the eligibility requirements, the applicant shall be advised in writing.
  - b. Upon submission of the required information and completion of the required training, a Certification Services Agreement shall be provided and thereafter executed between the parties. OPT Accreditation is complete after execution of the Certification Services Agreement. The initial term of OPT Accreditation shall be for the duration of one year.
- 5. Certificate of OPT Accreditation

Each OPT-accredited entity will receive an OPT GF Certificate of Accreditation bearing the scope of the Accreditation and an expiration date indicating the duration of one year. The OPT GF Certificate of Accreditation is sent by OPT electronically to the OPT Certifier once all Accreditation requirements have been met.

6. Appeal

An adverse decision regarding OPT Accreditation, other than eligibility, must be corrected as instructed by the Program or may be appealed. The OPT Certifier shall submit an appeal request within 30 days of the decision.

7. Ongoing Oversight and Renewal

The OPT will from time to time seek information from OPT Certifiers and prior to expiration of the Certification Services Agreement, OPT will set forth a renewal process for OPT Accreditation.

OPT Certifiers are expected to be able to fully implement the latest published edition of the OPT Grass-Fed Program Manual and Standards.

8. Certification Services Agreement

- A. Each accredited OPT Certifier will execute a Certification Services Agreement with OPT prior to undertaking to provide Certification Services. The Agreement sets forth contractual obligations of each party and works in conjunction with the OPT Grass-Fed Program Materials, the OPT Ancillary Materials and the OPT Certification Service Materials.
- B. The Certification Services Agreement shall be terminated when there is a cessation of business activity as an ACA. Otherwise, the OPT Certifier may cease performing Certification Services in accordance with the Agreement.
- 9. Forms, Documents, and Certificate Issuance Mechanism
  - a. OPT Certified Grass-Fed Organic Livestock Program<sup>TM</sup> Web Portal

The OPT Grass-Fed Program Web Portal is intended to be the source of all OPT GF Program-generated documents and repository of all documents submitted to OPT.

b. Certification Services Materials

Each OPT Certifier may develop and use its own Certification Services Materials as defined in Appendix A. They must be submitted to and approved by OPT. Materials that are not covered by this definition do not need pre-approval. However, in no case should marketing materials of any sort misrepresent the OPT GF Program or the OPT Certifier's relationship to it. The OPT Grass-Fed Organic Seal may be used for marketing purposes by an OPT Certifier.

c. OPT Grass-Fed Organic Certificates of Compliance

OPT Grass-Fed Organic Certificates of Compliance are issued solely through the OPT Grass-Fed Program Web Portal or, if the system is down, OPT shall issue a Certificate. Each Certificate will be uniquely numbered by the Certificate generator in the Portal. All documents supporting issuance of the Certificate must be uploaded by the OPT Certifier into the Portal. If the Web Portal is undergoing maintenance, the sole method of generation for Certificates of Compliance is by direct electronic submission of the Certification packet documents (Operation Application, Inspection Report, and Review Summary/Report) to the Program Director. OPT Certifiers do not need to receive OPT approval before accessing the Web Portal to issue a Certificate.

The aim of the Certificate generator is ease of use and to harmonize the representation of the OPT GF Program in the marketplace. Each Certificate issued contains mandatory language and reference to the OPT GF Program.

#### 10. OPT Accreditation Fee, Program Fees, and Licensing (Seal-Usage) Fees

The following types of fees must be remitted to OPT:

- a. An administrative fee of \$150.00 that each OPT-Accredited Certifier must remit to OPT for each Production Operation or Handling/Processing Operation that is OPT Grass-Fed Certified.
- b. An OPT Grass-Fed Organic Seal licensing fee applicable solely to OPT GF-Certified Handlers that place the Seal on consumer-facing packaging. This fee is assessed by and remitted directly to OPT via a licensing agreement OPT has with each Seal user.
- 11. Certification Fees for Service

Each OPT Certifier may set its own, non-discriminatory, fees for offering OPT modules to its clients.

## Appendix D

## GOVERNANCE OF THE OPT GRASS-FED STANDARDS DEVELOPMENT

## I. OPT Certified Grass-Fed Organic Livestock Program<sup>TM</sup> Steering Committee

- A. The OPT Steering Committee oversees the ongoing work on the OPT Grass-Fed Program and Standards. The goal of the Steering Committee is to review and approve modifications to the Standards, offer governance to program administration, represent the program in a favorable image and support the growth and development of the program.
- B. The Steering Committee shall consist of not less than 3 and not more than seven seats. The representation of the Steering Committee shall include industry stakeholders including but not limited to OPT certified farmers and handlers, OPT accredited certification agencies, animal welfare/nutritionists, advocacy/consumer focused organizations.
- C. Steering Committee members serve for a renewable term of three years beginning on February 1st. Terms may begin at varying times of the year in the event of unexpected resignation or turnover.
- D. Prospective Steering Committee members will submit a letter of interest, bio, and resume to the Organic Plus Trust Program Director at admin@organicplustrust.com. In an effort to broaden representation, individuals from a business/organization already represented on the Steering Committee will not be eligible to serve simultaneously. Prospective members that have engaged in an Advisory Committee role or participated in the Standards Development process outlined in section VI of Appendix D will be given priority.
- E. All active Steering Committee members will attend an annual onboarding/refresher meeting.

### **II. Steering Committee Meeting Processes**

A. Roberts Rules and Guidelines

The Steering Committee shall act in general accordance with Roberts' Rules and the principles set forth below, as may be developed or revised from time to time.

**B.** Meeting Sites and Frequency

The Steering Committee will meet at least four times per year either in person or virtually. It is acceptable for Steering Committee business, including voting on motions, to be conducted by teleconference, videoconference, and email.

## **III.** Supermajority

A 2/3 supermajority of a quorum of the Steering Committee is required to adopt a new Standard or an amendment to existing Standard by the Steering Committee,

## IV. No Conflicts

In no case shall an OPT Grass-Fed Program Standard be adopted that is in direct conflict with a corresponding federal Organic requirement. The federal NOP Organic standards are the baseline standards for the OPT Grass-Fed Program.

## V. Antitrust Policy

The OPT Grass-Fed Program shall be developed in accordance with applicable antitrust and competition laws and meetings amongst competitors to develop such Standards are to be conducted in accordance therewith.

## VI. Updates to the OPT Grass-Fed Program Manual and Standards

- A. The Annual Update includes an administrative review of standards, and the finalized version will be released. A Full Revision of standards includes an in-depth revision with involvement from materially affected parties and the finalized version will be released every 3 years, though this frequency may be amended as necessary. The most recent full revision occurred with Grass-Fed Standards version 4.0\_2024.
- **B.** The Update Schedule will be as follows.

## C. Comment Methods

- 1. Each draft shall be paginated with line numbers.
- 2. Comments shall be offered using track changes.
- 3. Alternatively, standard editorial signals using strikethrough to indicate deleted language and <u>underline</u> to indicate proposed new language.
- 4. We also encourage explanations of proposed edits using the convention of referring to suggestions as either "technical edits" and "substantive edits." These comments may be embedded using the "comment" feature or by a separate document.
- **D.** Any materially affected parties may submit comments during the open comment period, as announced by the Program, to suggest modifications to the Standards and Program manual. Open Meetings with the Advisory Committees will be scheduled and chaired by members of the Steering Committee to air comments on Program and Standards amendments. Updated standards will be released by September 30th annually.

Any OPT Certifier may bring substantive or technical matters to the attention of OPT at any time of the year. However, those issues will be brought forward in the process noted above per section VI(A) unless the issue is an extenuating circumstance.

**E.** Technical issues (e.g., typos, misspellings, missing words, formatting, and grammatical errors) are facially erroneous and immediately correctable.

## VII. The Advisory Committees

The Advisory Committees support the standards development process through analyzing standards, making standards recommendations to the Steering Committee, and participating in meetings to discuss standards topics. Advisory Committee meetings are open to the public and chaired by the OPT Program Director.

- A. Meetings will be held as needed, dependent on whether the Standards in question are being fully revised, updated annually or when specific topics arise in need of advisory consultation. Email communication and additional meetings throughout the year may be requested as needed. Agenda for meetings will be based on submission from the open comment period or extenuating circumstances that arise out of cycle.
- B.
- C. The Advisory Committees shall be open to all materially affected persons or parties with regard to the subject or activity. Prospective Advisory Committee members will submit their interest in serving to the Organic Plus Trust Program Director at <a href="mailto:admin@organicplustrust.com">admin@organicplustrust.com</a> and indicate desired Advisory Committee noted in section VII(C).
- D. The Advisory Committees are as follows:
  - 1. Production Standards This Advisory Committee receives and considers submissions concerning desired changes to the OPT Grass-Fed Standards that relate to Production (e.g., approval of Supplementary Feedstuffs).
  - 2. Handling Standards This Advisory Committee receives and considers submissions concerning desired changes to the OPT Grass-Fed Standards that relate to Handling.

Supplemental Feedstuffs - This Advisory Committee receives and considers submissions concerning desired changes to the Standards relating to Allowed but Restricted Supplemental Feedstuffs including, but not limited to Standards section V. in Table 2.

## VIII. Committee Process and Participation

## A. Openness

Participation in Advisory Committee work shall be open to all persons who are directly and materially affected by the activity in question. There shall be no undue financial barriers to participation. Membership on a Standards Advisory Committee shall not be conditioned upon membership in any organization, nor unreasonably restricted on the basis of technical qualifications or other such requirements.

## **B.** Lack of Dominance

The Advisory Committee Standards development process shall not be dominated by any single interest category, individual or organization. Dominance means a position or exercise of dominant authority, leadership, or influence by reason of superior leverage, strength, or representation to the exclusion of fair and equitable consideration of other viewpoints.

## C. Balance

Advisory Committees seek a balance of interests. Participants from diverse interest categories shall be sought with the objective of achieving balance.

### D. Coordination and Harmonization

Good faith efforts shall be made to resolve potential conflicts between and among Advisory Committee recommendations regarding existing Standards that operate in the same market space.

## E. Notification of Standards Development

Notification of Advisory Committee activity shall be announced in suitable media as appropriate to demonstrate an opportunity for participation by all directly and materially affected persons.

## F. Consideration of Views and Objections

Prompt consideration shall be given to the written views and objections of all Advisory Committee participants.

### G. Appeals

There are no appeals of final decisions of the Steering Committee. However, a Petition to amend the any change the OPT Grass-Fed Program may be submitted per section VI of Appendix D.

## Appendix E

## **OPT CERTIFICATION SERVICES BACKGROUND**

## I. Certification First Principles

The following first principles govern the delivery of OPT Grass-Fed Certification Services and issuance of Certification to a compliant Operation under the OPT Certified Grass-Fed Organic Livestock Program<sup>TM</sup>.

- A. The OPT Grass-Fed Program is underpinned by the NOP and incorporates to the extent reasonably possible the existing federal regulations and federal guidance governing ACAs and Organic Operations.
- **B.** Certification Services are delivered under the Certification Services Agreement that incorporates the OPT Grass-Fed Program Materials, the applicable OPT Ancillary Materials, and the applicable OPT Certification Service Materials, and strives for general accordance with NOP Guidance No. 2601, "The Certification Process" (Mar. 20, 2024).
- **C.** OPT Certifiers may develop their own OPT Certification Service Materials sufficient to ensure each OPT GF-Certified Operation has written NOP Practice Standards<sup>15</sup> reflecting elements necessary to ensure compliance with the OPT Grass-Fed Program, which may be contained in an Organic System Plan ("OSP").
- **D.** Pending an Applicant's selection of an ACA for combined Organic and Grass-Fed Certification, OPT is authorized to conduct desk audits of existing Certified Organic Operations for Certification to the OPT Grass-Fed Organic Livestock Program.
- **E.** The OPT Grass-Fed Program should be construed and applied to maximize the use of grazing in each animal's diet, minimize Grain and Grain-derived materials, and maximize animal well-being.
- **F.** OPT Accreditation seeks to ensure the OPT Grass-Fed Program is correctly construed and ensures consumers that products bearing the OPT Licensed Trademarks meet a consistent standard of identity.
- **G.** OPT Certifiers shall construe and apply the OPT Grass-Fed Program Materials to accomplish fundamental fairness to Producers, Handlers, and consumers of OPT Grass-Fed Certified products and to ensure animal well-being. Fundamental fairness is achieved when decisions under the OPT Grass-Fed Program are made (1) in good faith;

(2) with the care that an ordinarily prudent person in a like position would exercise under similar circumstances; and (3) in a manner reasonably believed to be in the best interests of the public benefit goals of the OPT and the OPT Grass-Fed Program.

- **H.** Certification is a conclusion of present compliance and a determination that future compliance is reasonably certain.
- I. Technological and programmatic innovation in Certification Services and OPT Certification Service Materials is encouraged.
- **II.** Federalism Principles
  - **A.** An OPT Grass-Fed Program provision shall be construed and applied to comport with the plain meaning of guidance documents, regulations, or Certification and enforcement decisions issued by or on behalf of the NOP and to avoid conflicts therewith.
  - **B.** OPT Certifiers shall exercise discretion in a manner that accords with its duties under, and reflects appropriate deference to the plain meaning of, guidance documents, regulations, and Certification and enforcement decisions of the NOP.
  - **C.** OPT Certifiers or the OPT may act to discharge OPT-related duties regarding the requirements or interests appearing in the OPT Grass-Fed Program or OPT Ancillary Materials, where NOP action or inaction has left a such interest demonstrably unvindicated, including situations where the OPT and the NOP appear to impose identical requirements.

## Appendix F

## **FREQUENTLY ASKED QUESTIONS**

### 1. How does my organization become an OPT Certifier?

Only an Accredited Certifying Agent ("ACA") in good standing with the National Organic Program (NOP) can apply.

Applicants need to submit the following documents to become accredited as an OPT Certifier by the OPT Grass-Fed Program.

- Copies of any existing Grass-fed standards the applicant ACA may be using or implementing.
- Copies of any practice standards or standard operating procedures (SOPs) that the applicant ACA has developed for implementation of the OPT Grass-Fed Program. Note that if the applicant ACA has developed templates or guidance documents for its clients, the OPT Grass-Fed OPT needs to review and approve them.
- Electronic copy of the applicant ACA's Certification Services Program Manual (the document that informs the OPT Grass-Fed Certified Operation about how the ACA exercises its discretion and ensures compliance, and the procedures observed to ensure fairness). The Manual must include a section on how the ACA deals with complaints or appeals of adverse outcomes.

Note: There is no need for the applicant ACA to submit to OPT its entire submission for Accreditation under the NOP. Parts of the submission may become relevant as the OPT Grass-Fed Program is implemented and may be required at a later time.

### 2. How does my organization begin offering services as an OPT-Certifier?

- Successfully complete the OPT Certified Grass-Fed Organic Livestock Program<sup>™</sup> training online, which is designed to ensure competence with the Standards of the OPT Grass-Fed Program.
- Execute a Certification Services Agreement with OPT prior to undertaking to provide Certification Services. The Agreement sets forth contractual obligations of each party and works in conjunction with the OPT Grass-Fed Program Materials, the OPT Ancillary Materials and the OPT Certification Service Materials.

### 3. Are OPT Certifiers charged an administrative fee by The OPT Grass-Fed Program?

Each accredited OPT Certifier must remit to OPT an administration fee of \$150.00 per Production Operation Certified and for each Handling Operation Certified. Note: The administration fee payment made by the OPT Certifier to OPT is based on the number of OPT Grass-Fed Certifications issued and not the number of On-Site Inspections conducted.

## 4. How often are OPT Certifier administrative fees due?

OPT Certifiers should submit payments to OPT monthly, sending a list of Operations that were OPT Grass-Fed Certified during the previous month and along with the applicable payment amount to OPT.

## 5. How do we make OPT Certifier administrative fee payments to the OPT?

The method of remitting payment to OPT is as follows:

# 6. What kind of products are eligible to bear the certification seal of the OPT Grass-Fed Program?

Single and multi-ingredient products composed of or containing ingredients derived from livestock may be identified as meeting this Program's standards. Livestock products sourced from OPT Certified ruminant livestock that are Handled and processed thereafter by a Handling operation certified under the OPT Grass-Fed Program, are eligible to bear OPT Grass-Fed Program seals on their packaging and labels.

Use of this Program's seal is *mandatory* on all consumer-facing packaging claiming the package's contents, in whole or in part, meet the production and handling requirements of this Program. This requirement is without regard to whether the product is composed of a single or multiple ingredients. In contrast, the use of OPT Grass-Fed Program seal is *permitted but not required* on bulk container packaging. If the seal is *not* used, such bulk container must bear appropriate descriptive labeling to ensure the contents are properly identified as compliant with the OPT Grass-Fed Program.

### 7. Does OPT conduct label review?

Review of proposed labels and packaging by a certifying agent or OPT is mandatory.

## 8. Who may affix the seal of this Program on a package or a label?

Only a farming or Handling operation certified under this Program may deploy the Grass-Fed Seal on a product's package or label. Its use must be reviewed and approved by the OPT or an OPT Certifier. The OPT seal is required to be used on all consumer facing labels that claim the container's contents meet the OPT Grass-Fed Organic program requirements.

### 9. Is a license required to use the OPT Grass-Fed Organic Seal on packaging or a label?

Yes. Each party seeking to deploy the seal must receive a license from OPT to do so.

## 10. Are Retailers or Restaurants considered a "Handler?

Sometimes. Any party that engages in "Handling" or "Processing" of an agricultural commodity as that activity is defined by the National Organic Program ("NOP") is a "Handler" under this Program. The definition of Handling is broad but does not include end users like restaurants or retailers that do not further process certified products.

Whether an activity not covered in the applicable CFR section rises to the level of Handling that requires an entity to be certified is reviewed on a case-by-case basis. Specifically, guidance is found in the exceptions to certification set forth in 7 CFR. §205.101.

### 11. Does the OPT Grass-Fed Program issue certificates to "producer groups"?

No. This Program does not certify groups; only individual farms or handlers. For example, any party that obtains livestock products of multiple certified farming operations and thereafter aggregates those products to conduct a bulk transaction to a third-party buyer that is not an exempted party under 7 CFR. §205.101 is engaging in Handling and must be certified as a Handler. If the downstream purchasing party thereafter engages in processing of the bulk product, it too must be certified as a Handler under this Program.

# 12. May I purchase certified OPT Grass-Fed Program ingredients in a bulk container from a seller that is not certified under this Program?

Generally, no. But there is a narrow "transshipment exception" that applies when a commercial entity receives certified products or ingredients in a sealed container from a Handler certified under this Program. The receiving entity is transshipping need not be certified under the following scenarios.

Transshipment occurs when party receives a (1) a container bearing the OPT Grass-Fed Program seal or labeling placed on that container by the OPT-certified Handler and (2) the container is sealed and bears tamper-evident attributes and (3) the container remains sealed and is re-shipped with the tamper-evident attributes intact.

Transshipment may also occur when a party receives a (1) a container bearing the OPT Grass-Fed Program seal or labeling placed on that container by the OPT certified Handler and (2) the container is sealed and bears tamper-evident attributes and (3) the container holds smaller sealed containers bearing tamper-evident attributes and (4) the smaller containers are thereafter re-shipped unopened with the tamper-evident attributes intact.

## 13. Does a slaughter plant need to be certified to the OPT Program?

Yes. Slaughter facilities engaged in handling and must be certified under the NOP and OPT Grass-Fed Program. Additionally, a certified farming operation that slaughters onsite, is engaging in Handling.

#### 14. What is verified during a Handling inspection?

A Handling inspection confirms (1) observation of operational SOPs while on site including appropriate sourcing, segregation, and anti-commingling practices and (2) the existence of adequate records and recordkeeping practices to substantiate consistent application of the foregoing SOPs.

Depending on the nature of the handling operation and the complexity of the products handled, the inspection may be more or less comprehensive. A traceability exercise may be conducted to ensure a substantiated chain of custody exists.

#### 15. What is the 'OPT Portal'?

The OPT portal provides web-based access to information and reports depending on the credentials of the portal user. Some information is available to the public, some to the certified farming and Handling operations, some to certification agencies and some to business users that are not themselves certified. To ensure confidentiality, access to portal is restricted.
