The Purchaser acknowledges and agrees to the following conditions of sale

Health Guarantees

Your puppy/kitten has received all veterinarian-recommended vaccinations, care, treatments, and a comprehensive health and wellness exam. Additionally, your pet has been given a clean bill of health by our veterinarian at *Companion Pet Clinic*. Based on this, we are offering the following health guarantees:

1. Initial Exam Guarantee
2. 10-Day Viral and Bacterial Guarantee
3. 12-Month Health Guarantee

- **Initial Exam Guarantee:** *Boyle's Creekside* guarantees that your puppy/kitten has undergone a wellness exam and is free from any life-altering physical, viral, or bacterial conditions, and is in good health and fit for sale to the best of our knowledge.
- **10-Day Viral and Bacterial Guarantee:** *Boyle's Creekside* guarantees that your puppy/kitten has not contracted any viral or bacterial illnesses during our care. This guarantee is valid for **10 calendar days** after your puppy/kitten leaves our property.
*Please note this guarantee does not cover illnesses contracted outside of Boyle's Creekside's care or due to improper handling by the new owner. We highly recommend you keep your puppy/kitten away from public areas, standing water, and other animals until they are fully vaccinated.
- **12-Month Health Guarantee:** *Boyle's Creekside* guarantees that your puppy/kitten until they reach **12 months of age** will be free of any genetic defects diagnosed by a licensed veterinarian that may significantly affect the long-term health of your pet. This guarantee **does not cover defects aggravated by activities such as jumping, climbing, or rough play**, and will not be honored if such conditions are found to exist. *Boyle's Creekside's recommends using ramps or carrying your puppy to avoid potential injuries or strain from jumping or climbing stairs as Dachshunds are naturally susceptible to back & hip injuries.

Health Guarantee Conditions

If, for any reason, your veterinarian declares the puppy/kitten unfit for sale during the initial exam, or if your puppy/kitten contracts any viral or bacterial illness within **10 calendar days** or is diagnosed with a life-altering genetic defect within **12 months** of age, you must notify *Boyle's Creekside* immediately—by phone and email—no later than **12 hours** after the exam. You must also provide a written report from the veterinarian, including their contact information.

In such cases, you may choose one of the following options:

1. **A full refund of the purchase price**, upon return of the puppy/kitten.
2. **An exchange** for another available puppy/kitten from a future litter of equal value.

No refund or exchange will be processed until the original puppy/kitten is returned to *Boyle's Creekside* and the claim has been confirmed by our veterinarian. **Boyle's Creekside's will not be responsible for any veterinary expenses incurred prior to the refund or exchange.*

Maintaining Health Guarantees

To maintain the health guarantees provided, you must:

1. Have your puppy/kitten examined by a licensed veterinarian of your choice no later than 5 business days after receiving your puppy/kitten.
2. Continue regular veterinary care as recommended by your veterinarian.
3. Keep all related veterinary records.

**Please note that Boyle's Creekside will not and is not responsible for any veterinary expenses or costs once your puppy/kitten has left our care.*

Additional Sale Conditions:

- **Proper Care and Health Guarantee:**

You, the Purchaser, agree to provide proper care, vaccinations, and recommended veterinary treatments for the lifetime of your puppy/kitten. You also agree to maintain health records. If, at any point, you fail to provide proper care, vaccinations, or recommended veterinary treatment, or if you fail to maintain health records, your health guarantee will be considered void and will not be honored by Boyle's Creekside.

- **No Guarantee on Size, Coat, Coloring, Temperament, or Behavior:**

Boyle's Creekside makes **no guarantees** regarding your puppy/kitten's size, coat, coloring, temperament, or behavior. These traits cannot be guaranteed, and some of them may change as your puppy/kitten matures.

- **Lifetime Ownership and Rehoming:**

You, the Purchaser, agree to maintain ownership and possession of your puppy/kitten for the duration of its life. You will not sell, lease, give away, donate, or surrender possession of the puppy/kitten without first contacting *Boyle's Creekside*. If, for any reason, you are unable to keep the puppy/kitten, you agree to return them to Boyle's Creekside or allow us to facilitate the rehoming process. Any new owners must be approved by *Boyle's Creekside* before rehoming occurs. **Under no circumstances will a puppy/kitten from Boyle's Creekside be sent to a shelter, pound, or be euthanized without just cause.*

- **Contact Information and Updates:**

You, the Purchaser, agree to keep your contact information up to date and allow *Boyle's Creekside* to contact you as needed for updates on your puppy/kitten, such as their adult appearance and general health. These updates help us ensure the ongoing well-being of your pet and allow us to address any unforeseen issues with our breeding program that may not be identified without feedback after the puppy/kitten leaves our care.

- **Microchip Responsibility:**

Your puppy/kitten has been microchipped with **AKC Reunite** (for puppies) or **Home Again** (for kittens). It is your responsibility to update the microchip registration with your own contact information to ensure that your puppy/kitten can be returned to you if found. If you fail to update your microchip information and *Boyle's Creekside* is contacted regarding your puppy/kitten, you may be charged a **\$100 fee** and will be responsible for any costs associated with having your puppy/kitten returned to you.

- **Care Commitment:**

Once again, you, the Purchaser, agree to take excellent care of your puppy/kitten by providing proper food, water, shelter, safe living conditions, daily interaction, exercise, recommended medical care, and the love required to keep your puppy/kitten happy and healthy.

Acknowledgment of Terms

By accepting your puppy/kitten, you, the Purchaser, acknowledge that you have read and understand the conditions of sale, the requirements of the health guarantees, and agree to all terms and conditions outlined herein. You also accept full responsibility for the health and well-being of the puppy/kitten being purchased.
