DEPOSIT

A €250 per person non-refundable* deposit is payable upon booking to secure your place.

BALANCE

The balance due is payable in full a minimum of 8 weeks before the tour start date. Upon receipt of your deposit and booking form we will e-mail you an *Invoice* with the *Balance Due* and the *Due Date* clearly marked.

LAND ONLY

This is a Land Only package. You are responsible for getting yourself to the start point on time and no responsibility or liability will be accepted by us for any failure in this by you or any other parties involved (including airlines) you book independently.

ASSISTANCE

Please advise us at - info@localgustotravel.com - of your proposed flight details so we can help you if required. If you arrive into Bologna Airport on the day the tour starts we will meet and transfer you to the hotel at no extra cost.

CANCELLATION CHARGES

If we cancel the tour for any reason (except hostilities, political unrest or force majeure) we will refund your payments to us in full (including the deposit*). This will not include any expenses incurred by you separately to us in relation to this holiday.

You may cancel your booking at any stage by giving us notice in writing but this may incur cancellation charges as we will have entered into similar contracts with other parties at certain stages before the tour commences:

You may however transfer your booking to another individual subject to the same booking conditions. This must be notified to us a minimum of one week in advance in writing. This may incur extra costs to you which will be passed on to you at cost by us if required.

CHANGES

We have no intention of making any material changes to the itinerary as described but on rare occasions on the road things happen outside our control. In this unlikely scenario we will first try to substitute an equal value item but if for any reason (other than hostilities, political unrest or force majeure) we cannot we will refund you the value of that component of the tour that has not been delivered upon your return.

EVENTS

This tour may comprise one or more outdoor events. These will often take place whatever the weather conditions are at your destination. Unless any given event is cancelled by the organisers and no substitute is possible no refunds will be made by us for unsatisfactory weather conditions.

FITNESS TO TRAVEL

While this tour is not considered strenuous it does involve a good deal of walking some of which will be on hilly ground. This is the nature of many Italian towns which also often have limited traffic access in their historic centres. These are some of the reasons that make Italy so atmospheric. If you have any significant mobility issues a group tour may not suit your needs and we reserve the right to refuse carriage if this is not disclosed in full and agreed by us before initial booking.

INSURANCE

We do not provide any personal travel insurance. We require all travellers to take out their own comprehensive personal travel insurance before travelling.

CONTRACT
