Thank you for choosing Copper Kettle Ranch, LLC, to assist you with boarding, training, and/or lessons. This Agreement is made between Copper Kettle Ranch, LLC, and Customer named above.

1. **Fees:** Attached to this letter are our schedule of fees that describe our policies and procedures for billing our customers. Our fees are adjusted from time to time to reflect increased costs or to accommodate inflationary cost increases affecting our business. The adjusted rates will apply to all services performed thereafter by mailing you a copy of the increased fee schedule. In addition to our fees, we will expect payment for disbursements and other charges. Each month we will furnish you with one or more statements describing our services rendered and separately showing disbursements and other charges. Due to the nature of showing, there often is an unavoidable delay in reporting disbursements and other charges, and therefore not all disbursements and charges may be billed at the same time as the related services. In addition, our employees, contractors, and subcontractors may invoice you separately for their services provided under the terms of this Agreement and schedule of fees. We will expect your invoices to be paid monthly as they are billed to you. A finance charge of 1-1/2 percent per month, or 18 percent a year, compounded monthly, is assessed for accounts not paid within 15 days. If your account is turned over for collection because of nonpayment of fees and costs when due, you will be responsible for all costs of collection, including Copper Kettle Ranch, LLC, reasonable attorney fees and costs.
2. **Right of Lien:** Copper Kettle Ranch, LLC, has the right of an agister's lien as set forth by the Colorado Revised Statutes for the amount due for board and additional services and shall have the right, without process of law, to retain your horse(s) until the indebtedness is satisfactorily paid in full, together with any fees, costs and/or attorney's fees.
3. **If Boarding, Care of Horses:** Supplements and vitamins, if required, are to be supplied by the Customer or, if purchased by Copper Kettle Ranch, LLC, will be billed to Customer or paid in advance by Customer, as Copper Kettle Ranch, LLC, deems appropriate. Stabling assignments, turn-out times, and paddocks used, will be decided by Copper Kettle Ranch, LLC. Copper Kettle Ranch, LLC, agrees to assist the customer in establishing a program of hoof care and deworming consistent with recognized standards, which will billed to

Customer or paid in advance by the Customer, as Copper Kettle Ranch, LLC, deems appropriate. Copper Kettle Ranch, LLC, has the permission of Customer to request a veterinary visit or request the services of a farrier. This will be done at Customer's expense. In an emergency, Copper Kettle Ranch, LLC, will make every effort to reach Customer. Any decisions made by Copper Kettle Ranch, LLC, in the absence of Customer, will be made in the best interests of the horse. Any veterinary charges are the responsibility of Customer, who will be billed directly by the veterinary clinic for any charges, or if Copper Kettle Ranch, LLC, has paid the same will be billed to Customer.

4. **Termination:** As boarding charges are incurred the first day of each month in advance for the entire month, written notice of at least 30 days prior to the first of the month (i.e., notice on April 15 will be effective May 30) shall be submitted to Copper Kettle Ranch, LLC, will be required to terminate any boarding agreement. Any shorter notice will result in boarding charges for the month of the notice and the following month. Copper Kettle Ranch, LLC, reserves the right to terminate any boarding agreement with thirty day's notice to Customer.
5. **Damages:** Customer is financially responsible for any and all damages caused by their horses to the stable, to the property, or to Copper Kettle Ranch, LLC, tack and equipment.
6. **Liability:** Copper Kettle Ranch, LLC, will provide ordinary care to the horse while on the premises. However, Copper Kettle Ranch, LLC, is not liable for injuries to the horse, Customer, or Customer's guests as more fully described in our General Release form. Customer must take all reasonable care when on the premises, including the wearing of an approved safety helmet when riding said horse. Customer will have the use of an unlocked tack room to store their equipment. Copper Kettle Ranch, LLC, management, and staff will not be responsible for lost or stolen articles. Customer must tidy Copper Kettle Ranch, LLC, equipment and premises after use.
7. **Hours:** The property is open during hours posted by Copper Kettle Ranch, LLC. Customer must seek permission of Copper Kettle Ranch, LLC, to be on the premises outside of posted hours. By agreeing to this Agreement, you are also agreeing to follow our Stable Rules as may be posted at the facility.
8. **Dispute Resolution/Arbitration:** We pride ourselves on our reputation and 99 percent of all problems can be resolved by communication. Any controversy, dispute, or claim arising out of or relating to our fees, charges, performance of services, obligations reflected in this Agreement, or other aspects of our contract that Customer has or may bring against Copper Kettle Ranch, LLC, shall be resolved through binding arbitration in Douglas County, Colorado in accordance with the rules then in effect of the American Arbitration Association, and judgment on the award rendered may be entered in any court having jurisdiction thereof. YOU ACKNOWLEDGE THAT BY AGREEING TO ARBITRATION, YOU ARE RELINQUISHING YOUR RIGHT TO BRING AN ACTION IN COURT AND TO A JURY TRIAL. Customer agrees to indemnify, defend, and hold harmless Copper Kettle Ranch, LLC, against any claims made by third parties and all those related by this Agreement from any expenses, damages or judgments, including legal expenses and attorney's fees, resulting from such claims. Nothing in this Agreement prohibits Copper Kettle Ranch, LLC, from

bringing action in a court of law for any claim it may have, including but not limited to agister's lien and breach of contract claims, as may election, in its sole discretion, and Customer consents to the jurisdiction of the court in Arapahoe County, Colorado.

9. **Attorneys' Fees:** If any controversy, dispute, or claim arises between us concerning our fees, charges, performance of legal services, or other aspects of our representation, Copper Kettle Ranch, LLC, will be entitled to recover from Customer all costs and expenses it incurs in bringing and prosecuting or defending any litigation or arbitration, including reasonable attorneys' fees and costs, including arbitration fees and costs.
10. **Agreement:** This Agreement and any attachments constitute the entire Agreement between the parties. Any modifications or additions must be in writing and signed by all parties to this Agreement. No oral modifications will be considered part of this agreement unless reduced to writing and signed by both parties.
