## NOTE TO DEMITTING SECRETARIES

\*\*\*\*\*\*

Demits can be granted ONLY at stated meetings and the date of the Demit must be the date of the stated meeting of your Chapter at which it was granted. The petitioner's membership ceases in your Chapter and becomes effective in the new Chapter on that date.

## SPECIAL INSTRUCTIONS

- Be sure that applicant holds an official receipt for dues for the current year, issued by a regular Chapter chartered by the Grand Chapter of Tennessee.
- This application should be handled exactly like a petition for the Degrees. Unanimous ballot is required for election.
- 3. Send no notice or inquiry to the other chapter until AFTER the ballot is spread. If elected, complete the NOTICE OF ELECTION AND REQUEST FOR DEMIT, detach the lower half of the form and mail to the Secretary of the other chapter. Addresses of Tennessee Chapter Secretaries will be found in the Proceedings, if address of out of state Secretary cannot be ascertained from applicant, mail the Grand Secretary, and she will forward to the proper address. If the petition is rejected notify the applicant but do NOT NOTIFY THE OTHER CHAPTER, as membership remains therein. Do not return the petition to applicant; file it with your records.
- IMPORTANT. Do not enroll the applicant as a member of your Chapter, until – Demit is received, then ENROLL MEMBER AS OF THE DATE APPEARING ON THE DEMIT, NOT THE DATE MEMBER WAS ELECTED BY THE CHAPTER.
