President Bob Bagshaw called the regular Board meeting to order at 6:09 pm on Zoom.

A quorum of five was met.

Minutes for November – Hollyfield – The January Minutes were approved as written.

Finance – Bob Stewart and Christina Rhoades –

Draft (Provisional) Budget – Stewart emphasized that he wanted the Board to have time to carefully consider four main aspects: 1) Reserve Study, 2) Budget, 3) Golf Club uncertainties, and 4) Division 14 dues. These will have an impact on the final budget.

Christina noted there were 413 lots when the turnover to professional management took place. There are 420 owners now. She is not proposing an increase in dues. The \$75/per lot is not going to be collected this time. She outlined other improvements to be made.
