

## Christians Against Abortions

The number one cause of deaths in the United States isn't heart attacks, cancer, diabetes, or car accidents – it's abortion.

Abortion is the worst evil. It's the killing of God's greatest gift – human life. Murder is the most heinous crime and sin of all, but even more so when it's the murder of a totally innocent being – a baby.

Babies are being expunged with the fallacious justification that it's a woman's reproductive right because it's her body and she can choose what to do with it, "Pro-Choice", which is really a pseudonym for "Pro-Death."

There have been approximately 50 million abortions in the U.S. since Roe v. Wade was enacted, which was a terrible decision by the Supreme Court that had no basis in the Constitution. Recently, the court reversed that decision and returned the abortion issue to the states, but that doesn't come close to eliminating abortion or reducing it substantially. There are over one million abortions annually in our country – precious little humans that would've experienced the joys of life had they not been expunged. That's a monumental tragedy. The U.S. population is declining, yet we're killing babies, which makes no sense whatsoever.

Abortion is brutal, especially partial birth abortion. One commonly used method is to insert a hypodermic needle into the baby's heart, inject poison to stop the beating and kill the baby. Ultrasound images show the babies' faces writhing with pain. Forceps are then used to tear apart the baby's body parts and remove them from the womb, the head being the hardest to pull out. Full-term babies, just born, that mothers don't want, are drowned in buckets of water or left to suffocate while the doctors and nurses watch. This is abominable and grossly evil. It's infanticide and should be prosecuted the same as a first-degree homicide. Too bad we can't ask the baby if he or she would choose to live or die in the womb. Of course, we can't, but we think that the answer unequivocally would be, "I want to live."

There's vociferous arguments over when a fetus grows sufficiently to be considered a baby. That's not the real issue. The real question is when does human life actually begin? Upon conception is the embryo dead or alive? Is it a viable human life or not? If it's dead, it would be automatically rejected from the mother's body within a few days – a miscarriage. If it's not rejected, that would imply it's alive. It must be alive because dead cells don't reproduce and grow, as an embryo does. So, without any doubt, the embryo is an active human life, God-given at the very moment of conception. It makes no difference whether it's aborted an hour, a day, a month, or six months later – it's undeniably a human life. A comprehensive study done at the University of Chicago in 2019 determined that 96% of 5,577 biologists surveyed worldwide believe that human life begins at conception. That stunning survey showed that 63% of the biologists were non-religious, 89% were liberals, and 92% were Democrats. Obviously, that survey wasn't biased towards religious conservatives.

There is nothing more precious in this world than a newborn baby, which all of those aborted fetuses would become if they weren't destroyed. When a baby is born to a mother, she has a new learning experience to love in a beautiful, nurturing, overwhelming, incredible way that she's never experienced before. Unfortunately, a mother who aborts her baby will never realize that transforming God-given love. Since two thirds of the U.S. is Christian, it's obvious that many Christian women have abortions, or support it, which is definitely contrary to Christian precepts. Statistics show that a large number of abortions are performed on Black women, who are 83% Christian. These are mainly done by Planned Parenthood, which is an abortion factory. In fact, 80% of their facilities are located in Black neighborhoods. Planned Parenthood was founded over a hundred years ago by Margaret Sanger, an avowed racist who advocated using eugenics to diminish the Black population which she thought was inferior and mentally defective, which we know is absurd.

Unfortunately, 450 million taxpayer dollars are donated to Planned Parenthood annually by our federal government, supposedly because of other services it provides women, when the big money is made from abortions. That's a gross misuse of taxpayer money and should stop immediately. That evil organization has made billions of dollars aborting mainly Black and Hispanic babies — 45% Black and 35% Hispanic. It also was the promoter of the Roe v. Wade lawsuit which legalized abortion, thus enabling it to make huge money by killing minority babies. In fact, the Black and Hispanic population would be at least double now if it wasn't for Planned Parenthood abortions. Of course, the main reason minority women seek abortions is because they can't afford the baby because they've been economically disadvantaged by the Democratic Party. Unfortunately, the minorities in the ghettos and barrios don't realize what the Democrats have done to them, currently and in the past.

The slave plantations in the old South were all owned by Democrats. The Republicans in the northern U.S. fought and died fighting the southern Democrats in the Civil War to free the slaves. In fact, it's the most important right he gives us that only he has the right to take. The Fifth Commandment says, “Thou shall not kill.” It doesn't say, “except for embryos, fetuses, and babies.” The Declaration of Independence states that we all have the “right to life, liberty and the pursuit of happiness.” So, when a woman has an abortion, it's a choice, not a right. Someone may make the choice to shoot the next-door neighbor, but it's not a right, it's a very bad choice. A woman might make the choice to commit suicide because it's her own body, but it also is not a right. In fact, it's against the law, as abortion should be. Therefore, when a woman makes the choice to have an abortion, she's choosing to cancel the right of another human

being to have life. The part of the statement “my body, my choice” that’s incorrect is “my body.” It’s not her body that she’s denying the right to life – it’s a separate body from her own. It’s a body within her body that relies on her for survival. If it was her body, she’d have two heads, four arms, four legs, two hearts, etc. In fact, the DNA of the mother is always different than the child’s DNA, so the embryo, fetus or baby can’t be part of her body. Most women will never choose to have an abortion, but because they’ve been propagandized and incited by the radical left liberals, many of them have become pro-choice. They’ve been told that they’ve been unfairly treated – that their rights as women have been violated because of abortion restrictions, making them loud and angry. Since about 85% of Americans believe in God and 64% are Christians, it’s obvious that many abortion supporters are Christians. It’s hard to understand how these people, men and women, can reconcile supporting abortion, the killing of human, God-given life, with their Christian beliefs. We’re very sure that Jesus Christ himself would condemn their choice. It seems that these people have forgotten that life is very short and we’ll all be leaving this world soon. There’s no doubt that he wants us to be merciful to the unborn.

A hundred years is but an instant, and not even that compared to eternity which never ends. God is incredible – beyond our imaginations. The creature will never fully know God, the creator, because he is ineffable. We will never fully grasp his essence, whether in this life or in the next. But we will know him to the extent of our human capacity, mainly through his Son, Jesus Christ, the second person of the Blessed Trinity who deigned to take a human form, thereby having two natures, the nature of God and the nature of man that enabled him to sacrifice himself on the cross for our sins. The universe that God created is so immense that its size is impossible to comprehend. Traveling at the speed of light (186,000 miles per second), which is seven and a half times around the world in one second, it would take 91 billion years to traverse the universe from one end to the other. Science doesn’t know what’s beyond the known universe, but we do. Of course, it’s God himself – Father, Son, and Holy Spirit. Again, that’s a concept our limited human intelligence can’t comprehend. The top executives earn \$600,000 per year and even more! Subordinate executives make \$300,000 to \$400,000 per year. Without naming the organizations, we will tell you that they are very well known. The percentage of their income that they fund for their charitable works is quite small in many cases, probably due to their expenses which include a lot of very high salaries and expensive TV ads. The charities with the lowest expenses and the highest funding were religious charities with low salaries and no TV ads. Their approach being by mail or the Internet. The TV ads which good hearted people watch that prompt them to donate are well made and we applaud those donors for their generosity, but sadly, they may be victims of exploitation. We highly recommend that before anyone donates, a thorough investigation be made online to check out the finances of the soliciting entity. Who's being paid? How much money and where does all the money go?

Currently we aren't registered as a deductible charity, which we're sure we will be shortly. In the meantime, we would appreciate contributions to our organization that we will use to help defeat abortions.

We believe that the best way to do this is to show photographs on our website of aborted fetuses and babies to stir peoples' consciences. We will also print and distribute them by mail, and other means, to the general public along with printed copies of the dialogue therein. The photos are shocking and heart wrenching, and many people will probably object to them, but we think it's important to show the devastating reality of abortion.

As Christians, we vow that the funds we receive from generous donors will not be used for our personal enrichment but will be used at minimal cost to help eliminate abortions. Our income and expense statements will be supplied to any donor upon request. Therefore, hereby pledge that the co-founders of our organization will earn no more than \$150,000 each annually, adjusted only for inflation and that other employees hired as we go will earn reasonably moderate incomes. That is fair because the laborer is worthy of his hire. However, the co-founders' income will be limited in any case to 10% of the funds donated, with a maximum being \$150,000.
