This is a great way to purchase holiday gifts for your family or friends.



# Renaissance painting class in Lake Forest!

I am a student of **Hector Hernandez** who teaches a renaissance painting class in Lake Forest (see his oil paintings below). The class is open to adults of any skill level.

**Location:** The David Adler estate. It was restored by world famous architect Adrian Smith and his wife Nancy.

Classes: 3-hour class on Mon. and Wed. 10am-1 pm or 6-9 pm

- Classes are ongoing throughout the year; you can start at any time.
- Techniques include figurative and realistic drawing, Neo-Medici Technique Mixte, and direct and indirect painting approaches.
- Hector works 1:1 with each student, and is flexible to each student's creative interests.

#### Cost:

- \$80: one, 3-hour class.
- \$576: twice a week for one month\*
- \$6480: twice a week for one year\*
  - \*Includes free studio access on Mondays and Wednesdays.
