The Trustees are pleased to present their report together with the financial statements of the Church for the year ended 31 December 2023.

Status of the Charity and Governing Document

Nairn Baptist Church is a Scottish Charitable Incorporated Organisation (Scottish Charity SC051157).

Aims and Affiliation

The principal purpose of the Church is the advancement of the Christian faith according to the principles of the Baptist denomination. The Church may also advance education and carry out other charitable purposes in the United Kingdom and/or other parts of the world. The Church is affiliated with the Baptist Union of Scotland.

TRUSTEE REPORT FOR the year 2023

LEADERSHIP CHANGES

The leadership team saw 2 changes due to established leaders stepping down in the early part of the year.

REVIEW OF THE YEAR

In 2023, the church marked the Induction and Ordination of a new minister – settling a period of training and consultation over three years. This was therefore a new season of ministry where there was also freedom from covid restrictions so the programme for the year could go ahead as planned.

During the year, we retained the overall mission statement of "Faith for today: Living and sharing the love of Jesus".

In our last report, we noted the following as key guides to our planning: -

- Prayer and the connection to witnessing to others.
- Wellbeing 23:3 (our expression of Renew Wellbeing)
- Consideration of buildings and space in the town for ministry (including Wellbeing 23:3)
- Continuing to care well for those in our fellowship in greater need.
- Developing community engagement and connections as part of our outreach in the area.

1. PRAYER AND WITNESSING TO OTHERS

At various points through the year, we had an emphasis on prayer, but we specifically supported the Trypraying initiative around Easter time and worked alongside three other churches using the same materials in order to encourage Christian unity. Trypraying is a national charity which advertises throughout various parts of Scotland and the UK. This charity produces materials to be given away and some were able to use the brand and the material in their witnessing to others.

Overall, our emphasis for outreach and evangelism continues to be via a model of individual witness to family, friends and others around us. In addition, expressing faith through care and creative ventures has brought interest from many visitors over the year. Many spoke of accessing our website and it seems it has been helpful over the year.

2. WELLBEING 23:3 (an expression of Renew Wellbeing)

Our Renew Wellbeing work continues at the United Reformed Church in Nairn and has continued to be a source of social contact and support for a number in the church people as well as a reasonable number who don't attend our church, with most being church connected but still in need of the support offered. We continue to hope that the group becomes more well known to the wider community and especially to those in greater need. In addition to remining open as much as possible each Monday to give continuity, we have done a further round of advertising and we have created a leaflet giving more information about the work and how a session runs. This has gone to local services and councillors.

We had the opportunity of running a small tent during the local Farmer's show and had a two-week period of information sharing and presence in the local library in the Autumn. We advertised in a widely distributed local magazine and have access to local NHS database. It has also been good to make contact with a professional with a remit for social prescribing and we hope to build on this. This group is one of our key ministries in connecting more widely so the hope is to remain able to offer this in the coming year. The movement also provides inspiration in our overall ethos to be a compassionate, non-judgemental and welcoming Christian community.

3. CONSIDERATION OF BUILDING SPACES IN THE TOWN

The vision has remained, to date, that we are seeking a presence on the High Street that is manageable for us and allows us to become better known and which can act as a space for our Renew Wellbeing work.

During the year, we have kept an eye on various properties and did investigate one in a little more detail but there has been nothing that has been a strong option for the church.

It is hoped that we can increase our energy on this action through this year.

4. FELLOWSHIP CARE

It has been important to us that we care well for our Church family at times of need and there has been a great deal of need through the year. Responding and supporting has been a privilege and blessing for us in our church family life. As would be expected, there are many informal networks and supports, but there has also continued to be some coordination of many small acts of kindness in giving meals at challenging times, offering necessary transport to hospital appointments, sending cards and keeping in contact with folk in various ways at points of need.

We anticipate the level of need continuing and so will continue our support. We would seek to be a people with a big heart for our own folk but also for others in the community who need support.

An enlightening and particularly interesting feature of the year was our need to adapt to the arrival of a lady who is profoundly deaf. We have been deeply enriched by this person being with us and one key method of supporting her in our Sunday services has been our use of speech to text which is then on the screen used by everyone. We recognise that there is more to be done and it is also very helpful that this lady uses text and email but we have all learned in the process.

5. DEVELOPING COMMUNITY ENGAGEMENT AND CONNECTIONS

Schools work – We have been delighted that it has been possible, since the start of 2023, to get back into Primary schools. This has been consistent for two of the Primaries that we would normally support so far and we are hopeful that the 3rd will soon have the chaplains back in.

We have also been invited back into the Secondary School – culminating in taking some assemblies around Christmas time. This is the first time in around 5 years so the group of the clergy who are involved including NBC hope to extend this work in the new year. The school have noted that they are looking for volunteering in various ways so there may be scope to do more in the Academy.

Easter – there was very positive working together by a number of churches as part of the easter celebrations which again include the very popular Easter sunrise service, led this year by the minister of NBC.

Community Centre Representation – During any year, the Community Centre hosts events for its users which is designed to demonstrate what each group offers and allows sharing of information and ideas. Our church took part in an informal discussion around the use of the building and also hosted a table giving some indication of our work and interests.

Farmer's Show – At fairly short notice, we managed to get a pitch at the local Farmer's Show and hosted a "resttent" alongside the United Reformed Church. The local reception to a joint-churches presence at the event was very positive.

Foodbank and Blythswood Shoe-Boxes – the church retains strong support for the Foodbank with direct involvement on a rota and in the giving of items. Our harvest service, in particular, was notable in giving many additional bags of food. In addition, we made up over 40 boxes for this year's Shoebox appeal.

Remembrance Services – as part of our developing profile, it was possible to be part of the planning for Armistice Day and, in the end, to lead and coordinate the war memorial service on Sunday 12th November.

Christmas season – This year, our theme was "home" and we worked towards giving out around 150 small, knitted houses as tree decorations and many painted stones with a scripture verse emphasising "Jesus as home". We had a display in the local Community Centre and in the library where people could take these small items as free gifts, and this connected to our Sunday services over the period. As a conclusion to this work, we held a concert for the charity Highland Homeless Trust and in total (along with offerings from the URC) we raised £875.

Spotlight and advertising – this year, the minister of NBC has contributed to the widely distributed Spotlight magazine, and we went further in advertising our Renew Space as well as our Christmas programme.

Drawing from having a settled minister of the church, alongside the work and connections of the whole church, we have sought to increase our visibility in the town and engage as widely as possible through the year. We have sought to address some elements of greater need in our support for missions and giving to local charities.

6. OTHER

Wider Missions - During the year, we have kept up our support for BMS World Mission and we responded early in the year – corporately – to the Turkey/Syria Earthquake disaster.

Baptist Union - Our link with the Baptist Union of Scotland has remained strong with key points of connection being the Induction and Ordination services. The Minister also attended the annual Scottish Baptist Minster's conference in June.

Children/young people and younger families – This is still an area of great concern to us as we have no children or young people at present. This is a focus of our prayers, and we are engaging with another church, in particular, about this. We continue to hope that our overall style and aim to be relevant will help alongside the further work in schools into the coming year. We seek to be ready each week to receive children and we have a safeguarding officer who oversees recruitment and the PVG process.

Website/technical – we seek to use as fairly modern methods, including some streaming/recording in our services and it has been good that our technical team has been strengthened a little bit through the year. This is, however, an area of some challenge for us and it would always be helpful to have more help.

CONCLUSION

As we move forward into 2024, we seek to draw from our period of prayer and will continue to press into: -

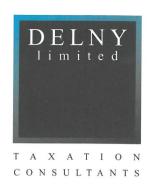
- The development of our Renew Wellbeing work by seeing a greater community connection.

- Arising from discussion at our church conference, to sustain our prayer focus within and beyond our church and to seek creativity and flexibility for our prayer initiatives.
- To continue to develop our church profile and visibility via church and minister activity (services, schools etc)
- To seek and consider models of replanting/re-starting that will help the church to see and gain experience of what change might look like
- To maintain our attention on our outward-looking schemes (charities, Blythswood, Foodbank, BMS, Farmer's Show) and ensure these are well planned.
- To focus on our energy and plan well for creative ventures eg Christmas, next Easter
