DIRECTIONS TO SHOW SITE: From I-10 (from Las Cruces or El Paso) take Vado Exit 155 for NM 277 towards Berino/Vado heading west. At the roundabout on the west side of I-10 take the second exit (west) onto NM 277 for 1.5 miles. At the stop sign, turn left onto NM 478 (south) for 700ft. Then turn right onto NM 189 (west) for 1.5 miles (you will cross the railroad tracks and the Rio Grande). At the stop sign, you will turn left onto NM 28 (south) for 2 miles. You will then turn left onto Afton Road and the destination is 0.60 miles on your left. 573 E Afton Rd, La Mesa, NM 88044.

There is limited close "in-car crating" and plenty of general parking. There will be on-site overnight parking for approximately 11 motor homes or travel trailers. There are no hook ups for RVs. Please complete the RV reservation form on Page 6 and send it to Suzanne Pindar at [radspin@yahoo.com](mailto:radspin@yahoo.com) to make a reservation. There is a fee, payable to Suzanne Pindar, of \$20 per night for trailers and RV's . There are many motels in Las Cruces, Anthony, and El Paso. You can go to the website "petswelcome.com" for more information. There are RV parks nearby if you need hook-ups. No food vendor on site. Lunch will be provided for workers.

Due to the small size of this trial, all exhibitors are encouraged to work. Please complete the volunteer form, because that way you make sure you are assigned to a job you enjoy and you get a free lunch.

The field will be available for set-up following set-up of ring on Friday, February 14. The field will not be available before 3:00 p.m. The surface is dirt). Check in is on Friday evening after ring set up. Check in time is 7:30 a.m. on Saturday, Sunday and Monday. If you check in once, you do not need to check in again. The judge's briefing and first walk-thru will begin immediately following set-up on Friday. On Saturday, Sunday and Monday the general briefing will be at 7:45am with the walk through to immediately follow. **The trial will start at 8:00 a.m. on Saturday, Sunday and Monday.**

Move ups from Friday to Saturday, Saturday to Sunday, and Sunday to Monday will be allowed. Written move up forms will be provided and all move up requests must be received by the Trial Secretary within 30 minutes of the completion of the day's last class.

Ribbons will be awarded for the first four places in each event for each height division. Green ribbons will be awarded for all qualifying scores.

Agility obstacles will include: Dog walk w/slats, A-frame w/slats (set at 5'6"), Teeter w/no slats. All contacts are rubberized. Weave poles, Non-winged jumps, Winged jumps, Open tunnels.

Anticipated Run Order (subject to change without prior notice) for each day of the trial: Friday: Regular 1&2 (EE,OO,NN); Saturday: Gamble 1 (E,O,N), Jumpers 1 & 2 (EE,OO,NN), Regular 1&2 (EE,OO,NN); Gamble 2 (E,O,N); Sunday: Gamble 1 (E,O,N), Jumpers 1&2 (EE,OO,NN), Regular 1 & 2 (EE,OO,NN), Gamble 2 (E,O,N); Monday: Gamble 1 (E,O,N), Jumpers 1 (E,O,N), Regular 1&2 (EE,OO,NN).

The **ACE program Standard Division** allows dogs 18 months or older to jump one height lower than their standard height. The **ACE Senior Dog Division** allows dogs ages 7 and older to jump 4" lower than in the ACE Standard Division. Course times in the ACE program will be 10% greater than the **Championship Division** dogs in Regular and Jumpers. Gamblers time will be the same in both programs and based on the height of the jump. Each dog and handler team can only enter either the Championship or Ace program on any one day of a trial. Once you have an ASCA Q Tracking Number, use it as your dog's "ASCA Registration Number" on all entry forms. Dogs without registration numbers will not be tracked for titles by ASCA. You may enter the trial "For Exhibition Only" (FEO), but no ribbons or placements will be awarded for FEO.</p>	<p>It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the organizing committee, be asked to leave the trial site. In such cases, no fees shall be refunded. There will be a \$30 service fee charge for any returned check. CHECKS MAY BE DEPOSITED PRIOR TO TRIAL DATE.</p>

Please specify preferred jump height.</p>	<p>A withdrawal from the trial after closing date due to an injury and/or illness <b>to a dog</b> will be eligible for a refund up to 70% of the total entry fee paid. Bitches which come in season after the closing date will be eligible for a refund up to 70% of the total entry fee paid. A veterinarian's notice of injury/illness or bitch in season will be required for a refund. <b>No refunds will be given for any amount less than \$15.</b></p>
<p>Pre-entry weekend package: all 18 runs \$210 per dog. Junior Handlers receive a 50% discount on entry fees when entered as a Junior. Day-of fees can be found on Page 5.</p>	<p>There shall be no refunds for entries in the event a dog and/or handler are dismissed from competition, regardless of the reason for such dismissal.</p>
<p><b>First dog on the line approximately 4:00 – 4:30 PM on Friday; 8:00 AM on Saturday, Sunday &amp; Monday.</b></p>	<p>All crates and exercise pens are to be set up only in designated areas. Each exhibitor is responsible for cleaning up his own setup.</p>
<p>The organizing committee may refuse any entry on the basis expressly provided through ASCA rules and regulations or guidelines established by ASCA Board of Directors. Anyone not currently in good standing with ASCA will not be allowed entry into the trial.</p>	<p>All dogs must show in the height class they entered unless measured into a higher jump height class by the judge. Dogs that measure into a higher height class will run at the end of the running order for that height class or for exhibition only in the lower height class.</p>
<p>Bitches in heat, lame or blind dogs are ineligible for entry, as is any dog with a deformity which may cause a judge to not be able to reasonably assess the dog's ability to function and perform agility obstacles safely, and in a manner that is in the best interest, health and welfare of the dog.</p>	<p>All handlers for a given class should be present at ringside at least 30 minutes prior to the start of scheduled classes for walk through and briefing. Any dog and handler not present when called shall be ineligible to run.</p>
<p>Any dog which demonstrates aggression towards any person or any dog, whether inside the ring or outside the ring must be excused from the agility trial. Any dog which the judge feels is not in enough control to perform all obstacles in a safe manner will be excused from the agility trial.</p>	<p>No alcoholic beverages or illicit substances are permitted on the trial grounds at any ZASC event. Violators will be prosecuted to the full extent of the law and barred from entry as a spectator or participant at future ZASC events.</p>
<p>No leads, collars, food, or other aids or devices shall be permitted on the course or within 10 feet of the ring entrance. The only exception to this rule is leading your dog on leash to the start, and then handing the leash to a ring steward. <b>Important Note: Toys will be allowed in the ring. Those running with toys will run as shown on the gate sheet.</b> See Chapter 9.1 in the rule book for guidelines on using toys in the ring.</p>	<p>Practicing on the equipment in the trial area is absolutely prohibited at all times, other than the use of the warm-up equipment as stipulated by ASCA guidelines governing trials. Any exhibitor practicing on the equipment will be barred from future ZASC events.</p>
<p>All dogs must be on leash when not competing in the ring, and must be contained unless being prepared to run.</p>	<p>Any dog that fouls the ring more than once will be excused from the remainder of the competition for that day.</p>
<p>Safety shall always be of foremost consideration in actions and conduct by the handler at all times.</p>	<p>This trial is open to any dog at least eighteen months of age, including purebred and non-purebred.</p>
<p>No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, acts of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.</p>	<p>NOTE – dogs not jumping in the 20"+ / 24" (16"+ veteran and juniors, ACE 16"+, ACE Sr. Dog 12"+) will require proof of measurement (ASCA/AKC/NADAC height card) or be measured at the trial. Jump height cards previously submitted at ZASC trials will be acknowledged.</p>

The Management will not be responsible for the loss or damage to any dog exhibited, or for possessions of any exhibitor whether the result of accident or any other cause. It is distinctly understood that every dog at this event is in the care and custody and control of his owner or handler during the entire time dog is on the premises.

**AGREEMENT**

**IMPORTANT LEGAL AGREEMENT**—Please read the following carefully as it, among other things, may prevent you from suing ASCA® and persons/entities affiliated with it. This agreement could even require you to defend them from demands and suits by third parties that include an assertion of wrongdoing by you. (1) The person signing this Agreement represents being authorized to enter into it on behalf of him/herself, as well as (if different) the owner(s)/exhibitor(s)/handler(s) of the dog(s) for which an entry form is being submitted (all these parties collectively referred to herein as “Applicant”). (2) “Releasees” here collectively refers to the Australian Shepherd Club of America® (ASCA®); its affiliate clubs; and the officers and board of directors, staff, contractors, insurers, attorneys, and agents of ASCA® and of those clubs. (3) This Agreement voluntarily is entered into by Applicant in exchange for the acceptance of the associated entry form and permission to participate in related activities. (4) Applicant agrees to abide by the rules and regulations of ASCA® and any other rules and regulations applicable to this event. (5) Applicant certifies that the entered dog will not pose a hazard to people, property, stock animals, or other dogs, and further that the dog is current with rabies shots along with any other vaccinations required by its state of residence. (6) Applicant acknowledges and assumes the risks to Applicant and Applicant’s dog associated with participation in the event, among which could be ones associated with poor condition of the facilities and surrounding areas; security measures or lack of them; electrical appliances; fittings; show rings; the presence of unfamiliar persons; and the presence/involvement of other animals—whether stock, dogs, or otherwise. (7) Applicant further agrees to comply with all recommended and required health and safety precautions, among which may be those related to social distancing; quarantining; wearing of face coverings; and non-participation of persons exhibiting symptoms or for whom there otherwise has been a likelihood of recent exposure to COVID-19 or other contagious diseases. (8) Applicant additionally acknowledges and agrees to assume the risks associated with taking part in the event though others might neglect compliance with health and safety precautions/requirements or pose an undue risk of spreading disease. For example, as is true as to any public event, there is some risk that Applicant and/or those affiliated with Applicant may catch COVID-19 or another contagious disease at the event. (9) To the maximum extent permissible, this release is to be interpreted under Texas law, without application of its choice of law rules. (10) To the extent that Applicant—or another party suing on behalf of Applicant, or suing to recover based on injuries/death/damage to Applicant/Applicant’s dog/Applicant’s property—sues ASCA® (or a board member or staff member or agent of ASCA®) as a defendant, the sole appropriate forum (to the maximum extent permitted by law) for the suit shall be the state or federal courts serving Brazoria County, Texas (where ASCA® has its headquarters). (11) Applicant hereby releases and waives any claims Applicant otherwise might assert against the Releasees as to any injury or damage claim connected in any way to any alleged act or omission arising out of, or occurring concurrent with, the event and related activities, interactions, communications, and even adjacent premises. (12) This release is made not only as to Applicant but also for anyone who might assert a claim on behalf of Applicant or based on purported injury or damage to Applicant/Applicant’s dog/Applicant’s property, as well as any heir, beneficiary, assignee, executor, trustee, agent, or survivor of Applicant. (13) Applicant further agrees to assume sole responsibility for and indemnify and hold Releasees harmless from related claims, demands, judgments, and settlement payments. (14) These waiver, release, and indemnification provisions extend even to claims or demands asserting that the acts or omissions resulted in bodily injury or death or from intentional wrongdoing, as well as to attorney fees and other costs of defense. (15) The duties of indemnification further extend to any claims or demands asserted against Releasees that are alleged to have arisen out of the acts or omissions of Applicant, Applicant’s dog, or others affiliated with Applicant. Among other things, this means that Applicant would pay the legal defense of Releasees if someone sued them based on a claim Applicant carelessly exposed the claimant to COVID-19. (16) Applicant’s promises in this agreement apply without regard to the type of claim or cause of action asserted against Releasees. (17) To the extent any provision of this agreement is unenforceable, the remainder of it nonetheless is to be enforced. (18) This agreement is to be interpreted to provide Releasees with the maximum permissible legal protection from—among other things—claims and suits pursued by Applicant (and/or those acting on behalf of Applicant or over injury/damage to Applicant), as well as from ones based on the purported wrongful acts or omissions of Applicant. (19) Nothing in this Agreement requires you to indemnify Releasees from claims by third parties that involve no allegations of improper acts or omissions by you, those affiliated with you, nor your dog(s). (20) Applicant acknowledges having read, understood, and had the opportunity for independent legal review of this document prior to signing it.

### What is the total cost for a QT number?

Membership fee is in addition to the QT number fee of **\$20 per dog**.

**The QT number for the dog will not expire.** If the owner is not a current service member, the total cost for one dog plus one owner's membership is **\$40**. QT Numbers for two dogs with one owner's membership would be a total of **\$60**. A QT Number for one dog plus two owners' memberships would be a total of **\$60**. (This is assuming no owners are current members or under 18).

### Do I have to have a QT number to compete?

- You do not need a QT number to compete in ASCA Agility, Stockdog or Dock Jumping events, unless you want to earn ASCA title certificates.
- You must have a QT number to compete in ASCA Obedience, Rally and Tracking Tests.

### Why would I need or want a QT number for my dog?

To have ASCA keep track of your scores and receive title certificates for your accomplishments.
