

Organizational Challenges

Industries, especially trades, are reporting staffing challenges and an aging workforce.

Aqua's goal to enhance workforce diversity to better reflect our communities:

- State goal 17% by 2025
- Current Ohio workforce diversity = 10.4%

Bottom Line = There are fewer qualified workers and this complicates the recruitment of the shrinking number of qualified, representatives of minority groups that are vital to reaching our diversity goals.

Develop an internal apprenticeship program to educate, grow, evaluate and hire a more diverse workforce and encourage them to establish a career in the water / wastewater industry.

Program requirements:

- At least 18 years old in 2023
- High school graduate or complete GED
- Good attendance record & 2.0 GPA
- Complete application
- Letter of recommendation
- Completion of 6-month apprenticeship program

Program offerings:

- Real-world hands-on, safety-first experience
- \$16/hour and first-in-line to fill \$26/hour positions at program completion
- All necessary tools and personal protective equipment
- Certificate of completion that demonstrates your achievement in field services
