Essential Functions:

Under the direction of the Chief Operator, the Wastewater Operator is responsible for the day-to-day operation and maintenance of a regional treatment facility. Major duties may include crew leading, maintenance, inspection, operating equipment, sampling, reporting, and other duties as required.

Required Qualifications:

Must hold an OEPA Class I Operator - Wastewater Works license for A-24; Must have a valid Ohio driver's license and a high school education or the equivalent thereof.

Physical Requirements:

Must have the ability to perform laborious tasks associated with wastewater and package plant operations. These tasks include: scrubbing, painting, shoveling, raking, heavy lifting, climbing ladders, working at heights, entering confined spaces, etc.

Hours of Work and Location:

The employees of the Wastewater Operations Section can be assigned to a schedule that includes shift work and a regular work-week that might include a Saturday and/or a Sunday.
