WATER TECHNICIAN REPAIRER

PUBLIC WORKS DEPARTMENT

DUTIES & REQUIREMENTS:

The city of Oakwood is currently accepting applications for *Water Technician Repairer* in the Public Works Department. Primary responsibilities include performing varied manual and semi-skilled maintenance and equipment operations duties involving flushing and otherwise cleaning sewers, and in repairing manholes and sewer lines.

The Water Technician Repairer also builds, cleans, and unclogs catch basins; assists in such tasks as laying and repairing sewer and water lines; rebuilds storm sewer inlets, lines, and sanitary sewer manholes; repairs water main line and service breaks. The position instructs General Service Workers in the causes of sewer line stoppages and proper cleaning and remedial procedures; locates and marks utilities; digs ditches, hoists materials, tools, equipment, and any related work with a backhoe.

As part of the Public Works team, the Water Technician Repairer removes snow and ice from roadways and walkways; collects limbs and debris on streets.

The position will act as a back-up to the Water Plant Technician on a limited basis, which includes responsibilities such as routine inspection, maintenance and repair of water plant equipment and facilities, making equipment and pump adjustments as needed; collecting samples and performing water tests, maintaining daily records and logs.

Applicants must:

- have two or more years of experience in water distribution operations; and
- maintain an Ohio EPA Class I (or higher) Water Distribution Certification at time of hire: and
- have the ability to obtain an Ohio EPA Class I Water Supply Certification within twelve (12) months of hire; and
- maintain a valid driver's license and CDL, or have the ability to obtain a CDL within twelve (12) months of hire; and
- be physically capable of performing manual labor related to maintenance and repairs of the water distribution system and sanitary sewer system, be able to work/stand for extended periods, and be able to tolerate all types of weather conditions.

Please provide copies of required Ohio EPA Class I Water Distribution Certification, as well as any other additional licenses and certifications (wastewater, water supply, applicator, arborist, etc.).

Work hours are 7:30 a.m. -4:00 p.m., Monday through Friday. On occasions when the position acts as backup to the Water Plant Technician, the schedule will require 2+ hours on Saturday and Sunday for the purpose of inspecting the public water system and performing routine water testing. Additional hours may be required as circumstances warrant.

COMPENSATION:

Current pay range is \$23.88/hr. to \$30.12/hr. Entry rate is contingent upon applicant's skills, knowledge and abilities. The city of Oakwood offers an excellent benefit package, including health, dental, vision and life insurance; paid vacation; sick leave and holidays; and membership in the Ohio Public Employees Retirement System (OPERS).

High school education or equivalent, and two (2) years' experience related to water treatment operations; water distribution system maintenance; and wastewater collection system maintenance.

Ohio Class I Water Distribution Certification; a Commercial Driver's license, or the ability to obtain such within twelve (12) months of hire; ability to obtain an Ohio Class I Water Supply Certification within twelve (12) months of hire.

MINIMUM ACCEPTABLE CHARACTERISTICS: (* indicates developed after employment)

Knowledge of: principles, practices, and methods related to water treatment plant operation, water distribution systems, and wastewater collection systems; functions and servicing requirements of mechanical equipment and machinery; standards governing safe drinking water; safe and current use of hand and power tools and equipment common to work; operation of backhoes and other equipment; water distribution systems construction, maintenance, and repair; water distribution systems and components; principles and practices of maintaining and repairing public utilities, streets, and refuse operations; grounds maintenance and repair.

Skill in: plumbing, pipefitting, soldering, motor equipment operation, snowplow operation; use or operation of maintenance and grounds keeping tools;

Ability to: read, interpret, and work from written and oral instructions governing operating procedures and laboratory routines; perform the operation and maintenance requirements of plant pumping, treatment, and control equipment; read meters, charts, and gauges accurately and to maintain required records; perform standard arithmetic calculations quickly and accurately; establish and maintain effective working relationships with others; climb stairways and ladders and bend to take water samples; visually detect problems; perform water plant maintenance activities; maintain mental alertness when reading, measuring, and treating water in compliance with standards; operate and control power tools; work outdoors in all types of extreme weather conditions; work alone; obtain laboratory certification; perform heavy manual labor for extended periods of time; travel to and gain access to work site; establish and maintain effective working relationships; climb up onto and operate equipment; observe and control materials being moved while operating equipment; hear obstacles as they are encountered by equipment and redirect equipment; load and unload materials; lift heavy objects; stand and sit for extended periods of time; work outdoors in a variety of extreme weather conditions; use peripheral vision in avoiding hazards; judge distances effectively while operating equipment.

ESSENTIAL FUNCTIONS OF THE POSITION: For purposes of 42 USC 12101:

- 30% (1) Performs varied manual and semi-skilled maintenance and equipment operations duties involving flushing and otherwise cleaning sewers and in repairing manholes and sewer lines; builds, cleans, and unclogs catch basins; assists in such tasks as laying and repairing sewer and water lines; rebuilds storm sewer inlets, lines, and sanitary sewer manholes; repairs water main line and service breaks; instructs general service workers in the causes of sewer line stoppages and proper cleaning and remedial procedures; locates and marks utilities.
- 30% (2) Digs ditches, hoists materials, tools, equipment, and any related work with a backhoe.
- 10% (3) Flushes, pumps, paints, repairs, and extends fire hydrants; assists in making street cuts and blacktop patches; repairs guardrails and traffic sign poles and replaces, sets, and troubleshoots water meters; assists in determining the location of water and sewer lines prior to excavation;
- 10% (4) Assists in maintaining water distribution system; installs water service taps and valves, fire hydrants; flushes and services fire hydrants.
- 5% (5) Performs a variety of public works maintenance activities; cleans assigned water plant areas and equipment and performs equipment maintenance, repair, and installation work; reports malfunctions of equipment; assists Water Plant Technician and other public works employees with projects and routine maintenance; acts as back-up to Water Plant Technician.
- 5% (6) Monitors and inspects water plants and equipment to determine operating condition; checks levels and ensures that chemical feeders are on-line; monitors machines and carries out preventive maintenance; adjusts pumps and other equipment to meet operating requirements; monitors production, transmission, storage levels, system pressure, and treatment processes; makes adjustments to meet demand; maintains operating log; performs backwash on filters; collects samples from designated sources and performs standardized tests for hardness and chlorine; maintains daily records of test results; inspects water tower.
- 5% (7) Insures the proper maintenance of equipment and tools by cleaning and checking equipment and tools after use; inventories tools and reports any lost or broken tools to the immediate supervisor.
- 5% (8) Removes ice and snow from roadways, driveways, and walkways; collects tree limbs and debris on streets.
 - (9) Meets all job safety requirements and all applicable OSHA safety standards that pertain to essential functions.
 - (10) Demonstrates regular and predictable attendance.

OTHER DUTIES AND RESPONSIBILITIES:

(11) Performs other related duties as required or assigned.

EQUIPMENT OPERATED: The following are examples only and are not intended to be all inclusive.

Backhoe, mini-excavator, sewer jet, cut-off saws, hand tools, street sweeper, dump truck, salt truck, water tapping machines, insertion valve equipment and pneumatic tools

- 11. Is exposed to possible injury as a result of working with moving mechanical parts of equipment or machines.
- 12. Is exposed to possible injury as a result of falling from high places.
- 13. Has contact with potentially violent or emotionally distraught persons.
- 14. Has exposure to potentially vicious animals.
- 15. Has exposure to life threatening situations.
- 16. Has exposure to hot, cold, wet, humid, or windy weather conditions.
- 17. Has exposure to hazardous driving conditions.
- 18. Has exposure to shaking objects or surfaces.
- 19. Has exposure to second-hand smoke.
