Summary of Responsibilities:

Provides skilled labor and technical expertise in the operation, installation, maintenance, repair and replacement of water mains, hydrants, valves, meters, and other related infrastructure on the water distribution system.

Essential Functions:

- Leading role with installation of new water services/taps, water mains, water pipes, meters and valves.
- Repair and maintain hydrants, meters and ruptured water lines as needed.
- Aid in landscape restoration work.
- Operate various types of equipment and vehicles including light-duty trucks and tractors with mowers.
- Clean and maintain equipment, tools and trucks. Ensure vehicles are stocked with proper items.
- Other duties as assigned.

Competencies and Qualifications:

Required:

- A current Ohio CDL Class A license (or ability to obtain within 12 months of hire date).
- Knowledge in the use of various hand and power tools, and motorized equipment used for general repair and maintenance work.
- Proficiency in operating heavy machinery.
- Willingness to perform manual labor in adverse weather conditions.
- A high school diploma or GED.
- A valid driver license with an acceptable driving record.

- OEPA Distribution Operator License (class I or II) or a minimum of five years of experience as a Distribution Laborer.
