Summary of Responsibilities:

Operate and control water treatment plant including machines and equipment relevant to process an adequate supply of safe, potable water to Del-Co Water customers. Assist the Plant Superintendent with plant operations and personnel issues as required.

Essential Duties:

- Properly operate and control electric motors, pumps, and valves to regulate flow of raw water into plant.
- Correctly adjust specified amounts of chemicals such as chlorine, fluoride, and lime into water or adjust automatic devices that admit specified amount of chemicals into tanks to disinfect, deodorize, and clarify water.
- Start agitators to mix chemicals and allow impurities to settle to bottom of tank.
- Pump purified water into water mains.
- Clean tanks and filter beds using backwashing at scheduled intervals.
- Manage scheduling and assist with training new and current plant Operators.
- Assist with coordinating plant operations and ensure that standard plant operations practices and procedures are being followed.
- Advise Plant Superintendent of operational and personnel issues.
- Assist with administration of plant and completion of necessary regulatory paperwork.
- Chief Operator will be expected to assist with staff supervision, delegation and be on call during an emergency.
- Assist with facility maintenance, plant cleaning and snow and ice removal as needed.

- Draw water and perform basic chemical tests: alkalinity, pH, chlorine, hardness, turbidity, and fluoride.
- Manage water quality in the distribution system, including placing and scheduling water flushing activities.
- Troubleshoot and resolve a wide variety of customer inquiries regarding water quality.
- Ensure that safe practices and safety regulations are being followed in plant.

Required Qualifications:

- A high school diploma or GED.
- Chief Operator –A current Ohio EPA Class III or Class IV Water Supply License.
- Senior Operator A current Ohio EPA Class III Water Supply License.
- Chief Operator Previous supervisory experience at a water treatment plant.
- Thorough knowledge of water chemistry, safety procedures and practices, and advance knowledge of water treatment plant operations.
- Certified by Ohio EPA for Wet Chemistry.
- Ability to work independently.
- Ability to perform manual labor and willingness to occasionally work in adverse weather conditions.
- A valid Ohio driver license and an acceptable driving record.
- Solid communication skills and willingness to answer customer questions and concerns regarding water quality.
- Any combination of training and work experience, which indicates possession of the skills, knowledge, and abilities to perform the job duties successfully.

Desired Qualifications:

- Chief Operator OSHA 30 Certification.
- Senior Operator OSHA 10 Certification.

Physical Demands:

- Regularly required to sit; use hands to finger, handle, or feel; and talk or hear.
- Frequently is required to walk and reach with hands and arms.
