The Project Manager is responsible for managing and coordinating activities related to capital improvement projects/facility renovations and for the proper operation and maintenance of the sanitary sewer collection system. The qualified candidate must understand engineering plans, specifications, contracts, and regulations associated with standard construction projects, including sanitary sewer systems. This position includes coordinating with contractors, consultants, engineers, architects, construction managers, and field inspection staff. The Project Manager will also manage project objectives, oversee quality control, and manage overall project budgets.

<u>Qualifications</u>: Possession of a bachelor's degree in engineering, architecture, construction management, or a related construction industry field AND four (4) years of managerial or supervisory experience in the construction, renovation, and/or maintenance of buildings, utilities and public infrastructure. Position Description:

Under direction of the Director, is responsible for managing and coordinating activities related to capital improvement projects, facility renovations and performs related duties as required. The Project Manager will be responsible for supervising others engaged in planning, directing, coordinating, managing, budgeting, executing and finalizing construction and maintenance projects and utility system infrastructure. The Project Manager must understand contracts, engineering plans, specifications, and regulations associated with standard construction projects, including water treatment plants, groundwater wells, and sanitary sewer systems. Construction projects may include main water distribution lines and appurtenances, sanitary sewer system piping, and building & facility construction and modifications. This job includes coordinating with contractors, consultants, engineers, architects, construction managers, and field inspection staff. The Project Manager will also manage project objectives, oversee quality control, and manage overall project budgets.

Education and Experience:

Possession of a bachelor's degree in engineering, architecture, construction management, or a related construction industry field AND four (4) years of managerial or supervisory experience in the construction, renovation, and/or maintenance of buildings, utilities and public infrastructure. An Associate's Degree and (4) years of experience may substitute for a bachelor's degree based on experience. Construction management experience within the water & wastewater construction industry is preferred.

Required Certificates, Licenses & Registrations:

Possession of a valid, State of Ohio Class I Wastewater Collection Certification, or the ability to obtain certification within 24 months. Possession of a valid motor vehicle operator's license.

Essential Duties and Responsibilities:

- Manages, plans, and coordinates the work of inspection staff, maintenance personnel, outside contractors, technical trades and maintenance personnel engaged in construction, maintenance and renovation projects
- · Manages and oversees all phases of construction, maintenance, and building renovation projects
- Prepares preliminary and final plans, bid specifications, and cost estimates for construction, maintenance, and renovation projects.
- Reviews plans for capital improvement projects
- Administers contracts and prepares contract modifications as necessary
- Develops cost projections for future capital and facility projects; meets with design professionals and contractors to discuss project goals and projected costs
- Maintains plans, shop drawings, and contract change orders for all new construction and renovation projects
- Assists engineers, architects, contractors, and other managerial or supervisory personnel with developing timelines and providing quality services
- Participates in contract negotiations related to construction projects
- Coordinates capital improvement project activities with other internal and external departments
- · Acts as a liaison between engineers, architects, design professionals, contractors, and stakeholders
- Inspects job sites and review construction progress reports to ensure conformity to specifications and timetables
- Maintains records and prepares reports as necessary
- Explains and interprets governmental regulations, policies and procedures to the general public and personnel
- Participates in the on-call rotation for emergency responses.
- · Performs all other duties as assigned

Knowledge, Skills and Abilities:

- Considerable knowledge of various building and maintenance methods, tools, and materials
- General knowledge of construction drawings and plans
- · General knowledge of bid specifications and cost estimates relating to construction and renovation projects
- · General knowledge of safety principles and practices associated with the construction and maintenance fields
- Some knowledge of contracts and contract administration
- Ability to compute time estimates and material costs
- Ability to read an interpret construction plans and specifications
- Ability to manage, plan and coordinate large-scale work projects
- Ability to operate a computer and related software
- Ability to communicate effectively orally and in writing
- · Ability to develop and maintain effective working relationships with employees, the public, the Board, and other parties
- Ability to prepare reports and maintain records
