JWSD provides water and sanitary sewer services to more than 4,000 customers located within Jefferson Township, Ohio and performs water and sanitary sewer utility inspection services for new developments, system improvements, and utility extensions within the district service area.

The Seasonal Inspector is responsible for overseeing the construction of water and sewer lines in the District and performs other related duties as required. This position is seasonal, and employment occurs between May and October. Work hours will generally occur between 7:30am-4:00pm but may vary based on construction activities and the amount of construction occurring on specific projects. Work will only be performed when contractors are working, and inspection services are necessary. Days where no construction occurs (rain days, etc) will not require this employee to work.

### **Position Description:**

Under general supervision, is responsible for overseeing the construction of water and sewer lines in the District and performs other related duties as required. This position is seasonal, and employment occurs between May and October. ### **Education and Experience:**

High School Diploma or GED and one (1) year of experience in the construction, inspection, or field testing of materials in the construction or repair of hard infrastructure (e.g., manholes or anything related to sewer or water installation).

### Required Certificates, Licenses & Registrations:

Possession of a valid motor vehicle operator's license.

## **Essential Duties and Responsibilities:**

- Has the ability to read and interpret District construction and material specifications, standard drawings, and construction plans to ensure that construction procedures and materials comply with specifications.
- Inspects and oversees the installation of water and sanitary sewer lines under the supervision of the District superintendent.
- Tracks quantities of materials received or used during specified construction activities.
- Maintains a daily log of construction and inspection activities and prepares construction progress reports.
- May recommend changes in location and placement of water lines due to existing conditions; performs hydrostatic testing of new water lines.
- Prepares descriptions of water lines after installation; draws up survey plans and water line layouts.
- Must be able to work with contractors, residents and others related to the projects.
- Provide progress updates to the superintendent of all construction activities.
- Performs all other duties as assigned.

# Knowledge, Skills and Abilities:

- General knowledge of the District Code of Regulations pertaining to water and sanitary sewer service.
- General knowledge of the techniques, tools and materials used in repairing water lines; general knowledge of plumbing; some knowledge of hydraulics.
- Ability to read and interpret manuals, graphs, charts, and construction plans.
- Ability to write descriptive sentences; ability to speak tactfully with contractors and the public.
- Ability to operate computer systems.
- Ability to add, subtract, multiply and divide decimals and units of measure.

# **Physical Activities and Environment:**

The physical activities described are a representation of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions and expectations.

While performing the functions of this job, the employee is continuously required to talk or hear; frequently required to sit; and occasionally required to stand, walk, use hands to finger, handle or feel, reach with hands or arms, and climb stairs.
