- Effective November 1, 2018
- Specifies responses any time distribution pressure goes below 20 PSI
- Transient (TNC) and Non transient non community (NTNC) serving <1000 shall provide bottled water or the equivalent



All community and non transient non notification provisions must follow the event response and community systems serving 1000 or greater



- During an event systems must monitor line repairs pressure upstream and downstream of water
- Pressure monitored by in-line pressure elevated storage tanks, towers or other monitors, hydrant pressure recorders, Director approved methods



TYPE 1 Event – controlled pipe repair, positive pressure maintained and no sign of contamination intrusion.



TYPE 1 Event Response

- Excavate below the repair
- Maintain pit water level below the repair
- Disinfect in accordance with AWWA C651
- Repair under positive pressure
- After repair verify disinfectant presence
- Document steps taken
- No boil advisory
- No Coliform Sampling necessary
- If all steps not followed the event is elevated to Iype 2



TYPE 1 Reporting Requirements

- No notification to Ohio EPA is required provided the event response items are followed
- An after action report must be maintained by the facility





Type 2 Event – controlled pipe repair, contamination. Water line replacement can be completed and no signs of controlled shutdown of the affected area does not exceed one full section of pipe. positive pressure maintained until a



Type 2 Event Response

- Excavate to below the repair
- Maintain pit water level below the repair
- Affected critical customers notified
- Perform controlled shut down
- Repair the water line
- Disinfect affected area in accordance with C651



Type 2 Event Response (Continued)

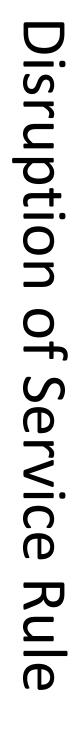
- Flush lines in accordance with C651
- Verify disinfectant presence
- Document activities
- No boil advisory
- No coliform samples
- Move to Type 3 if process not followed



TYPE 2 Reporting Requirements

- No notification to Ohio EPA is required provided the event response items are followed
- An after action report should be maintained by the facility





Type 3 Event – loss of pressure at the signs of possible contamination intrusion repair site, localized depressurization near repair, an uncontrolled shut down or



Type 3 Event Response

- Activate the notification procedures in the system's contingency plan
- Document possible contamination
- Issue precautionary boil advisory
- Disinfect, repair and flush in accordance with C651
- Test for chlorine residual and comply with minimum requirement
- Move to Type 4 if event becomes a widespread disruption



Type 3 Event Response (Continued)

- After repairs, repressurization and chlorine samples verification, collect special purpose total coliform
- If samples negative for E. Coli or fecal coliform the boil advisory may be lifted
- advisory consecutive samples 24 hrs apart to lift the advisory stays in effect and need If samples positive for E. Coli or fecal coliform



Type 3 Reporting Requirements

- If the disruption affects 10 percent of a systems Ohio EPA hotline (after hours) is least, notify the appropriate District office or customers or 100 service connections whichever
- Must speak with a person at Ohio EPA
- Document activities in writing. Submit after action report to Ohio EPA w/in 48 hrs



Type 4 Event – Catastrophic failure, contamination intrusion widespread depressurization or actual



Type 4 Event Response

- Activate notification process in contingency plan
- Document contamination
- Consult with Ohio EPA
- Issue boil advisory or "Do Not Drink" advisory
- Disinfect, repair and flush in accordance with C651
- Test for chlorine residual and comply with minimum requirement

Type 4 Event Response (Continued)

- After repairs, repressurization and chlorine samples verification, collect special purpose total coliform
- If samples negative for E. Coli or fecal coliform the boil advisory may be lifted
- If samples positive for E. Coli or fecal coliform advisory consecutive samples 24 hrs apart to lift the advisory stays in effect and need



Type 4 Reporting Requirements

- Document activities in writing. Submit after action report to Ohio EPA w/in 48 hrs

New Operator Certification Rules

- Effective August 15, 2018
- Congratulations you are all now considered professional operators
- New definition of operating experience beginning on August 15, 2019
- Minimum Staffing requirements for distribution systems.
- Reporting of minimum staffing on eDWR



New Operator Certification Rules

- Requirement for electronic submission of that expire December 31, 2018 renewal applications beginning with certificates
- Moving official due date for renewals to November 30 of the expiration year.
- Reducing grace period from 1 year to 6 months.



New Operator Certification Rules

- Certify that Ohio EPA Certification Course has been reviewed for all applications
- 3745-7-21 (Contract Operator Rule)
- Require Director approval for all contract operators and contract operation companies
- Spells out requirements for contract operations companies
- Provisions for preventing companies or operators

from acting as contract operators
