Nature of Work:

Performs a variety of skilled and semi-skilled tasks in maintenance work, and operates equipment in the construction, operation, repair, and maintenance of our village utility plants and system as Operator of Responsible Charge.

Required Training and Experience:

- Preferred: High School diploma or GED equivalent
- Possession of or ability to obtain and maintain a valid State Driver's License
- Skill in operation of motorized vehicles and equipment such as dump truck, pickup truck, mowers, snowplow, tractor, street sweeper, tamper, plate compactor, saws, common hand tools, shovels, wrenches, mobile radio, phone
- > OEPA class 1 water operator license
- ➤ OEPA class 2 wastewater operator license
- > Ability to read and interpret basic maps and blueprints
- > Ability to communicate effectively both verbally and in writing
- ➤ Ability to understand and carry out written and oral instructions
- Ability to establish and maintain effective working relationships with employees, other departments, and the public

Physical Demands

- The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job in compliance with the American with Disabilities Act (ADA) requirements.

- ➤ Will work in class 2 wastewater plant and class 1 water plant as ORC
- Contact residents and business owners in area where service interruptions will impact them and represents the Village in a positive manner in these situations
- Ensure the proper maintenance of equipment and tools by cleaning and checking equipment and tools after use
- Perform routine inspections and preventive maintenance on assigned equipment and report defects or needed repairs to Village Administrator
- > Perform all duties in conformance to appropriate safety and security standards
- Prepare and submit reports and correspond with regulatory agencies
- ➤ Read and install radio-read water meters
- Assist in inspections of laterals and service connections
- Other duties as assigned

Schedule and Compensation

- Regular work schedule will be 7am to 3 pm, Monday through Friday and 2-hour plant checks every other weekend
- ➤ The Village offers a competitive compensation package, with insurance available.
