Daycare Policies

1. All day care dogs must complete a temperament evaluation. TRW reserves the right to refuse, or reject any dog that might be a safety hazard to one self, other dogs in our care, or staff members. This includes but is not limited to: dogs who are aggressive, anti-social, object or people aggressive, anxious, and physically ill. All dogs must be at least four months old and have all vaccines up to date.
2. All dogs must have current vaccinations against, Rabies, Bordetella, and DHLPP. Your dog will not be admitted into TRW without proof of all vaccines given by a veterinarian prior to appointment.
3. All dogs are required to have flea protection. Your dog must be on a form of flea control. No dogs with fleas will be permitted.
4. All dogs must be on heartworm preventative.
5. Payment is expected at the time service is rendered. We accept cash, check, Visa, MasterCard, American Express and Discover.
6. Any dog still in daycare at 6:15 will be moved to our boarding facility next door for the night at the owner's expense.
7. TRW is not responsible for injuries or disease that may occur or develop while your dog is at Daycare.
