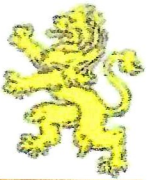

The Recording Secretary read the minutes from the May meeting. There were no additions or corrections, and the Minutes were accepted as read.

The Corresponding Secretary reported the completion of the By-Laws updates and rewrite. Copies were presented to the Board Members for review. The specific change was related to granting full membership to Associate members. That by-law change passed a member vote at the September, 2024 meeting. A motion to accept the report and the By-Laws updates was passed.

Old Business: A discussion began about the 2027 Reunion, whether to have the Reunion at the Ramada Hotel, another Hotel venue, or book a group Reunion Cruise for 2027. Members discussed the cruise for having one price per person covering all Reunion Cruise expenses which would be handled by a

cruise planner. However, ship cruising dates and times, port locations and transportation could be a problem. Attendees who play golf would be left out. Hotels with hospitality rooms around the Kissimmee, Orlando area are restrictive, regarding alcohol and catering brought into the hotels. Therefore, the members present agreed to have the Reunion at the Ramada for 2027.

New Business: Arrangements have been made with the Ramada Hotel, Kissimmee, Florida to have a Reunion January 28, 2027 to January 30, 2027. The original Hospitality Room used at the first Nassau Blue Reunion has been booked. The location is on the 2nd floor (walk up) at the back of the pool area. It has been updated and renovated. Discounted room rates have been secured at the hotel. More information is forthcoming. Also, we will be celebrating the 55 year Police Academy classes from 1972.
