**Private Mooring Licence Terms & Conditions (Mooring number prefixed with "BP")**

The Mooring Licence will be granted for a period from 01 April to 31 March of the following year. The terms of the Mooring Licence ('the Mooring Licence') are as follows:

1. Subject to payment in advance of the annual Licence fee prescribed by **The Manor of Bosham and the Hundred Limited (TMOB)**, which will match the **Chichester Harbour Conservancy (CHC)** prices for Private Mooring Site Licences, the Licensee shall be entitled to lay down and maintain the approved mooring of the specified Class and Category, on the site indicated on a plan available for inspection at the Quay Office, Bosham or the CHC Office, Itchenor.
2. The Licensee shall pay the Site Licence fee by the 28th February preceding the Licence period.
- 3. The Mooring License is personal to the Licensee and is not transferable.**
4. The Licensee shall ensure that the full mooring number is clearly displayed on the mooring buoy in letters and numbers of no less than 5 centimetres in height. The mooring number must be prefixed with BP and end with the category ie B3 or B4. Any mooring not displaying this number will be deemed to be unlicensed and will be removed.
5. The Licensee must supply TMOB with the details of the vessel using the mooring and the Licensee must be the owner of that vessel and registered as such with CHC. TMOB reserves the right to require further proof of ownership of vessel.
6. The Licensee must maintain insurance for the vessel using the mooring, throughout the Licence period, against third party claims for at least the minimum sum recommended by leading Marine Insurers and evidence this to TMOB on request.
7. The measurement of the length of the vessel using a mooring is to include all protruding fittings, e.g. bowsprits, bow-rollers, pulpits, davits, bathing platforms or raised outboard engines and must be within the length limit of the mooring category. For "B3" category the maximum vessel length is 9 metres. For "B4" category the maximum vessel length is 6 metres.
8. TMOB reserves the right not to permit vessels to use the mooring which might cause damage to the vessels on adjacent moorings.
9. The Licensee must obtain, in advance, the approval of TMOB to change the vessel using the mooring.
10. TMOB will not be liable for any claim whatsoever arising out of or in connection with this Licence.
11. The Licensee, during the continuance of this License, must keep the mooring in a good and safe state of repair to the satisfaction of TMOB. All mooring tackle is to be inspected annually by the Licensee and replaced as necessary. Mooring buoys are to be clearly visible.
12. Any contractor engaged by the Licensee to maintain the mooring must first register with TMOB and operate in accordance with all legal requirements and adhere to a safety management system.
13. The Licensee is responsible for ensuring that the vessel using the mooring, for which these conditions apply, is in a seaworthy and safe condition, to the satisfaction of TMOB.
14. The Licensee is responsible for the safety of their vessel using the mooring. Should the vessel ground at low tide, it should do so safely and without hindrance to other vessels.
15. The Licensee shall comply with all lawful and reasonable requests made by TMOB or CHC concerning the specification of the mooring tackle and the method of laying and siting the mooring.
16. In the event of non-compliance with any of these conditions this license shall be terminated forthwith.
17. No refund of fees will be given.
18. Payment of the license fee acknowledges compliance with all of the terms & conditions of this agreement.
