- \* Broke story on President Jimmy Carter's admission U.S. Iranian hostages were relocated. May 9, 1980.
- \* Is the last known U.S. public officeholder to have been burned in effigy in St. Denis, France November 30, 2006 regarding Mumia Abu-Jamal, according to Betsey Piette, "Support in France stays strong for Mumia Abu-Jamal" *Worker's World* (Dec. 7, 2006).
- \* Holds world record for being oldest person, at age 59, to compete in his very first sanctioned wrestling bout. U.S. Veterans National April 17, 2014, having never wrestled in school or college.

- \* Became first person to be terminally ill to win a non-Paralympic national championship at May 20, 2017 at USA Wrestling Beach Wrestling Championships, Carolina Beach, NC.
- \* Rank 18th (11 points) in USA Wrestling's 2017 Master Ironman (age 35+) Standings (Nov. 2017) ranking behind 67 competitors and ahead of 115 competitors.
