PHS Granted 501(c)(3) Tax Exempt Status by IRS

Last month the Polish
Heritage Society of Grand
Rapids was notified by the
federal Internal Revenue
Service that the
organization has been
granted tax exempt status,
so donors can now deduct
contributions on their
federal taxes and the
organization can receive
tax deductible gifts and
bequests.

"Getting our 501(c)(3) designation is a huge win for the PHS," President Adam Porczynski said. "This is laying the foundation for the society to approach larger corporations and organizations that have

expressed interest in supporting our mission, but also have required us to be tax exempt."

Porczynski said he received a letter from the federal Internal Revenue Service in June that stated the PHS now is considered tax exempt, effective January 6 of this year. In addition, the PHS may be exempt from paying state income, sales and employment taxes, enjoy reduced postal rates, and receive taxexempt financing. The PHS relies on volunteers to operate and does not have any employees.

He said local attorney Martin Rogalski, former PHS president Marilyn Lignell and others worked diligently for about 18 months to obtain the 501 (c)(3) designation. The finished document submitted to the IRS was nearly ½-inch thick of pages detailing the mission, (See page 2)

Matka Boska: Our Lady of the Greens

(from Page 1) St. Isidore Catholic Church at 625 Spring Ave NE, announced last month that the service and ceremony celebrating the Assumption of Mary will take place 7 p.m. at his church, with appropriate measures being taken to protect participants from contracting COVID.

Hankiewicz said the service will maintain the hallmarks that has made it a traditional favorite for local Catholics: a Mass with a blessing of flowers and herbs, music sung in Polish, and a procession to and crowning of a statue of the Virgin Mary in the church courtyard. Last year more than 200 people attended Matka Boska Zielna and a reception with refreshments that followed the service.

In Poland, it is celebrated at the Feast of Our Lady of Greens, where herbs are blessed and then woven into wreaths that are hung near holy pictures and used as medicinal recipes as protection against illness and natural disasters.

Participants at this year's service are expected to wear face masks, and there will be social distancing in the pews. The crowning of the statue of Mary will take place, but unfortunately

there will not be a reception due to the logistics of gathering so many people in an enclosed area.

The Polish Heritage Society is an active sponsor of the celebration, providing flowers, herbs and the woven crown for Mary and refreshments at the reception. In past years, the Pulaski Queen and her Court and the Malbork Dance Ensemble of Grand Rapids have attended.

(From Page 1) "This is particularly true for photos and other documents that the next generations may not be able to identify, read, or place in historical context -- especially if they

are discovered after the fact," she said.

The PAHA has put out a national appeal to families to provide "memoirs, diaries, letters, interviews, and photos" that document the experience of post war Polish immigrants. The project is in collaboration with Central Connecticut State University's Library and the Polish American Librarians' Association.

With the new designation comes new reporting responsibilities and obligations for the PHS, Porczynski said. The society must file annual returns with the IRS for tax exempt organizations at the end of the calendar year, keep ongoing accurate and detailed records of transactions for itself and its donors, and meet disclosure requirements.

The society has formed a committee with Porczynski,

Director Michael Jasperse and 2nd Vice President Anthony Zasuwa to assess accounting software programs and local services to meet the new requirements.

"It's going to take some effort, to maintain our tax exempt status but it really is worth it," Porczynski said. "We hope to use the new tax status to expand our educational programs on the influence that the Polish and Lithuanian cultures have had on West Michigan."




Walt and Penny
