If issued equipment and/or uniform is not returned within prescribed time frame or returned in poor condition (as determined by Shively Seminole); I, the signor will pay the full cost to replace the issued equipment and/or uniform as outlined in the following fee schedule. **Helmet \$135.00 Shoulder Pads \$100.00** I, the signor, further realize that Shively Seminole will exercise all rights prescribed by law against me, the signor, to retrieve above said issued equipment and uniform or seek monetary value outlined above to replace the missing and/or damaged issued equipment and uniform. I, the signor, further understand that signing this agreement is accepting full responsibility of outlined. I, the signor, also understand that any money contributed or paid to Shively Seminole is non-refundable or will not be returned due to my child not playing the season and that any equipment and uniforms issued are required to be returned or paid for in full as prescribed in the fee schedule above. I, the signor, attest all my contact and identifying information listed above is true and accurate.

If Shively Seminole has to take any action to recover said equipment and uniform, I understand that I will be responsible for all legal and administrative fees associated with Shively Seminole retrieving equipment and uniform and/or the monetary value (listed above) of all items.
