## Vendor Terms & Conditions 2026

### 1. Event Overview

The **Peninsula Home & Lifestyle Expo** will take place on:

**Dates:** August 1-2, 2026

**Location:** Wiarton Arena & Community Centre, Wiarton, ON

**Part of:** Wiarton Homecoming Weekend

This curated event features a limited number of vendors per category, ensuring a diverse and high-quality experience for attendees. All vendor applications are subject to approval by the event committee.

---

### 2. Application & Approval Process

- Vendors must [complete and submit](#) the official Vendor Application Form.
- Applications are reviewed by our selection committee to ensure a balanced mix of vendors. Approval is based on product/service quality, category availability, and overall fit for the expo.
- Submitting an application does not guarantee acceptance.
- Approved vendors will receive a confirmation email and invoice for booth payment.

---

### 3. Booth Fees & Payment

- **Standard Booth (10'x10'):** \$350 After March 30, 2026 | \$300 By March 30, 2026
- **Double Booth (10'x20'):** \$500 After March 30, 2026 | \$450 By March 30, 2026
- **Outdoor Booth (10'x10'):** \$300
- **Premium Corner Showcase (Themed Room Display):** \$600 After March 30, 2026 | \$500 By March 30, 2026 (Electricity access included at no extra charge.)
- Additional options such electricity access (\$25) and featured listings are available for an extra fee.



#### **Payment Deadlines:**

- Invoice will be sent upon approval.
- Full payment is due within 30 days of invoice date.
- Failure to make payment by the deadline may result in forfeiting your booth space.

#### **Accepted Payment Methods:**

- E-transfer
- Cheque

### **4. Cancellation & Refund Policy**

- **Cancellations before May 30, 2026:** Eligible for a 50% refund.
- **Cancellations after May 30, 2026:** Non-refundable.
- If the event is canceled by organizers due to unforeseen circumstances, vendors will receive a full refund.

---

### **5. Booth Setup & Display Guidelines**

- Vendors must provide their own signage, branding materials, and any additional booth decor.
- **Set-Up Times:**
  - By appointment
  - Schedule to be released approximately 10 days prior to event.
- **Tear-Down:** August 2 after 3 PM (Early tear-down is not permitted.)
- Premium Corner Showcases should be fully styled, allowing attendees to walk through and experience the space.

#### **Electricity & Special Requests:**

- Power access is available (at an extra charge) but must be requested in advance (limited availability).
- Any special booth requests (placement, extra space, etc.) must be indicated in the application.

## 6. Vendor Responsibilities

- Vendors must staff their booth for the entire duration of the expo.
- Booths must be presented professionally and safely.
- No offensive, inappropriate, or unapproved materials may be displayed or sold.
- Vendors must follow all local health and safety regulations.

---

## 7. Marketing & Promotion

- Approved vendors will be featured on the event website and social media leading up to the expo.
- Vendors are encouraged to cross-promote the event using the official Peninsula Home & Lifestyle Expo branding.
- Vendors may contribute raffle prizes for additional brand exposure.

---

## 8. Liability & Insurance

- Vendors are responsible for their own products, equipment, and booth materials.
- The event organizers, venue, and sponsors are not liable for any lost, stolen, or damaged property.
- Vendors may be required to provide proof of liability insurance (if applicable to their industry).

---

## 9. Code of Conduct

- All vendors must conduct themselves professionally and respectfully.
- Disruptive, aggressive, or uncooperative behavior may result in removal from the event without a refund.
- The event committee reserves the right to decline any vendor that does not align with the vision and values of the expo.
