# Introductions & Round Table

- Werner Ambros: Werner suggested that the industry updates be sent out prior to monthly meetings to make more time for presentations and Questions. Holly will request updates before the meeting and distribute with agenda beforehand. He suggested using the AER map rather than the County map. Holly agreed to meet with Angela to check it out for our use. PAZA was is the report? Bob Marshall indicated that the report from proponent that came back was not as detailed as hoped so the raw data has to be gone through in order to get to the data we were looking for. Wondering if Keyera has plans for new gas plant. Vanessa C. indicated not at this time.
- Leanne Van Wagner Rural Crime Watch, invitation to join and attend meetings, check out the website,

### Secure Energy:

- Secure is moving a service rig Sept 10 into 13-36-70-9W6 which is on the south side of Twp Rd 710 just East of RR91
- The rig will be onsite for about 7 days to re-complete the well to assess its potential for Produced water disposal. If the well is acceptable it may be pipeline connected from our Water Disposal facility in the SW05-71-8W6 which is North of Twp Rd 710 and ½ mile East of RR85.
- Construction is About 50% completed on our Disposal facility in the SW05-71-8W6 and we hope to commission the site in the first half of October.

# CNRL:

- We have our completions on our 13-01-72-09W6 location. This is 3/4 mile north of TWP RD 720 on RR 91. We are also 90% complete installing a 6 km 8" pipeline from 13-01 to 03-17-72-08W6. Facility work is 98% complete.
- We will have our flowback equipment set up around the last week of September/first week of October to flow test our 02-28-70-09W6 pad well inline to the new Tidewater plant. Our 6 km 4" sour pipeline is roughly 70% complete over to the Tidewater facility with a small branch coming from the 12-03-71-09W6 Nuvista wellsite. The 02-28 wellsite is located 4 miles south of HWY 43 on RR 92. Than 1/2 mile west on TWP RD 710. Than 2 miles south on RR 93. Than 1/2 mile west on TWP RD 704.
- We are continuing with the groundwork on our new oil battery site at 01-20-72-08W6. Trees have been cleared and site grade work continues. This is located 1 mile south of TWP RD 724 on RR84. We will be starting a few pipelines to/from here in Q1 2020. The facility itself will also be constructed mostly in 2020. Expected startup will be Q4 2020.
- We are 98% complete building our frac water storage cell in section SE-31-72-08W6. This is located 1/2 mile south of TWP RD 730 on RR 85. Some minor facility work is all that is left to complete.

#### Tidewater Midstream

 12-35-70-9w6 Plant commissioning ongoing. Expect to be processing gas mid-September.

- -Service rig on site completing injection well at Plant site. Should be off site mid-September.
- -Closing in on reconstruction of RR92 south of TWP 710 directly in front of plant site.
- -Service rig moved off of 1-25-70-9w6 wellsite end August. Work complete there.
- Good progress on Pipeline ROW remediation with improved weather conditions.
- -TWM joined a roving road monitoring program monitoring industry activities in the Pipestone Area.
- -Construction crews from TC Energy moving in/out TWM road from our location at 15-30-71-8w6. Completing install of gas metering station, north of HWY 43 on RR85 about 1 mile.

#### Encana

- 4-31-71-8 W6 (RR90 South of TWP720)
- 11 additional wells drilled in 2019 from an existing pad
- Hydraulic fracturing done
- Well testing/flowback starting shortly
- Expected on production mid- October
- 15-30-72-8 W6 compressor station
- (RR90 North of TWP 724)
- Phase 2 construction is underway
- 15-6-75-7 W6M Highway 724, North of TWP 750
- (adjacent to Encana Sexsmith gas plant)
- Drilling scheduled to be done Sept 9
- Completions to follow
- Road upgrade (TWP 720 between RR92 to RR90)
- Partnership of Encana and County of GP
- Weather has delayed completion of job
- Road is now partially open to the public,
- Encana traffic will still access location from the East, until repairs on RR92 pavement have been completed
- Pipestone Processing Facility (RR 92 South of Emerson highway)
- Piling has started and will continue until early November
- Intersection upgrade (RR 92 and the Emerson)
- Encana working with AB transportation to upgrade the corner of RR92 and Emerson highway to accommodate an oversized load going to the Pipestone Processing Facility.
- Construction scheduled to start Sept 15
- 14-28-72-9 W6M (½ mile SE of Bush Lake)
- Drilling scheduled to start Sept 11
- Single well being added to padsite
- 15-26-72-9 W6M (North of TWP 724 between RR91 and RR92)
- Padsite expansion construction underway
- Community Investment
- Encana has committed to donating \$5,000 in support of the Town of Wembley's upgrades to the Spray Park.
- Construction is planned for spring 2020.

#### Keyera

- Pipestone compressor station (8-15-70-8-W6) Major construction complete with small crews completing clean-up work. Commissioning and startup activities commenced and will continue into September.
- Pipestone lateral pipeline –Construction complete.
- North Wapiti pipeline system (Keyera Wapiti gas plant at 3-19-67-7 W6 to the Keyera Pipestone Compressor Station at 8-15-70-8-W6) Commissioning underway, clean-up activities will continue through October.
- Keyera's system in the region will be operating fall 2019.

# Kelt Exploration

- Drilling
  - i. No Operations to report
- Completions
  - i. 12-3-73-8W6M (3 wells to complete) (Hiway #724 & Emerson Trail) commence well frac's on September 9, 2019. Stimulation operation will be 3 to 4 days per well. The intention is to test these wells inline once the pipeline to 1-14 battery is complete in late September/early October. Water has been secured via private landowner sources in the Wembley area and the water line is to be laid in Hiway 724 right of way from NE corner of Wembley town site north to 12-3 location.
- Pipeline/Facilities
  - Pipeline 12-3-73-8W6M (Hiway #724 & Emerson Trail) to 14-2-73-8W6M (TWP 730 & RR 82) to 1-14-72-8W6M (TWP 722 & RR81) Construction commenced on July 15/19. All crossings complete, mainline trenching and welding underway. Some backfilling proceeding. Late September/early October completion (weather pending)
  - ii. Facility at 1-14-72-8W6M (TWP 722 & RR 81) Facility is under construction and is approximately 75% complete. Still require water injection pump package to be delivered to site. Anticipated to commence production flow late September. Full completion of site Mid -October.
