Secretary's Report

Ashleigh Rolfson emailed a copy of the August minutes to all club members. No one in attendance requested any edits to be made to the minutes that were sent out.

Election Committee

As a reminder our annual meeting is scheduled for Monday, October 27th. It is during this meeting we hold the annual elections for club officers and board positions. All of the positions (President, Vice President, Secretary, Treasurer as well as the 5 Board Positions) are elected annually. To keep things impartial and fair, we are using this form to complete our nomination process. Once our election committee has completed their tabulations, we will complete the process of asking each nominee whether they accept or decline the nomination. Final decisions will be made by the Board based on a variety of factors, including member interest, feasibility, and alignment with club goals.

As you begin to think about who you may vote for in October, please consider the following: who is best suited for the position, who advocates for TTR both within both the ATV and local community whether in person or from afar, and who actively participates with TTR. It is exciting to see new folks wanting to join the board.

President's Remarks

During the meeting Jenny Little provided updates on the following:

Municipal Grant Update

I want to keep the club informed about this year's municipal grant process. While the application phase went smoothly, the reimbursement portion has involved a number of detailed questions. This is due to a mix of existing policies and procedures, as well as some enhancements introduced by the new director of the RV department. I believe these questions reflect a thorough and responsible approach, and we're committed to working through them. That said, the process has been noticeably different from the past two years and may continue to evolve in future cycles. On a positive note, Mr. Bursey has completed his portion of the grant work, which has made a significant impact. We are currently awaiting reimbursement in order to pay him, with approximately \$24,000 due. As you'll see in the Treasurer's Report, our current balance does not yet cover this amount. It is my understanding that they are reviewing each line item of the reimbursements hence why there are additional questions which is also why the reimbursements are taking a bit longer to process.

Maine Trail Bond Application

During our August meeting, I shared with the group that there was an additional funding opportunity available through the Maine Trail Bond—Question #4. At the time, we had every intention of completing and submitting an application before the September 26 deadline. However, a few factors came into play, and ultimately, we ran out of time. The process, as noted by the grant administrators, ideally should begin three to six months in advance—and that guidance proved to be quite accurate.

Rather than submitting an incomplete or rushed application that might not reflect well on the club, the Board and I decided to hold off this round. That said, we're not letting the winter months go to waste. We plan to use this time to strengthen and solidify our application so we're well-prepared for the next opportunity.

Southern Maine Regional Meeting

Earlier this month, I attended a meeting hosted by the Ossipee Mountain ATV Club, facilitated by Brent LeBlanc. It was a great opportunity to connect with fellow clubs and open dialogue around recurring challenges we all face. Brent had many topics he could have brought to the table, but he focused heavily on the exciting developments in the southern region of the state.

He shared that some clubs are just one or two landowners away from completing trail connections that could make southern Maine a true destination spot—potentially allowing riders to travel from the Oxford area all the way to Greenville.

Another key point Brent emphasized was the value of enhanced signage and kiosks, which he has seen implemented effectively in other areas. These not only improve rider experience but also help communicate important information. As we look ahead to replacing or upgrading our own signage in the coming years, this is something we should be mindful of. If anyone is interested in seeing the proposed trail maps or learning more, feel free to reach out to me. It was refreshing to sit down with other volunteers who share our mission and hear about the promising developments ahead.

West Side Park and Ride

In early September, while fueling up at the Nouria gas station—located near our West Side Park & Ride—I noticed a "For Lease" sign posted at the entrance to the adjacent dirt parking lot, otherwise known as our West Side Park & Ride. Despite efforts to reach out for more information, I have not received any response. This is something the Board is aware of, and we are actively monitoring the situation. While the park and ride remains technically open, it's important to note that there is currently no access trail leading from that location.

West Side Reroute Update

Earlier this year, a landowner development project led to the closure of one of our trails leaving the West Side Park & Ride. The club has submitted paperwork to CMP and is awaiting a response. Our trail coordinator has emphasized the urgency, and a potential reroute—partially following the old Trail #1—has been scouted and deemed viable with some maintenance. There's no new update at this time, but we're continuing to monitor the situation and remain hopeful.

Winter Meeting Location

A reminder that last year we relocated our meetings beginning in November and continued until March because the Exhibition Hall is used as a storage unit during the winter months. Earlier this year, we contacted the town and they have offered us the use of the Don Russell Board room located in the Municipal Building. I am merely mentioning this to get the location change on our radars!

Maine ATV Coalition

I'd like to share with the membership that I have recently been voted in as a board member of the Maine ATV Coalition. I do not anticipate this role interfering with my responsibilities as the leader of Topsham Trailriders. It is both my civic duty and personal commitment to continue representing our club to the best of my ability—whether in coalition meetings, working with ATV Maine, or advocating for our interests. I'll always prioritize what's best for TTR, and I wanted everyone to hear this update directly from me.

Treasurer Report

Tim provided a printed treasurer report which will be attached to the minutes when they are sent out which is an update since our August meeting.

Motion was made by Kyle McComiskey to approve the treasurer's report as provided at the meeting

Motion accepted by Ron Carey Was Passed with No Opposition Tim Moody abstained from the vote

After discussing the treasurer's report, we discussed that we have a large bill to the excavation company who recently completed work that we included on our municipal grant. The quote that Bursey Enterprises provided to us was around \$26,760. We are waiting to receive the money from our first municipal reimbursement before we can negotiate payment to Bursey Enterprises.

A motion was made by Tim Williams to pay Bursey Enterprises the total due in the amount of \$26,760 ONLY after we receive the money back from our first municipal grant. He added to the motion to include the ability to transfer balances from our other sub-accounts to the main operating account.

Motion was accepted by Kyle McComiskey Was passed with no opposition

Trail Master

Tim Williams provided the following update:

East Side

All of trails on the East side are open and are in great shape especially after this weekend's work party. I'm pleased that we've already addressed areas of concern that were recently mentioned by our trail coordinator during a recent inspection.

West Side

All the trails that we have permission to use are still currently open and dry. If you have an opportunity to ride the west side you should take the chance because it would allow you to see all of the work recently completed.

Trail Work Hours Due

Jenny Little provided the following update:

Ride for a Cure Flyer

Day of Event
