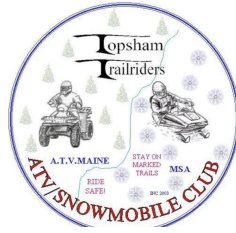

Secretary's Report

President's Remarks

During the meeting Jenny Little provided updates on the following:

West Side Reroute

I want to provide a brief, transparent overview of the West Side Reroute Project and how we arrived at this point. As many know, last year west-side riding access from the Park and Ride was unavailable because the connecting trail beyond the access point was closed at the landowner's request due to work being conducted on their property. As always, we respect landowner decisions, and this situation highlighted a long-standing connectivity issue on the west side that requires a permanent solution.

Since then, the club has worked methodically and in compliance with state process, securing landowner permissions and consulting with the ORV Program and State Trail Coordinator. Based on early guidance, additional agencies were engaged, including DEP, which identified wetlands and the presence of a protected species. As a result, the scope of the project expanded and required additional review and clearance letters from agencies including IFW and MNAP, some of which are still pending.

What was initially believed to be a relatively modest reroute has evolved into a larger-scale project that will require engineered solutions and contracted work. Until all required reviews are completed—particularly input from MNAP—the project remains at a pause point, with the focus on transparency, compliance, and long-term protection of the club, our landowners, and the trail system.

Since our last meeting, we have continued closely examining the reroute and exploring different options within the reroute itself in an effort to minimize impact and disruption. One potential secondary reroute option is no longer viable due to a recent property sale, which would require engaging a new landowner. As a result, our near-term focus is shifting toward re-establishing connectivity between the east and west sides of the trail system so riders can at least access each side independently. At this time, a connection to the Nouria gas station is not expected for this riding season, though this may be revisited in the future. On a positive note, we have heard back from MNAP, and a site visit is scheduled for tomorrow afternoon and Assistant Trailmaster Mike Little will be escorting them. While progress has been slow, it is progress, and updates will continue as additional information becomes available.

East & West Side Reconnection

Ron and I have continued discussions, and our focus is now shifting heavily toward re-establishing connectivity between the east and west sides of the trail system. Based on past experience and early conversations, what we suspect will be most viable is revisiting a previously approved connection that allowed the club to leave the east-side Park and Ride (the dirt lot located across from the bus loop at the entrance to Mt. Ararat High School), travel approximately 0.8 miles along the roadway, and then enter the woods near the overpass to access the trail system. Given the current reroute challenges, this option is being explored as a potential solution.

We are in the process of preparing a formal request package to submit to the Select Board. This is understood to be only the first step in a multi-stage process. We anticipate an initial

discussion with the Select Board, followed by requests for input from town officials, a public hearing, and ultimately a vote. Should the Select Board vote in favor of the request, the next required step would be to formally engage DOT before any progress could move forward. While the outcome of this process cannot be predicted, this effort is considered mission-critical for restoring system connectivity. We have secured written permission from the affected landowner and will continue to proceed transparently and methodically as each step unfolds.

Municipal Grant 2025 & 2026

Before we move into the Treasurer's Report, I want to take a moment to share an update that was mentioned a few months ago. When we submitted our final 2025 municipal grant reimbursement, a portion of the submission was inadvertently entered into an incorrect field, which initially affected the amount reimbursed. The Bureau of Parks was incredibly understanding and allowed us to complete a corrective process. As a result, you will see later in the Treasurer's Report that we received over \$3,500 back for 2025. This was a generous accommodation on their part, and we are extremely appreciative.

Looking ahead, we remain optimistic and are doing everything possible to finalize the 2026 municipal grant application but our window to do so is shrinking. These grants provide a significant opportunity for the club to pursue larger-scale projects, but they also require matching effort and manpower to make them viable. As we move forward, volunteer participation will be essential to help offset costs and position the club to fully take advantage of these funding opportunities.

Trail Intel Demo Class

Yesterday, I connected with Dana McLean, President of the Over the Hill ATV Riders (West Bath), to discuss the upcoming addiction recovery event and other shared matters. During our conversation, we referenced the Trail Intel demo held last Wednesday, which we both agreed moved at a very swift pace. Dana proposed the idea of hosting a more in-depth Trail Intel demonstration at a local venue, noting that he has a location and ATV available.

Following that discussion, I initiated an email conversation with Brian Gavin, owner of Trail Intel, including Dana. As a result, we now have a Trail Intel class scheduled for Saturday, May 30th, to be held at the Phippsburg Sportsman's Club in Phippsburg. While the exact time and duration are still to be determined, we have secured a commitment, location, and date. The venue can reportedly accommodate up to 100 participants, and other clubs will be invited.

Additional details will be provided prior to the main event, likely via email, and members will also be reminded during the May meeting. Members are encouraged to mark Saturday, May 30th on their calendars as a prime opportunity for expanded Trail Intel training.

Treasurer Report

Tim was not able to be in attendance but had provided a printed treasurer report to Jenny. They will be attached to the minutes when they are sent out which is an update since our March meeting.

Trail Master

Ron Carey provided the following update:

East and West Side Update

Trail work started on April 11th this year with a ride on the east side. We cleared trees and brush and that preliminary run opened the east side to general pedestrian traffic. On the April 26th work party we rode the east side to evaluate and “breadcrumb” the spots that need trail work. We made notes of the work required at each of the spots so we know what needs to be done. Again brush and branches were cleared for safe access. We were approached by a pedestrian on the trail by the ponds, the gentleman thanked Charlie and I and stated, “your club has been doing a great job on the trails.” We truly appreciate the public noticing our hard work. Please note that our trail system is still closed for motorized use.

Our plan for the upcoming work party on May 9th is to use the “breadcrumbs” created yesterday to start hauling in the materials for the maintenance areas needed. We will be staging materials by the Tedford Rd intersection and hauling trailers to the needed areas. The work will be completed on the road crossings in the Topsham Crossing area. We will need a tractor for this work party. Everyone is welcome, make sure to spread the word as many hands make light work.

Our hope is to finish the small bit of work on the east side by May 16th, then shift our focus to the west side on the 23rd. This should allow the trails to dry a bit and the ground to firm up before we start working. Stay informed on work parties by following our events page. As of yesterday afternoon we have accumulated 68.5 hours of volunteer trail work. Great job getting out there.

We are in a severe drought and the woods are quite a bit drier than usual. Please be aware of where you’re parking your hot machines in these conditions. Don’t forget you represent the Topsham Trailriders, always ride responsibly, tread lightly, stay on marked trails and carry in - carry out. It’s just how we ride.

An individual asked if it would be acceptable to go out and complete trail work independently. It was confirmed that this is 100% acceptable. Members are asked to notify either the President or the Trail Master, or send a Facebook message, either before heading out or shortly after, so leadership is aware and can respond appropriately if calls are received

Trail Work Parties Volunteer Tracking

As a reminder, for the club to be eligible to receive credit for our volunteer trail hours we must submit a trail worksheet for each individual. In an effort to ensure we do not miss getting a signature we are asking members to sign in each and every time they attend a work party using the gray Trail Master log book. Please print the date, clearly print your name so it’s legible, and then sign at the bottom. If you do not see the gray book, it is your responsibility to seek out a Trail Master or Assistant Trail Master—hours will not be backtracked or added later. This process is important, and we appreciate everyone’s cooperation.

Ride for a Cure

Jenny Little provided the following update:

The Ride for a Cure Committee met on Monday, April 6, to continue planning for this year's event, scheduled for Saturday, October 17. We are excited to once again partner with the Dean Snell Cancer Foundation, based in Topsham, which provides support to patients receiving care at the New England Cancer Specialists facility. We are honored to support their mission.

Addiction Recovery Benefit Ride

Marie Carey provided the following update:

Our food trucks are secured. We have B&D Roadside Grill, The Smothered Spud, and Legendary ice cream truck. The dessert truck had to back out. Both the Road side Grill & The Smothered Spud serve soft drinks & water. So we are good to go with that.

Tee shirts & hoodies are complete and available for online purchase at Got Vinyl. It's under Topsham Trail riders and there is also a QR code. T-shirts are \$25, hoodies are \$40. Would like to advertise these more. How long should we leave them up for sale after the event?

Pre-registration for the event is open, \$20 per machine. a QR code and link was created by KVCAP so that the money will go directly into Operation Hope's account. There is small credit card processing fee (.60) at checkout for each person at online checkout. A list will be able to be printed so we can know who has pre-registered for day of the event.

There are volunteer sheets that have been sent out to TTR members and the Path to Recovery committee for different positions/tasks that need to be filled as well as a list of supplies that will be needed.

Ron & I went to the Mechanic Falls Park & Ride to check it out and met with Lou to talk about over flow parking if needed. Lou stated the park and ride can easily park 90 trucks & trailers (more if parked correctly) and stage the machines along with registration tables. If overflow parking is needed, there is a small plaza up the road that can be used to park an additional 12-15 trucks & trailers (maybe more). There is a trail off from the parking lot that goes directly to Mechanic Falls Park & Ride. He asked that we be respectful if parking there as to not block the customer parking for the businesses at the plaza.

As of today, on the Facebook event page, there are 30 signed up as going, and 155 interested. This could be a very large event.

Old Business:

ByLaw Amendment Discussion

Jenny Little provided the following update

During the month of March, a survey was distributed to the membership seeking input on whether Topsham Trailriders should continue its relationship with ATV Maine. The results and feedback from the membership were reviewed by the Board and taken under advisement. After discussion, the Board voted to continue the club's relationship with ATV Maine.

It is important to emphasize that regardless of the club's affiliation decision, individual members always retain the choice of whether or not to participate in ATV Maine. ATV Maine membership is not automatic. The club only submits dues on behalf of members who explicitly request to be enrolled. Moving forward, ATV Maine submissions will be processed on a monthly basis. At the end of each month, eligible member information will be submitted, and stickers and confirmation materials will be generated and distributed accordingly.

As part of the broader discussion, the Board reviewed the club bylaws and noted language stating that Topsham Trailriders "will participate" in both MSA and ATV Maine. To better align the bylaws with the optional, membership-driven nature of ATV Maine participation, a draft set of bylaw amendments was prepared and reviewed by the Board. These revisions also add clarification regarding timing, specifying that the decision on whether to continue the club's relationship with ATV Maine will be addressed at the annual meeting. This establishes a clear, consistent point each year when that determination is made.

The proposed bylaw amendments were distributed at the previous meeting and are included in tonight's packet, with strikeouts and additions clearly marked to highlight changes. The goal of tonight's discussion is to answer questions, gather feedback, and identify any requested edits. If changes are proposed, the discussion will continue into the May meeting before any final action is taken.

Club 501c3

Jenny Little provided the following update:

During last month's meeting, the membership voted to officially begin the process of obtaining 501(c)(3) nonprofit status. Tim Moody has graciously volunteered to spearhead this effort on behalf of the club. Based on updates shared by Tim, initial steps are underway, including an upcoming meeting with legal counsel to begin outlining the requirements and next phases of the process.

MOMS Topsham – Open House May 2nd/ TTR Membership Drive (?)

Jenny Little provided the following update:

At this time, planning for the MOMS Open House remains tentative, as we have not yet received a confirmed date or details from MOMS Topsham. Once we receive clarification, we will move forward accordingly.
