Mission, Vision, & Core Values

The mission of the Idaho Anti-Trafficking Coalition is to work alongside community members in providing awareness, education, services, and safe housing for victims of human trafficking.

Our vision is to create a safe environment where individuals can receive appropriate services and support, and when necessary, safe housing, in order to work on healing, restoration, recovery, and independence.

We believe in the following core values:

- 1. All individuals have the right to be treated with dignity and respect.
- 2. All individuals should have access to needed services that achieve optimal outcomes.
- 3. All individuals should be empowered to exercise informed consent.

Funding & Data Reporting

2020 was the first full fiscal year that Idaho Anti-Trafficking Coalition was funded. In addition to community donors, Idaho Anti-Trafficking Coalition relies on two main funding sources, a subgrant from the <u>Idaho Council on Domestic Violence and Victim</u> <u>Assistance</u> and a subgrant through the <u>Idaho Department of Health and Welfare</u>. On an annual basis Idaho Anti-Trafficking Coalition receives \$364,163 and \$17,525 from these sources, respectively.

A requirement of these funding sources is data collection. Idaho Anti-Trafficking Coalition is the first organization in the State of Idaho to be officially collecting data on human trafficking. All classifications and metrics are created by and reported to the Idaho Council on Domestic Violence and Victim Assistance.

Idaho Anti-Trafficking Coalition was invited to sit on the advisory committee of the <u>United Way of Treasure Valley 2020 Community Assessment</u>. Human trafficking was previously not included in community assessments. Under the 'Safety' portion of the community assessment, the conclusion was made that in Idaho 'human trafficking remains a highly under-reported crime'. The policy, systems, and environmental change recommendation was to 'increase availability of programs that provide mental health treatment for victims of domestic and sexual abuse and victims of human trafficking'.


2020 Victim Demographics

2020 Types of Victimization


There are 26 subsets of crime victimization categorized by the Idaho Council on Domestic Violence and Victim Assistance. Out of 458 individuals aided, there were 1,174 counts of crime victimization. From our data, 259 individuals indicated that they were victims of multiple crimes. On a national-level, it is understood that self-identifying as a victim of sex trafficking is extremely low. From our data, 22.05% of individuals self-identified as a victim of sex trafficking.

2020 Special Classifications

There are 8 subsets of special classifications categorized by the Idaho Council on Domestic Violence and Victim Assistance. Out of 458 individuals aided, there were 233 counts of special classifications. Traffickers often prey and target vulnerable populations. These populations carry a heightened risk of being exploited.

2020 Shelter & Housing Services

In 2020, 122 individuals were aided and received 532 counts of direct services. Shelter and housing services include emergency shelter or safe housing, transitional housing, and relocation assistance.

2020 Emotional Support & Safety Services

In 2020, 321 individuals were aided and received 1,045 counts of direct services. Emotional support and safety services include crisis intervention, hotline response, on scene crisis response, counseling, holistic therapy, support groups, and emergency financial assistance

2020 Criminal & Civil Justice System Assistance

In 2020, 58 individuals were aided and received 85 counts of direct services. Criminal and civil justice system assistance include notification of criminal justice events, victim impact statement, restitution, aid in obtaining protection order, civil legal family law issues, immigration services, advocacy or accompaniment with prosecution, law or criminal interviews, and other legal advice or counsel.

2020 Information and Referral Services

In 2020, 346 individuals were aided and received 786 counts of direct services. This assistance includes providing information on or a referral to agencies that can provide services for criminal justice process and notifications on victim rights. According to our data, referrals to outside community agencies that could aid an individual in conjunction with Idaho Anti-Trafficking Coalition were made 321 times.

2020 Personal Advocacy/Accompaniment Services

In 2020, 248 individuals were aided and received 518 counts of direct services. This assistance includes advocacy and accompaniment with medical care, law enforcement, forensics exams, immigration, child care, transportation, and interpreters.

2020 Crime Victims Compensation Program

The Idaho CVCP was established in 1986 to provide assistance to victims of crime for costs related to treatment for injuries sustained as a result of a crime and for sexual assault forensic examinations. The program works with victims and family members to ensure they understand the benefits available to them and to assist them in accessing the necessary treatment or services they need. The program believes that offenders should be held accountable for costs associated with their criminal activity, and actively pursues reimbursement for crime related costs from offenders through restitution and any other source of payment. Idaho Anti-Trafficking Coalition has the ability to aid individuals who qualify for the Idaho Crime Victims Compensation Program. In 2020, Idaho Anti-Trafficking Coalition aided 7 individuals who qualified for the program with the completion of the application.
