# **GARFIELD PARK ORDINANCE**

ORDINANCE #5 REGULATES CONDUCT IN PUBLIC PARKS FOR THE USE, PROTECTION, REGULATION AND CONTROL OF PARK SERVICES, FACILITIES, RECREATION, CONSERVATION, EDUCATION, HISTORICAL AND SCENIC AREAS.

# RULES

#### NO PERSON IN ANY GARFIELD TOWNSHIP PARK SHALL:

- 1. DAMAGE ANY PARK PROPERTY
- 2. DRINK, POSSESS, SELL OR BE UNDER THE INFLUENCE OF ALCOHOLIC BEVERAGES WITHOUT PRIOR APPROVAL OF THE GARFIELD TOWNSHIP BOARD.
- 3. BE UNDER THE INFLUENCE OF INTOXICANTS, DRUGS, NARCOTICS OR POSSESS, USE, SELL OR DISTRIBUTE ANY CONTROLLE SUBSTANCE.
- 4. LITTER OR LEAVE ANY HOUSEHOLD RUBBISH, WASTE, GARBAGE OR REFUSE.
- 5. DROP, THROW OR OTHERWISE SCATTER LIT CIGARETTES, MATCHES OR CIGARS.
- 6. USE PARK FACILITIES DURING THE HOURS OF DARKNESS.
- 7. HUNT, TRAP, CATCH, WOUND OR KILL ANY BIRD OR ANIMAL.
- 8. KEEP DOGS/PETS ON A LEASH AND UNDER CONTROL.
- 9. IMMEDIATELY REMOVE DOG/PET FECES AND DISPOSE IN SANITARY MANNER.
- 10. OPERATE ANY MOTORIZED VEHICLE OFF ROADWAY OR DESIGNATED PARKING AREA.
- 11. LEAVE ANY MOTOR VEHICLE OVERNIGHT.
- 12. BUILD ANY FIRE, EXCEPT IN TOWNSHIP APPROVED GRILLS IN PICNIC AREAS.
- 13. FIRE, DISCHARGE OR POSSESS ANY FIREWORKS.
- 14. FLY MODEL AIRPLANES OR DRONES WITHOUT PRIOR APPROVAL.
- 15. USE ANY LOUD SPEAKER WITHOUT PRIOR APPROVAL.
- 16. HIT, DRIVE OR PUTT GOLF BALLS.
- 17. PEDDLE, SOLICIT OR FUNDRAISE WITHOUT PRIOR APPROVAL.
- 18. CREATE ANY DISTURBANCE WHICH IMPAIRS THE QUIET ENJOYMENT OF PARK.

#### EACH VIOLATION OF THIS ORDINANCE IS PUNISHABLE BY A FINE OF UP TO \$500.00.
