HOUSE RULES

Our House Rules ensure good order and safety for members and guests. These rules are not all inclusive. Any inappropriate or disorderly conduct shall not be tolerated per AMVETS Constitution and Bylaws.

1. No member or guest shall bring alcoholic beverages into or take them out of the post.
2. Anyone under 18 years old is prohibited from sitting or standing at the bar.
3. Minors must be accompanied by a parent or guardian and must vacate the post by 8:00 PM unless approved by the trustee chairman or post commander.
4. Guests must be signed in by a current member and leave the post when the sponsor leaves or may be signed in by another member. Sponsor takes full responsibility for the conduct of guest.
5. Special Guests include Active-Duty military, National Guard or Reservists with Military ID. They must sign into the guest log but do not require a sponsor.
6. Bartender on duty has the **right and responsibility** to refuse service to anyone under the age of 18 or those deemed "intoxicated, belligerent or unruly.
7. Lewd, foul, obnoxious remarks, physical abuse or gestures directed at other members will not be tolerated in the post.
8. Abbreviated, suggestive clothing is prohibited on post premises. Profane or obscene artwork or texts on clothing is not permitted. Shirts, shoes and appropriate pants or shorts must be worn at all times.
9. No one is allowed behind the bar or walk-in cooler unless requested by the bartender on duty.
10. Only post officers and authorized employees are allowed in the office area without official escort.
11. The check cashing limit is \$100 per day for all members, provided there is enough cash in the register to cover the check. No two-party checks are accepted.
12. There is a \$30 service charge for returned checks.
13. All bar tabs must be settled by close of business.
14. Only AMVETS members, Ladies Auxiliary, Sons and sponsored guests are allowed to participate in post-sponsored activities (i.e. pool, poker, bingo and pull tabs, etc.).
15. No Solicitation of money allowed in the Post unless approved by the executive committee.
16. Last call is 15 minutes prior to the posted closing time. The bartender has full discretion to stay open past posted closing if business warrants.
17. Bartender will settle all TV use disputes and music choice when members cannot agree.
18. No Smoking or vaping in the Canteen, Game Room, front entrance.
19. Absolutely no firearms, or items normally considered a weapon, shall be brought into the post.
20. AMVETS organization at all levels from National to local has a non-discrimination/harassment policy for employees, members, and guests. Constitutions and Bylaws state there can be no discrimination or harassment based on Age, Marital Status, Race, Religion, Gender, Sexual Orientation, Nationality, or Origin of Birth.
21. Bathroom use will be based on sex assigned at birth.
