AMVETS POST 2298 HOUSE RULES

Post 2298 standards of conduct ensure good order and safety for members and guests at the canteen. These rules are not all inclusive. Any inappropriate or disorderly conduct shall not be tolerated per AMVETS Constitution and Bylaws.

- 1. No member shall bring alcoholic beverages into the post.
- 2. Anyone under 18 years old is prohibited to sit at the bar.
- 3. Minors must be accompanied by a parent or guardian and must vacate the post by 8:00 PM unless approved by the trustee chairman or post commander.
- 4. ALL guests (except Active-Duty military) must be sponsored (signed in) by a current member and leave the post when the sponsor leaves. However, a different current member may take responsibility for the guest by signing them in again. A sponsor takes full responsibility for the conduct of their guest.
- 5. Bartender on duty has the **right and responsibility** to refuse service to anyone deemed over their limit or a danger to themselves or others.
- 6. Obscene and/or offensive language shall not be tolerated in the post.
- 7. Appropriate clothing (shirts, shoes, and pants, shorts, dresses, or skirts) must be worn while on premises. Suggestive clothing, obscene art or text, and anti-government art or text on clothing is not permitted.
- 8. No one is allowed behind the bar or walk-in cooler unless requested by the bartender on duty.
- 9. Only post officers and authorized employees are allowed in the office area without official escort.
- 10. The check cashing limit is \$100 per day for all members, provided there is enough cash in the register to cover the check. No two-party checks are accepted.
- 11. There is a \$25 service charge for returned checks.
- 12. All bar tabs must be settled by close of business.
- 13. Only AMVETS members, Ladies Auxiliary, Sons and sponsored guests are allowed to participate in post-sponsored activities (i.e. pool, poker, bingo and pull tabs, etc.)
- 14. No Solicitation of money is allowed in the Post unless approved by the executive committee.
- 15. Last call will be given 15 minutes prior to the posted closing time. The bartender has full discretion to stay open past posted closing if business warrants.
- 16. Bartender will settle all TV use disputes and music choice when members cannot agree.
- 17. No Smoking or vaping is allowed in the Post except in designated areas. The front door, entrance and game area are designated no-smoking areas.
- 18. Weapons shall not be brought into the post.
- 19. AMVETS organization at all levels from National to local has a non-discrimination/harassment policy for employees, members and guests. Per our Constitution and Bylaws there can be no discrimination or harassment based on Age, Marital Status, Race, Religion, Gender, Sexual Orientation, Nationality, or Origin of Birth.
