Statement of intent

Underhill School and Children's Centre wishes to ensure that pupils with medical conditions receive appropriate care and support at school. This policy has been developed in line with the DfE's guidance released in April 2014: Supporting pupils at school with medical conditions.

Ofsted places a clear emphasis on meeting the needs of pupils with special educational needs and disabilities (SEND), and this includes children with medical conditions.

Key roles and responsibilities

1. The local authority (LA) is responsible for:

2. Providing support, advice and guidance to schools and their staff.
3. Making alternative arrangements for the education of pupils who need to be out of school for 15 days or more due to a medical condition.
4. Providing suitable training to school staff in supporting pupils with medical conditions to ensure that Individual Healthcare Plans (IHCPs) can be delivered effectively.

The governing body is responsible for:

5. The overall implementation of the Supporting Pupils with Medical Conditions Policy and procedures of Underhill School and Children's Centre.
6. Ensuring that the Supporting Pupils with Medical Conditions Policy, as written, does not discriminate on any grounds including, but not limited to: ethnicity/national origin, culture, religion, gender, disability or sexual orientation.
7. Handling complaints regarding this policy as outlined in the school's Complaints Policy.
8. Ensuring that all pupils with medical conditions are able to participate fully in all aspects of school life.
9. Ensuring that relevant training provided by the LA is delivered to staff members who take on responsibility to support children with medical conditions.
10. Guaranteeing that information and teaching support materials regarding supporting pupils with medical conditions are available to members of staff with responsibilities under this policy.
11. Keeping written records of any and all medicines administered to [individual pupils](#) and [across the school population](#).
12. Ensuring the level of insurance in place reflects the level of risk.

The Headteacher is responsible for:

13. The day-to-day implementation and management of the Supporting Pupils with Medical Conditions Policy and procedures of Underhill School and Children's Centre ensuring the policy is developed effectively with partner agencies.
14. Staff are aware of this policy.
15. Liaising with healthcare professionals regarding the training required for staff.
16. Ensuring staff who need to know are aware of a child's medical condition.
17. Developing IHCPs.
18. Ensuring a sufficient number of trained members of staff are available to implement the policy and deliver IHCPs in normal, contingency and emergency situations.

19. If necessary, facilitating the recruitment of a member of staff for the purpose of delivering the promises made in this policy.
 20. Ensuring the correct level of insurance is in place for teachers who support pupils in line with this policy.
 21. Contacting the school nursing service in the case of any child who has a medical condition.
 22. Organising first-aid training.
 23. **Staff members are responsible for:**
 24. Taking appropriate steps to support children with medical conditions.
 25. Where necessary, making reasonable adjustments to include pupils with medical conditions into lessons.
 26. Administering medication, if they have agreed to undertake that responsibility.
 27. Undertaking training to achieve the necessary competency for supporting pupils with medical conditions, if they have agreed to undertake that responsibility.
 28. Familiarising themselves with procedures detailing how to respond when they become aware that a pupil with a medical condition needs help.
 29. Named staff are responsible for administering injections.
 30. **School nurses are responsible for:**
 31. Liaising locally with lead clinicians on appropriate support.
 32. **Parents and carers are responsible for:**
 33. Keeping the school informed about any changes to their child/children's health.
 34. Completing a [parental agreement for school to administer medicine](#) form before bringing medication into school.
 35. Providing the school with the medication their child requires and keeping it up-to-date.
 36. Collecting any leftover medicine at the end of the course or year.
 37. Discussing medications with their child/children prior to requesting that a staff member administers the medication.
 38. Where necessary, developing an [IHCP](#) for their child in collaboration with the Headteacher, other staff members and healthcare professionals.
- Definitions**
39. "Medication" is defined as any prescribed or over the counter medicine.
 40. "Prescription medication" is defined as any drug or device prescribed by a doctor.

41. A "staff member" is defined as any member of staff employed at Underhill School and Childrens Centre including teachers.

42. Training of staff

43. Teachers and support staff will receive regular and ongoing training as part of their development.

44. Teachers who undertake responsibilities will receive training.

45. No staff member may administer prescription medicines or undertake any healthcare procedures without undergoing training specific to the responsibility, including administering medication.

46. No staff member may administer drugs by injection unless they have received training in this responsibility.

47. The role of the child

48. Children who are competent will be encouraged to take responsibility for managing their own medicines and procedures.

49. Where possible, pupils will be allowed to carry their own medicines and devices. Where this is not possible, their medicines will be located in an easily accessible location.

50. If pupils refuse to take medication or to carry out a necessary procedure, parents will be informed so that alternative options can be explored.

51. Where appropriate, pupils will be encouraged to take their own medication under the supervision of a teacher.

52. Individual Healthcare Plans (IHCPs)

53. Where necessary, an IHCP will be developed in collaboration with the pupil, parents/carers, Headteacher, special educational needs coordinator (SENDCO) and medical professionals.

54. IHCPs will be easily accessible while preserving confidentiality.

55. IHCPs will be reviewed annually or when a child's medical circumstances change, whichever is sooner.

56. Where a pupil has an Education, Health and Care (EHC) plan or special needs statement, the IHCP will be linked to it or become part of it.

57. Where a child is returning from a period of hospital education or alternative provision or home tuition, we will work with the LA and education provider to ensure that the IHCP identifies the support the child needs to reintegrate.

58. Medicines

59. Where possible, it is preferable for medicines to be prescribed in frequencies that allow the pupil to take them outside of school hours. Only medication that has been prescribed for 4 times a day will be administered in school
60. No child will be given any prescription or non-prescription medicines without written parental consent except in exceptional circumstances.
61. Medicines MUST be **in date, labelled**, and provided in the **original container** (except in the case of insulin which may come in a pen or pump) with dosage instructions. Medicines which do not meet these criteria will not be administered.
62. Medications will be stored in the **Medical Room**. Any medications left over at the end of the course will be returned to the child's parents.
63. Pupils will never be prevented from accessing their medication.

64. Administering medication

65. Prior to staff members administering any medication, the parents/carers of the child must complete and sign a parental agreement.
66. Where appropriate, pupils will be encouraged to take their own medication under the supervision of a teacher.
67. Written records will be kept of any medication administered to children.

68. Emergencies

69. Where an IHCP is in place, it should detail:
- What constitutes an emergency?
 - What to do in an emergency.
70. Pupils will be informed in general terms of what to do in an emergency, such as telling a teacher.
71. If a pupil needs to be taken to hospital, a member of staff will remain with the child until their parents arrive.

72. First aid

73. Underhill School and Children's Centre accepts its responsibilities under the Health and Safety (First Aid) Regulations 1981.
74. The Headteacher will ensure that an annual risk assessment of first aid needs is undertaken, appropriate to the circumstances of the Underhill School and Children's Centre and the supporting of pupils with medical conditions.
75. Unless first aid cover is part of a staff member's contract of employment, people who agree to become first aiders should do so on a voluntary basis.
76. Lunch time supervisors will also undertake first aid training.
77. The designated medical room and meets the DfE guidance specifically to:

- Be large enough to hold the necessary equipment.
- Have washable surfaces and adequate heating, ventilation and lighting.
- Be kept clean and tidy at all times.
- Be positioned as near as possible to a point of access for transport to hospital.
- Display a notice on the door advising of the names, locations and telephone numbers of first aiders.
- Have a sink with hot and cold water. Have drinking water and disposable cups.
- Have soap and paper towels.
- Have a suitable container with disposable waste bags.

78. The school has a first aid cabinet, which can be found in the Medical room. The cabinet contains a sufficient number of suitable provisions to enable the administration of first-aid.

79. First aiders will be made aware of any pupils with medical conditions and treat them accordingly, should the need for first aid arise.

80. The main duties of the first aiders are to give immediate help to casualties with common injuries and those arising from specific hazards or medical conditions at the school and ensure that an ambulance or other professional medical help is called where appropriate.

81. The Headteacher will ensure that procedures are in place to report any major or fatal injuries without delay (e.g. by telephone), as required by the Reporting of Injuries, Diseases and Dangerous Occurrences Regulations 2013 (RIDDOR). Other reportable injuries will be reported within 10 days.

82. Avoiding unacceptable practice

83. Underhill School and Children's Centre understands that the following behaviour is unacceptable:

- Assuming that pupils with the same condition require the same treatment.
- Sending the pupil to the medical room or school office alone if they become ill.
- Creating barriers to children participating in school life, including school trips.
- Refusing to allow pupils to eat, drink or use the toilet when they need to in order to manage their condition.

Appendix 1 - Individual healthcare plan implementation procedure

1

Parent or healthcare professional informs school that child has medical condition or is due to return from long-term absence, or that needs have changed.

2

Headteacher co-ordinates meeting to discuss child's medical needs and identifies member of school staff who will provide support to the pupil.

3

Meeting held to discuss and agree on the need for IHCP to include key school staff, child, parent and relevant healthcare professionals.

4

Develop IHCP in partnership with healthcare professionals and agree on who leads.

5

School staff training needs identified.

6

Training delivered to staff - review date agreed.

Appendix 8 - Model letter inviting parents to contribute to individual healthcare plan development

RE: DEVELOPING AN INDIVIDUAL HEALTHCARE PLAN FOR YOUR CHILD

Thank you for informing us of your child's medical condition. I enclose a copy of the school's policy for supporting pupils at school with medical conditions for your information.

A central requirement of the policy is for an individual healthcare plan to be prepared, setting out what support each pupil needs and how this will be provided. Individual healthcare plans are developed in partnership with the school, parents/carers, pupils, and the relevant healthcare professional who can advise on your child's case. The aim is to ensure that we know how to support your child effectively and to provide clarity about what needs to be done, when and by whom. Although individual healthcare plans are likely to be helpful in the majority of cases, it is possible that not all children will require one. We will need to make judgements about how your child's medical condition impacts their ability to participate fully in school life, and the level of detail within plans will depend on the complexity of their condition and the degree of support needed.

A meeting to start the process of developing your child's individual health care plan has been scheduled for **xx/xx/xx**.
